A BILL ENTITLED

1 AN ACT concerning

2 **Boating – Migratory Waterfowl Season – Prohibited Acts**

3 FOR the purpose of prohibiting a person from operating a vessel within a certain distance
4 of a stationary blind or blind site that is occupied and being used for hunting
5 migratory waterfowl during open season; and generally relating to prohibited acts
6 related to boating.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
23 That the Laws of Maryland read as follows:

24 **Article – Natural Resources**

1 During the open season for migratory waterfowl, a person may not fish by any means
2 within 500 yards of any stationary blind or blind site which is occupied and is being used
3 for hunting migratory waterfowl.

5 (a) In this subtitle the following words have the meanings indicated.

6 (s) (1) “Vessel” means every description of watercraft, including an ice boat
7 but not including a seaplane, that is used or capable of being used as a means of
8 transportation on water or ice.

9 (2) “Vessel” includes the motor, spars, sails, and accessories of a vessel.

11 **DURING THE OPEN SEASON FOR MIGRATORY WATERFOWL, A PERSON MAY NOT**
12 **OPERATE A VESSEL IN ANY MANNER WITHIN 500 YARDS OF ANY STATIONARY BLIND**
13 **OR BLIND SITE THAT IS OCCUPIED AND BEING USED FOR HUNTING MIGRATORY**
14 **WATERFOWL.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 2023.
