A BILL ENTITLED

1 AN ACT concerning

2 **Public Schools – Medical and Psychological Treatment in School–Based Health**
3 **Centers and Public Schools – Parental Notice**

4 FOR the purpose of requiring certain school health practitioners employed by or under
5 contract with certain entities to provide school health services in a school–based
6 health center or public school to provide certain information to a certain student’s
7 parent or guardian to consult, diagnose, or treat a certain student under certain
8 circumstances; and generally relating to medical and psychological treatment of
9 students in school–based health centers and public schools.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Education**

18 7–401.

19 (a) With the assistance of the county health department, each county board shall
20 provide:

21 (1) Adequate school health services;

22 (2) Instruction in health education, including the importance of physical
23 activity in maintaining good health; and

1 (3) A healthful school environment.

2 (b) The Department of Education and the Maryland Department of Health jointly
3 shall:

4 (1) Develop public standards and guidelines for school health programs;
5 and

6 (2) Offer assistance to the county boards and county health departments
7 in their implementation.

8 (c) (1) (i) Each county board shall designate a school health services
9 program coordinator.

10 (ii) A county board may authorize the county health department to
11 designate the school health services program coordinator.

12 (2) The school health services program coordinator shall:

13 (i) Implement State and local health policies in the public schools;

14 (ii) Ensure that public schools adhere to local health services
15 guidelines; and

16 (iii) Communicate State and local health policies to the parents and
17 guardians of public school students.

18 (3) (i) Except as provided in subparagraph (ii) of this paragraph, the
19 county board shall grant the school health services program coordinator the authority to
20 carry out the provisions of this subsection.

21 (ii) The county board shall consult with a county superintendent
22 before any change in the hiring or termination of personnel in connection with a school
23 health services program.

24 (4) The Department of Education shall conduct at least two meetings
25 annually with all school health services program coordinators in the State.

26 **(D) A SCHOOL HEALTH PRACTITIONER, HEALTH CARE PRACTITIONER, OR**
27 **CERTIFIED SCHOOL PSYCHOLOGIST EMPLOYED BY OR UNDER A CONTRACT WITH A**
28 **SCHOOL-BASED HEALTH CENTER, LOCAL SCHOOL SYSTEM, OR LOCAL HEALTH**
29 **DEPARTMENT TO PROVIDE SCHOOL HEALTH SERVICES AT A PUBLIC SCHOOL SHALL**
30 **PROVIDE TO A STUDENT'S PARENT OR GUARDIAN INFORMATION ABOUT ANY**
31 **CONSULTATION, DIAGNOSIS, OR TREATMENT PROVIDED TO THE STUDENT.**

32 **[(d)] (E)** On or before December 1, 2015, and every 5 years thereafter, the

1 Department shall report to the Governor and, subject to § 2–1257 of the State Government
2 Article, to the General Assembly a summary of the information reported to the State
3 Superintendent during the COMAR certification process.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
5 1, 2023.
