1 AN ACT concerning

2 **Equity in Transportation Sector – Guidelines and Analyses**

3 FOR the purpose of requiring that equity be considered when certain State transportation
4 plans, reports, and goals are developed; altering the membership of the advisory
5 committee on State transportation goals, benchmarks, and indicators; requiring the
6 Department of Transportation, in collaboration with the Maryland Transit
7 Administration, to conduct certain analyses and consult with certain communities
8 before announcing or proposing certain service changes; requiring the
9 Administration to take certain actions to avoid or minimize certain disparate
10 impacts or disproportionate burdens; requiring the Administration to compile a
11 report on the impacts of a proposed service change after holding a public hearing on
12 the proposed service change; requiring the Department, in collaboration with the
13 Administration, to conduct certain analyses and consult with certain communities
14 before announcing any reduction or cancellation of a capital expansion project in the
15 construction program of the Consolidated Transportation Program; requiring the

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 21 That the Laws of Maryland read as follows:

22 **Article – Transportation**

23 2–103.1.

24 (d) **(1)** The Maryland Transportation Plan shall:

25 **[(1)] (I)** Except as otherwise provided, be revised every 5 years through
 26 an inclusive public participation process;

27 **[(2)] (II)** Include a 20–year forecast of State transportation needs, based
 28 on the financial resources anticipated to be available to the Department during that
 29 20–year period;

30 **[(3)] (III)** Be expressed in terms of the State transportation goals and
 31 measures; and

32 **[(4)] (IV)** Include a summary of the types of projects and programs that are
 33 proposed to accomplish the State transportation goals and measures, using a multi–modal
 34 approach when feasible.

1 **(2) BEGINNING WITH THE 2045 MARYLAND TRANSPORTATION PLAN,**
 2 **THE DEPARTMENT SHALL CONSIDER WAYS TO ACHIEVE EQUITY IN THE**
 3 **TRANSPORTATION SECTOR WHEN DEVELOPING THE STATE TRANSPORTATION**
 4 **GOALS.**

5 (g) Beginning with the year 2002 State Report on Transportation and continuing
 6 thereafter, before the General Assembly considers the proposed Maryland Transportation
 7 Plan and the proposed Consolidated Transportation Program, the Department shall submit
 8 an annual report on the attainment of State transportation goals and benchmarks for the
 9 approved and proposed Maryland Transportation Plan and the approved and proposed
 10 Consolidated Transportation Program to the Governor and, subject to § 2–1257 of the State
 11 Government Article, to the General Assembly.

12 (h) (1) The report required under subsection (g) of this section shall include:

13 (i) The establishment of certain measurable performance indicators
 14 or benchmarks, in priority funding areas at a minimum, designed to quantify the State
 15 transportation goals and measures specified in the Maryland Transportation Plan and §
 16 2–103.7 of this subtitle; and

17 (ii) The degree to which the projects and programs contained in the
 18 approved Maryland Transportation Plan and Consolidated Transportation Program attain
 19 those goals and benchmarks as measured by the performance indicators or benchmarks.

20 (2) The Department shall include in its report measurable long–term goals,
 21 and intermediate benchmarks of progress toward the attainment of the long–term goals,
 22 for the following measurable transportation indicators:

23 (i) An increase in the share of total person trips for each of transit,
 24 high occupancy auto, pedestrian, and bicycle modes of travel;

25 (ii) A decrease in indicators of traffic congestion as determined by
 26 the Department; and

27 (iii) Any other performance goals established by the Department for
 28 reducing automobile traffic and increasing the use of nonautomobile traffic.

29 **(3) (1) BEGINNING WITH THE 2024 ATTAINMENT REPORT ON**
 30 **TRANSPORTATION SYSTEM PERFORMANCE, THE ADVISORY COMMITTEE ADVISING**
 31 **THE DEPARTMENT ON STATE TRANSPORTATION GOALS, BENCHMARKS, AND**
 32 **INDICATORS SHALL RECOMMEND MEASURABLE TRANSPORTATION INDICATORS**
 33 **THAT CAN BE EVALUATED FOR:**

10 [(3)] (4) The performance indicators or benchmarks described in this
 11 subsection shall acknowledge the difference between urban and rural transportation needs.

12 (i) The Smart Growth Subcabinet, established under Title 9, Subtitle 14 of the
 13 State Government Article, shall conduct an annual review of the State transportation goals,
 14 benchmarks, and indicators.

15 (j) (1) An advisory committee shall be assembled to advise the Department on
 16 the State transportation goals, benchmarks, and indicators under subsection (h) of this
 17 section.

18 (2) Membership of the advisory committee shall include but is not limited
 19 to the following members appointed by the Governor:

20 (i) A representative of the Maryland business community;

21 (ii) A representative of the disabled citizens community;

22 (iii) A representative of rural interests;

23 (iv) A representative of an auto users group;

24 (v) A representative of a transit users group;

25 (vi) A representative of the goods movement industry;

26 (vii) A nationally recognized expert on transportation demand
 27 management;

28 (viii) A nationally recognized expert on pedestrian and bicycle
 29 transportation;

1 (ix) A nationally recognized expert on transportation performance
2 measurement;

3 (x) A representative of an environmental advocacy organization;

4 (xi) A representative from the Maryland Department of Planning;

5 (xii) A representative of the Maryland Association of Counties; [and]

6 (xiii) A representative of the Maryland Municipal League;

7 (XIV) A REPRESENTATIVE OF THE MARYLAND STATE
8 CONFERENCE OF THE NATIONAL ASSOCIATION FOR THE ADVANCEMENT OF
9 COLORED PEOPLE; ~~AND~~

10 (XV) A REPRESENTATIVE OF A TRANSPORTATION LABOR
11 ORGANIZATION, DESIGNATED BY THE MARYLAND STATE AND DISTRICT OF
12 COLUMBIA AFL-CIO; AND

13 (XVI) A REPRESENTATIVE OF THE TRANSPORTATION
14 CONSTRUCTION INDUSTRY.

15 (3) The Governor shall appoint the chairman of the advisory committee.

16 (4) The advisory committee shall meet at least four times during the
17 process of developing the Maryland Transportation Plan to provide advice to the
18 Department on meeting the requirements of this subsection.

19 (5) The Department and the advisory committee shall consider the
20 following:

21 (i) Transportation and population trends and their impact on the
22 State's transportation system and priority funding areas;

23 (ii) Past and present State funding devoted to the various
24 transportation modes and demand management;

25 (iii) The full range of unmet transportation needs in priority funding
26 areas;

27 (iv) The full range of transportation measures and facilities
28 available, and their role, effectiveness, and cost effectiveness in providing travel choices
29 and reducing congestion;

30 (v) A review of transportation performance indicators and their use
31 in other states;

1 (vi) A review of the coordination of State transportation investments
2 with local growth plans for priority funding areas;

3 (vii) The types of investments needed and their levels of funding for
4 supporting the State transportation goals and measures established under § 2–103.7 of this
5 subtitle;

6 (viii) The impact of transportation investment on:

7 1. The environment;

8 2. Environmental justice as defined in § 1–701 of the
9 Environment Article;

10 3. Communities; [and]

11 4. Economic development; [and]

12 5. **RACIAL EQUITY; AND**

13 6. ~~TO THE EXTENT DATA IS AVAILABLE, PERSONS~~
14 **PERSONS WITH DISABILITIES, INCLUDING SERVICE ACCESSIBILITY; AND**

15 (ix) The Climate Action Plan goals required by the Greenhouse Gas
16 Emissions Reduction Act of 2009 under § 2–1205(b) of the Environment Article.

18 (a) In this title the following words have the meanings indicated.

19 (b) “Administration” means the Maryland Transit Administration.

20 (c) “Administrator” means the Maryland Transit Administrator.

21 **(D) “DISPARATE IMPACT” MEANS A FACIALLY NEUTRAL POLICY OR**
22 **PRACTICE THAT DISPROPORTIONATELY AFFECTS MEMBERS OF A GROUP**
23 **IDENTIFIED BY RACE, COLOR, DISABILITY, OR NATIONAL ORIGIN, WHERE THE**
24 **RECIPIENT’S POLICY OR PRACTICE LACKS A SUBSTANTIAL LEGITIMATE**
25 **JUSTIFICATION AND WHERE THERE EXIST ONE OR MORE ALTERNATIVES THAT**
26 **WOULD SERVE THE SAME LEGITIMATE OBJECTIVES BUT WITH LESS**
27 **DISPROPORTIONATE EFFECT ON THE BASIS OF RACE, COLOR, DISABILITY, OR**
28 **NATIONAL ORIGIN.**

1 **(E) “DISPROPORTIONATE BURDEN” MEANS A FACIALLY NEUTRAL POLICY**
2 **OR PRACTICE THAT DISPROPORTIONATELY AFFECTS LOW-INCOME POPULATIONS**
3 **MORE THAN NON-LOW-INCOME POPULATIONS AND, ON A FINDING OF**
4 **DISPROPORTIONATE BURDEN, REQUIRES THE RECIPIENT TO EVALUATE**
5 **ALTERNATIVES AND MITIGATE BURDENS WHERE PRACTICABLE.**

6 **[(d)] (F) “District” means:**

7 (1) The Metropolitan Transit District, consisting of Baltimore City,
8 Baltimore County, Anne Arundel County, and other areas as designated by the Secretary
9 after consultation and coordination with the affected jurisdiction and subject to the
10 provisions of the Washington Metropolitan Transit Authority Compact; and

11 (2) Any area in which railroad service is performed under contract with the
12 Administration or in which railroad facilities are owned by the Administration.

13 **[(e)] (G) “Excursion train” means any special event train sponsored or**
14 **contracted for in connection with the promotion of a public event benefiting the State and**
15 **its citizens.**

16 **[(f)] (H) “Light rail transit” means rail transit which is electrically powered and**
17 **can operate in mixed traffic with automobiles.**

18 **[(g)] (I) “Private carrier” means any person that renders transit service within**
19 **the District under an operating permit or license issued by an agency of this State**
20 **exercising regulatory jurisdiction over transportation of passengers within this State and**
21 **over persons engaged in that business.**

22 **[(h)] (J) “Proof of fare payment” means evidence of fare prepayment authorized**
23 **by the Administration for the use of transit service.**

24 **[(i)] (K) “Railroad company” means any entity engaged in the providing of**
25 **railroad service under this title.**

26 **[(j)] (L) (1) “Railroad facility” means any facility used in providing railroad**
27 **services, and includes any one or more or combination of:**

28 (i) Switches, spurs, tracks, structures, terminals, yards, real
29 property, and other facilities useful or designed for use in connection with the
30 transportation of persons or goods by rail; and

31 (ii) All other appurtenances, including locomotives, cars, vehicles,
32 and other instrumentalities of shipment or carriage, useful or designed for use in
33 connection with the transportation of persons or goods by rail.

34 (2) “Railroad facility” does not include any transit facility.

1 **[(k)] (M)** “Railroad service” means any service utilizing rail or railroad facilities
2 performed by any common carrier operating under the jurisdiction of the State or federal
3 government as a common carrier and includes any such service performed by the National
4 Railroad Passenger Corporation.

5 **[(l)] (N)** “Transit facility” includes any one or more or combination of tracks,
6 rights-of-way, bridges, tunnels, subways, rolling stock, stations, terminals, ports, parking
7 areas, equipment, fixtures, buildings, structures, other real or personal property, and
8 services incidental to or useful or designed for use in connection with the rendering of
9 transit service by any means, including rail, bus, motor vehicle, or other mode of
10 transportation, but does not include any railroad facility.

11 **[(m)] (O)** “Transit-oriented development” means a mix of private or public
12 parking facilities, commercial and residential structures, and uses, improvements, and
13 facilities customarily appurtenant to such facilities and uses, that:

14 (1) Is part of a deliberate development plan or strategy involving:

15 (i) Property that is adjacent to the passenger boarding and alighting
16 location of a planned or existing transit station; or

17 (ii) Property, any part of which is located within one-half mile of the
18 passenger boarding and alighting location of a planned or existing transit station;

19 (2) Is planned to maximize the use of transit, walking, and bicycling by
20 residents and employees; and

21 (3) Is designated as a transit-oriented development by:

22 (i) The Secretary, after considering a recommendation of the Smart
23 Growth Subcabinet established under § 9-1406 of the State Government Article; and

24 (ii) The local government or multicounty agency with land use and
25 planning responsibility for the relevant area.

26 **[(n)] (P)** (1) “Transit service” means the transportation of persons and their
27 packages and baggage and of newspapers, express, and mail in regular route, special, or
28 charter service by means of transit facilities between points within the District.

29 (2) “Transit service” does not include any:

30 (i) Vanpool operation; or

31 (ii) Railroad service.

1 [(o)] (Q) (1) "Transit station" means any facility, the primary function of
2 which relates to the boarding and alighting of passengers from transit vehicles.

3 (2) "Transit station" includes platforms, shelters, passenger waiting
4 facilities, parking areas, access roadways, and other real property used to facilitate
5 passenger access to transit service or railroad service.

6 [(p)] (R) "Transit vehicle" means a mobile device used in rendering transit
7 service.

20 ADMINISTRATION’S TITLE VI REQUIREMENTS AND GUIDELINES FOR FEDERAL
21 TRANSIT ADMINISTRATION RECIPIENTS, THE DEPARTMENT, IN COLLABORATION
22 WITH THE ADMINISTRATION, SHALL:

23 (1) CONDUCT A TRANSIT EQUITY ANALYSIS IN ACCORDANCE WITH
24 THE FEDERAL AMERICANS WITH DISABILITIES ACT AMENDMENTS ACT AND THE
25 FEDERAL REHABILITATION ACT OF 1973 AS AMENDED TO DETERMINE WHETHER
26 THE CHANGE WILL CREATE A DISPARATE IMPACT ON PERSONS WITH DISABILITIES;

27 (2) CONDUCT A TRANSIT EQUITY ANALYSIS IN ACCORDANCE WITH
28 THE TITLE VI REQUIREMENTS AND GUIDELINES FOR FEDERAL TRANSIT
29 ADMINISTRATION RECIPIENTS TO DETERMINE WHETHER THE CHANGE WILL
30 CREATE A DISPARATE IMPACT OR A DISPROPORTIONATE BURDEN;

16 OF THE PROPOSED SERVICE CHANGE; AND

17 (II) CONDUCT A TRANSIT EQUITY ANALYSIS ON THE
18 ALTERNATIVES.

19 (2) IF A DISPARATE IMPACT CAN BE AVOIDED THROUGH USE OF ONE
20 OF THE ALTERNATIVES ANALYZED, THE ADMINISTRATION SHALL PROCEED WITH
21 THAT ALTERNATIVE AS THE PRIMARY PROPOSED SERVICE CHANGE.

22 (3) IF THERE IS NO ALTERNATIVE THAT WOULD AVOID A DISPARATE

4 **CHANGE, THE ADMINISTRATION SHALL PUBLISH ON THE ADMINISTRATION’S**
5 **WEBSITE, FOR THE ROUTES OR LINES IMPACTED BY THE SERVICE CHANGE, AN**
6 **EVALUATION ON THE DEMOGRAPHICS OF:**

23 **SUBSTANTIAL JUSTIFICATION STATEMENT.**
