A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Procedure – Expungement of Records – Waiting Periods**
3 **(REDEEM Act of 2023)**

4 FOR the purpose of altering the waiting periods applicable to the filing of petitions for
5 expungement of convictions of certain crimes; and generally relating to expungement
6 of records.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Criminal Procedure**

20 10–110.

21 (a) A person may file a petition listing relevant facts for expungement of a police
22 record, court record, or other record maintained by the State or a political subdivision of
23 the State if the person is convicted of:

20 controlled dangerous substance under § 5–602 of the Criminal Law Article; or

21 (iii) § 6–202(a), § 6–203, or § 6–204 of the Criminal Law Article; or

22 (3) an attempt, a conspiracy, or a solicitation of any offense listed in item
23 (1) or (2) of this subsection.

24 (c) (1) Except as **OTHERWISE** provided in [paragraphs (2), (3), and (4) of] this
25 subsection, a petition for expungement under this section may not be filed earlier than [10]
26 **3** years after the person satisfies the sentence or sentences imposed for all convictions for
27 which expungement is requested, including parole, probation, or mandatory supervision.

28 (2) A petition for expungement for a violation of § 3–203 of the Criminal
29 Law Article[, OR common law battery[, or for an offense classified as a domestically related
30 crime under § 6–233 of this article] may not be filed earlier than [15] **5** years after the

1 person satisfies the sentence or sentences imposed for all convictions for which
2 expungement is requested, including parole, probation, or mandatory supervision.

3 **(3) A PETITION FOR EXPUNGEMENT FOR AN OFFENSE CLASSIFIED AS**
4 **A DOMESTICALLY RELATED CRIME UNDER § 6-233 OF THIS ARTICLE MAY NOT BE**
5 **FILED EARLIER THAN 15 YEARS AFTER THE PERSON SATISFIES THE SENTENCE OR**
6 **SENTENCES IMPOSED FOR ALL CONVICTIONS FOR WHICH EXPUNGEMENT IS**
7 **REQUESTED, INCLUDING PAROLE, PROBATION, OR MANDATORY SUPERVISION.**

8 ~~[(3)] (4)~~ Except as provided in paragraph ~~[(4)] (5)~~ of this subsection, a
9 petition for expungement of a felony may not be filed earlier than ~~[15] 5~~ years after the
10 person satisfies the sentence or sentences imposed for all convictions for which
11 expungement is requested, including parole, probation, or mandatory supervision.

12 ~~[(4)] (5)~~ A petition for expungement of a conviction of possession with
13 intent to distribute cannabis under § 5-602 of the Criminal Law Article may not be filed
14 earlier than 3 years after the person satisfies the sentence or sentences imposed for all
15 convictions for which expungement is requested, including parole, probation, or mandatory
16 supervision.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2023.
