## A BILL ENTITLED

1 AN ACT concerning

2 **Institutions of Higher Education – Transcripts – Prohibition on Punitive**  
3 **Measures Related to Student Debt**

4 FOR the purpose of prohibiting an institution of higher education from refusing to provide  
5 a current or former student with a transcript or taking other punitive measures  
6 regarding a student’s transcript request because the student owes a debt to the  
7 institution of higher education; and generally relating to the prohibition on punitive  
8 measures by institutions of higher education regarding transcript requests from  
9 students who owe debts to the institution.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – Education**

18 **15–118.**

19 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**  
20 **INDICATED.**

21 **(2) (I) “DEBT” MEANS ANY MONEY, OBLIGATION, CLAIM, OR SUM**  
22 **DUE OR OWED BY A STUDENT TO AN INSTITUTION OF HIGHER EDUCATION.**

23 **(II) “DEBT” INCLUDES:**

1                   **1. CREDIT EXTENDED BY OR ON BEHALF OF THE**  
2 **INSTITUTION THAT A STUDENT IS OBLIGATED TO REPAY; AND**

3                   **2. A NONFEDERAL LOAN OR DEBT AGREEMENT THAT IS**  
4 **ISSUED EXPRESSLY FOR POSTSECONDARY EDUCATION EXPENSES AND THAT IS**  
5 **GUARANTEED BY:**

6                   **A. AN INSTITUTION OF HIGHER EDUCATION; OR**

7                   **B. A PRIVATE EDUCATIONAL LENDER THAT IS**  
8 **AFFILIATED WITH AN INSTITUTION OF HIGHER EDUCATION.**

9                   **(III) "DEBT" DOES NOT INCLUDE THE FEE, IF ANY, CHARGED TO**  
10 **A STUDENT FOR THE ACTUAL COSTS OF PROVIDING A TRANSCRIPT.**

11                   **(3) "STUDENT" INCLUDES CURRENT STUDENTS AND FORMER**  
12 **STUDENTS OF AN INSTITUTION OF HIGHER EDUCATION.**

13                   **(B) AN INSTITUTION OF HIGHER EDUCATION MAY NOT:**

14                   **(1) REFUSE TO PROVIDE A TRANSCRIPT TO A STUDENT BECAUSE THE**  
15 **STUDENT OWES A DEBT;**

16                   **(2) CONDITION THE ISSUANCE OF A TRANSCRIPT ON THE PAYMENT**  
17 **OF A DEBT;**

18                   **(3) CHARGE A HIGHER FEE FOR OBTAINING A TRANSCRIPT BECAUSE**  
19 **A STUDENT OWES A DEBT;**

20                   **(4) PROVIDE LESS FAVORABLE TREATMENT OF A TRANSCRIPT**  
21 **REQUEST BECAUSE A STUDENT OWES A DEBT; OR**

22                   **(5) USE TRANSCRIPT ISSUANCE AS A TOOL FOR DEBT COLLECTION.**

23                   **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July**  
24 **1, 2023.**
