2 **State Employee Rights and Protections – Personnel Actions and Harassment –**
3 **Complaints**

4 FOR the purpose of authorizing a certain applicant or employee to file a certain complaint
5 within a certain period of time alleging harassment by an employer; increasing the
6 period of time for a certain applicant or employee to file a certain complaint alleging
7 certain prohibited personnel actions; and generally relating to State employee rights
8 and protections.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – State Government**

2 (a) An employer may not:

3 (5) engage in harassment of an employee.

4 **Article – State Personnel and Pensions**

5 5-211.

6 (a) An applicant or employee subject to this subtitle may file with the head of the
7 principal unit a written complaint:

8 (1) that alleges a violation of § 5-208 of this subtitle; OR

9 (2) **THAT ALLEGES HARASSMENT IN VIOLATION OF § 20-606(A)(5) OF**
10 **THE STATE GOVERNMENT ARTICLE.**

11 (b) A complaint under [this subtitle] **SUBSECTION (A)(1) OF THIS SECTION**
12 **must be filed within [30 days] 1 YEAR** after the complainant first knew of or reasonably
13 should have known of the alleged violation that is the basis for the complaint.

14 (c) **A COMPLAINT UNDER SUBSECTION (A)(2) OF THIS SECTION MUST BE**
15 **FILED WITHIN 2 YEARS AFTER THE ALLEGED VIOLATION THAT IS THE BASIS FOR THE**
16 **COMPLAINT.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2023.
