A BILL ENTITLED

1 AN ACT concerning

2 **Department of Transportation – Heads of Business Units – Appointment and**
3 **Senate Confirmation**

4 FOR the purpose of requiring that certain heads of business units in the Department of
5 Transportation be appointed by the Secretary of Transportation with the approval
6 of the Governor; requiring that the heads of business units in the Department be
7 appointed with the advice and consent of the Senate; and generally relating to the
8 heads of business units in the Department of Transportation.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

Article – Transportation

23 There is a Maryland Transportation Authority.

1 (a) **(1) THE HEAD OF THE AUTHORITY IS THE EXECUTIVE DIRECTOR,**
2 **WHO SHALL BE APPOINTED BY THE SECRETARY WITH THE APPROVAL OF THE**
3 **GOVERNOR AND THE ADVICE AND CONSENT OF THE SENATE.**

4 **(2)** The Authority is entitled to the staff provided in the State budget.

6 There is a Maryland Aviation Administration in the Department.

8 (a) The head of the Administration is the Executive Director, **WHO SHALL BE**
9 **APPOINTED BY THE SECRETARY WITH THE APPROVAL OF THE GOVERNOR AND THE**
10 **ADVICE AND CONSENT OF THE SENATE.**

11 6-202.

12 There is a Maryland Port Administration.

13 6-203.

14 (a) The head of the Administration is the Executive Director, **WHO SHALL BE**
15 **APPOINTED BY THE SECRETARY WITH THE APPROVAL OF THE GOVERNOR AND THE**
16 **ADVICE AND CONSENT OF THE SENATE.**

17 7-201.

18 There is a Maryland Transit Administration in the Department.

19 7-202.

20 (a) The head of the Administration is the Maryland Transit Administrator, who
21 shall be appointed by the Secretary with the approval of the Governor **AND THE ADVICE**
22 **AND CONSENT OF THE SENATE.**

23 8-201.

24 There is a State Highway Administration in the Department.

25 8-202.

26 (a) The head of the Administration is the State Highway Administrator, who shall
27 be appointed by the Secretary with the approval of the Governor **AND THE ADVICE AND**
28 **CONSENT OF THE SENATE.**

1 12-101.

2 There is a Motor Vehicle Administration in the Department.

3 12-102.

4 (a) The head of the Administration is the Motor Vehicle Administrator, who shall
5 be appointed by the Secretary with the approval of the Governor **AND THE ADVICE AND**
6 **CONSENT OF THE SENATE.**

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 October 1, 2023.
