8 (1) the child was convicted in an unrelated case excluded from the
9 jurisdiction of the juvenile court under [§ 3–8A–03(e)(1) or (4)] **§ 3–8A–03(D)(1) OR (4)** of

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
10 1, 2021. [It shall remain effective for a period of 2 years and 1 month and, at the end of
11 June 30, 2023, this Act, with no further action required by the General Assembly, shall be
12 abrogated and of no further force and effect.]

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
21 1, 2022. It shall remain effective for a period of 1 year and 9 months and, at the end of
22 [February 28, 2023] **MARCH 1, 2024**, this Act, with no further action required by the
23 General Assembly, shall be abrogated and of no further force and effect.

1 intended solely to correct technical errors in the law and there is no intent to revive or
2 otherwise affect law that is the subject of other acts, whether those acts were signed by the
3 Governor prior to or after the signing of this Act.

4 SECTION 5. AND BE IT FURTHER ENACTED, That the publishers of the
5 Annotated Code of Maryland, subject to the approval of the Department of Legislative
6 Services, shall make any changes in the text of the Annotated Code necessary to effectuate
7 any termination provision that was enacted by the General Assembly and has taken effect
8 or will take effect prior to October 1, 2023. Any enactment of the 2023 Session of the General
9 Assembly that negates or extends the effect of a previously enacted termination provision
10 shall prevail over the provisions of this section.

11 SECTION 6. AND BE IT FURTHER ENACTED, That the publishers of the
12 Annotated Code of Maryland, in consultation with and subject to the approval of the
13 Department of Legislative Services, shall make nonsubstantive corrections to codification,
14 style, capitalization, punctuation, grammar, spelling, and any reference rendered incorrect
15 or obsolete by an Act of the General Assembly, with no further action required by the
16 General Assembly. The publishers shall adequately describe any such correction in an
17 editor's note following the section affected.

18 SECTION 7. AND BE IT FURTHER ENACTED, That this Act is an emergency
19 measure, is necessary for the immediate preservation of the public health or safety, has
20 been passed by a yea and nay vote supported by three-fifths of all the members elected to
21 each of the two Houses of the General Assembly, and shall take effect from the date it is
22 enacted.
