## A BILL ENTITLED

1 AN ACT concerning

2 **Statewide Rental Assistance Voucher Program – Establishment**

3 FOR the purpose of establishing a Statewide Rental Assistance Voucher Program in the  
4 Department of Housing and Community Development to provide vouchers and  
5 housing assistance payments for low-income families that are on a certain federal  
6 housing program waitlist; requiring the Department and public housing agencies to  
7 administer the State Program; and generally relating to the Statewide Rental  
8 Assistance Voucher Program.

9 BY repealing and reenacting, with amendments,  
10 Article – Housing and Community Development  
11 Section 4–101, 4–103, and 4–1401  
12 Annotated Code of Maryland  
13 (2019 Replacement Volume and 2022 Supplement)

14 BY adding to  
15 Article – Housing and Community Development  
16 Section 4–2901 through 4–2921 to be under the new subtitle “Subtitle 29. Statewide  
17 Rental Assistance Voucher Program”  
18 Annotated Code of Maryland  
19 (2019 Replacement Volume and 2022 Supplement)

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
21 That the Laws of Maryland read as follows:

22 **Article – Housing and Community Development**

24 (a) In this title the following words have the meanings indicated.

1 (b) “Administration” means the Community Development Administration.

2 (c) “Division” means the Division of Development Finance.

3 (d) “Elderly household” means, **EXCEPT AS PROVIDED IN § 4–2901 OF THIS**  
4 **TITLE**, one or more individuals who occupy a residential dwelling unit, at least one of whom  
5 meets the age limit specified by the Secretary that:

6 (1) is greater than or equal to age 55; and

7 (2) may vary for different programs or types of projects.

8 (e) “Nonprofit sponsor” means a sponsor that is:

9 (1) a nonprofit organization; or

10 (2) a limited partnership, if:

11 (i) 1. each general partner is a nonprofit organization; or

12 2. each general partner is a wholly owned subsidiary of a  
13 nonprofit organization;

14 (ii) the limited partnership is formed to undertake a project that is  
15 eligible as a whole or in part for a federal program or incentive, including low-income  
16 housing tax credits; and

17 (iii) a nonprofit organization manages the project or will receive the  
18 net cash flow or residual sale proceeds on the sale of the project.

- 1 (8) the local government infrastructure program;
- 2 (9) the Maryland Home Financing Program;
- 3 (10) the Maryland Housing Rehabilitation Program;
- 4 (11) the Neighborhood Housing Services Fund;
- 5 (12) the Operating Assistance Grants Demonstration Projects;
- 6 (13) the Partnership Rental Housing Program;
- 7 (14) the Radium Grant Program;
- 8 (15) the Rental Allowance Program, **THE STATEWIDE RENTAL**  
9 **ASSISTANCE VOUCHER PROGRAM**, and other rental assistance programs;
- 10 (16) the Rental Housing Program; and
- 11 (17) the Self-Help Homeownership Technical Assistance Program.

19 **(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS**  
20 **INDICATED.**

21 **(B) “DISABLED” MEANS HAVING:**

22 **(1) A DISABILITY UNDER 42 U.S.C. § 423;**

23 **(2) A PHYSICAL, MENTAL, OR EMOTIONAL IMPAIRMENT THAT IS**  
24 **EXPECTED TO BE OF LONG-CONTINUED AND INDEFINITE DURATION, IS EXPECTED**  
25 **TO SUBSTANTIALLY IMPEDE AN INDIVIDUAL’S ABILITY TO LIVE INDEPENDENTLY,**  
26 **AND MAY BE IMPROVED BY MORE SUITABLE HOUSING OPTIONS; OR**

1           **(3) A DEVELOPMENTAL DISABILITY AS DEFINED IN THE FEDERAL**  
2 **DEVELOPMENTAL DISABILITIES ASSISTANCE AND BILL OF RIGHTS ACT.**

3           **(C) “ELDERLY” MEANS AN INDIVIDUAL THAT IS AT LEAST 62 YEARS OLD.**

4           **(D) (1) “FAMILY” MEANS AN INDIVIDUAL OR GROUP OF INDIVIDUALS**  
5 **ELIGIBLE FOR ASSISTANCE UNDER THE STATE PROGRAM.**

6           **(2) “FAMILY” INCLUDES A PREFERENCE CATEGORY ESTABLISHED**  
7 **UNDER § 4-2906(B) OF THIS SUBTITLE.**

8           **(E) “HOUSING ASSISTANCE PAYMENT” MEANS THE MONTHLY ASSISTANCE**  
9 **PAYMENT PAID FOR A FAMILY UNDER THE STATE PROGRAM.**

10           **(F) “HOUSING CHOICE VOUCHER PROGRAM” MEANS THE PROGRAM**  
11 **ESTABLISHED UNDER 24 C.F.R. PART 982.**

12           **(G) “LIVE-IN AIDE” MEANS AN INDIVIDUAL THAT:**

13                   **(1) MEETS THE REQUIREMENTS UNDER 24 C.F.R. § 5.403; AND**

14                   **(2) RESIDES WITH AN ELDERLY OR DISABLED INDIVIDUAL WHO**  
15 **RECEIVES ASSISTANCE UNDER THE STATE PROGRAM.**

16           **(H) “PAYMENT STANDARD” MEANS THE MAXIMUM MONTHLY HOUSING**  
17 **ASSISTANCE PAYMENT FOR A FAMILY ASSISTED UNDER THE STATE PROGRAM.**

18           **(I) (1) “PUBLIC HOUSING AGENCY” MEANS AN ENTITY AUTHORIZED BY**  
19 **THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO ADMINISTER**  
20 **THE FEDERAL HOUSING CHOICE VOUCHER PROGRAM IN THE STATE.**

21                   **(2) “PUBLIC HOUSING AGENCY” DOES NOT INCLUDE THE**  
22 **DEPARTMENT.**

23           **(J) “STATE PROGRAM” MEANS THE STATEWIDE RENTAL ASSISTANCE**  
24 **VOUCHER PROGRAM ESTABLISHED UNDER THIS SUBTITLE.**

25           **(K) “VOUCHER” MEANS A DOCUMENT ISSUED BY THE DEPARTMENT OR A**  
26 **PUBLIC HOUSING AGENCY TO A FAMILY THAT IS SELECTED TO RECEIVE ASSISTANCE**  
27 **UNDER THE STATE PROGRAM, WHICH DESCRIBES THE STATE PROGRAM AND**  
28 **PROCEDURES UNDER THE STATE PROGRAM.**

29 **4-2902.**

1           **THERE IS A STATEWIDE RENTAL ASSISTANCE VOUCHER PROGRAM IN THE**  
2 **DEPARTMENT.**

3 **4-2903.**

4           **THE PURPOSE OF THE STATE PROGRAM IS TO PROVIDE VOUCHERS AND**  
5 **HOUSING ASSISTANCE PAYMENTS FOR LOW-INCOME FAMILIES THAT ARE**  
6 **CURRENTLY ON A WAITING LIST UNDER THE FEDERAL HOUSING CHOICE VOUCHER**  
7 **PROGRAM FOR HOUSING IN UNITS APPROVED BY THE DEPARTMENT OR A PUBLIC**  
8 **HOUSING AGENCY, IN ACCORDANCE WITH GUIDELINES UNDER THE FEDERAL**  
9 **HOUSING CHOICE VOUCHER PROGRAM.**

10 **4-2904.**

11           **(A) (1) IN POLITICAL SUBDIVISIONS WITHOUT A LOCAL ADMINISTRATOR**  
12 **UNDER THE FEDERAL HOUSING CHOICE VOUCHER PROGRAM, THE DEPARTMENT**  
13 **SHALL ADMINISTER THE STATE PROGRAM AND ISSUE VOUCHERS AND HOUSING**  
14 **ASSISTANCE PAYMENTS TO ASSIST LOW-INCOME HOUSEHOLDS THAT ARE ELIGIBLE**  
15 **FOR BUT ARE NOT CURRENTLY RECEIVING HOUSING CHOICE VOUCHERS UNDER THE**  
16 **FEDERAL HOUSING CHOICE VOUCHER PROGRAM.**

17           **(2) IN POLITICAL SUBDIVISIONS WITH A PUBLIC HOUSING**  
18 **AGENCY-ADMINISTRATOR UNDER THE FEDERAL HOUSING CHOICE VOUCHER**  
19 **PROGRAM, THE PUBLIC HOUSING AGENCY SHALL ADMINISTER THE STATE**  
20 **PROGRAM AND ISSUE VOUCHERS AND HOUSING ASSISTANCE PAYMENTS TO ASSIST**  
21 **LOW-INCOME HOUSEHOLDS THAT ARE ELIGIBLE FOR BUT ARE NOT CURRENTLY**  
22 **RECEIVING HOUSING CHOICE VOUCHERS UNDER THE FEDERAL HOUSING CHOICE**  
23 **VOUCHER PROGRAM.**

24           **(B) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE, THE STATE**  
25 **PROGRAM SHALL BE ADMINISTERED IN ACCORDANCE WITH FEDERAL GUIDELINES**  
26 **UNDER THE FEDERAL HOUSING CHOICE VOUCHER PROGRAM.**

27 **4-2905.**

28           **TO BE ELIGIBLE FOR A HOUSING ASSISTANCE PAYMENT UNDER THE STATE**  
29 **PROGRAM, A FAMILY SHALL:**

30           **(1) RESIDE IN THE STATE;**

31           **(2) BE ON A FEDERAL HOUSING CHOICE VOUCHER WAITING LIST; AND**

1           **(3) MEET LOW-INCOME ELIGIBILITY LIMITS UNDER THE FEDERAL**  
2 **HOUSING CHOICE VOUCHER PROGRAM OR INCOME REQUIREMENTS AS**  
3 **DETERMINED BY THE PUBLIC HOUSING AGENCY.**

4 **4-2906.**

5           **THE DEPARTMENT AND EACH PUBLIC HOUSING AGENCY SHALL PRIORITIZE**  
6 **VOUCHERS AND HOUSING ASSISTANCE PAYMENTS FOR FAMILIES THAT INCLUDE:**

7           **(1) A CHILD WHO IS UNDER THE AGE OF 16 YEARS;**

8           **(2) A MILITARY VETERAN;**

9           **(3) AN INDIVIDUAL EXPERIENCING HOMELESSNESS;**

10          **(4) A DISABLED INDIVIDUAL; OR**

11          **(5) AN ELDERLY INDIVIDUAL.**

12 **4-2907.**

13           **WHEN AN OFFER OF ASSISTANCE IS MADE, A FAMILY HAS 15 DAYS TO PROVIDE**  
14 **DOCUMENTATION TO VERIFY THEIR INCOME WITH THE DEPARTMENT OR THE**  
15 **PUBLIC HOUSING AGENCY.**

16 **4-2908.**

17          **(A) THE DEPARTMENT OR A PUBLIC HOUSING AGENCY SHALL CALCULATE**  
18 **PAYMENT STANDARDS AND HOUSING ASSISTANCE PAYMENTS UNDER THE STATE**  
19 **PROGRAM IN ACCORDANCE WITH GUIDELINES FOR THE FEDERAL HOUSING CHOICE**  
20 **VOUCHER PROGRAM.**

21          **(B) A FAMILY ASSISTED UNDER THE STATE PROGRAM SHALL BE EXPECTED**  
22 **TO PAY A PROPORTION OF ITS MONTHLY ADJUSTED GROSS INCOME FOR RENT AND**  
23 **UTILITIES, AS DETERMINED BY THE DEPARTMENT OR THE PUBLIC HOUSING**  
24 **AGENCY.**

25 **4-2909.**

26           **HOUSING ASSISTANCE PAYMENTS FOR A FAMILY SHALL CONTINUE FOR UP TO**  
27 **5 YEARS OR UNTIL A FEDERAL HOUSING CHOICE VOUCHER UNDER THE FEDERAL**  
28 **HOUSING CHOICE VOUCHER PROGRAM BECOMES AVAILABLE, WHICHEVER OCCURS**  
29 **FIRST.**

2 (A) A FAMILY MAY REQUEST THAT THE DEPARTMENT OR A PUBLIC  
3 HOUSING AGENCY APPROVE A LIVE-IN AIDE IF THE FAMILY IS COMPOSED OF A  
4 DISABLED INDIVIDUAL WHO IS THE HEAD OF HOUSEHOLD.

5 (B) THE DEPARTMENT OR A PUBLIC HOUSING AGENCY SHALL APPROVE A  
6 LIVE-IN AIDE IF A LIVE-IN AIDE IS REQUIRED AS A REASONABLE ACCOMMODATION  
7 UNDER 24 C.F.R. § 8.11.

8 (C) THE DEPARTMENT OR A PUBLIC HOUSING AGENCY MAY NOT INCLUDE A  
9 LIVE-IN AIDE'S INCOME WHEN DETERMINING A FAMILY'S INCOME ELIGIBILITY  
10 UNDER THE STATE PROGRAM.

11 4-2911.

12 (A) (1) (I) THE DEPARTMENT OR A PUBLIC HOUSING AGENCY SHALL  
13 CONDUCT ANNUAL INSPECTIONS OF EACH UNIT RENTED USING HOUSING  
14 ASSISTANCE PAYMENTS TO ENSURE THE CONTINUED COMPLIANCE WITH FEDERAL  
15 HOUSING QUALITY STANDARDS UNDER 24 C.F.R. § 982.401.

16 (II) INSPECTIONS SHALL OCCUR ON THE INITIAL LEASE DATE  
17 AND EACH YEAR THEREAFTER.

18 (2) FOR A UNIT LOCATED IN A BUILDING WITH 3 TO 49 UNITS, THE  
19 PROPERTY OWNER SHALL PROVIDE THE DEPARTMENT OR THE PUBLIC HOUSING  
20 AGENCY WITH A CERTIFICATE OF OCCUPANCY THAT HAS BEEN COMPLETED WITHIN  
21 1 YEAR.

22 (3) FOR A UNIT LOCATED IN A BUILDING WITH 50 UNITS OR MORE,  
23 THE PROPERTY OWNER SHALL PROVIDE THE DEPARTMENT OR THE PUBLIC  
24 HOUSING AGENCY WITH AN INSPECTION CERTIFICATE.

25 (B) A PROPERTY OWNER WHO HAS RECEIVED THREE OR MORE PENALTY  
26 NOTICES FROM THE DEPARTMENT OR A PUBLIC HOUSING AGENCY FOR A VIOLATION  
27 OF FEDERAL HOUSING QUALITY STANDARDS IS NOT ELIGIBLE TO LEASE THE  
28 OWNER'S PROPERTIES TO FAMILIES RECEIVING ASSISTANCE UNDER THE STATE  
29 PROGRAM.

9                           **(II) DENYING A VOUCHER UNDER THE STATE PROGRAM;**

10                          **(III) WITHDRAWING A STATE PROGRAM VOUCHER;**

11                          **(IV) REFUSING TO ENTER INTO A CONTRACT FOR HOUSING**  
12 **ASSISTANCE PAYMENTS; OR**

13                          **(V) REFUSING TO APPROVE A LEASE UNDER THE STATE**  
14 **PROGRAM.**

15           **(2) THE DEPARTMENT OR A PUBLIC HOUSING AGENCY SHALL DENY**  
16 **ASSISTANCE UNDER THE STATE PROGRAM TO:**

17                          **(I) SEX OFFENDERS WHO ARE SUBJECT TO A LIFETIME**  
18 **REGISTRATION REQUIREMENT UNDER A STATE SEX OFFENDER REGISTRATION**  
19 **PROGRAM; AND**

20                          **(II) ALL OTHER SEX OFFENDERS, FOR 10 YEARS FOLLOWING**  
21 **THEIR CONVICTION FOR A SEX-RELATED CRIME.**

22           **(3) THE DEPARTMENT OR A PUBLIC HOUSING AGENCY MAY DENY**  
23 **ASSISTANCE UNDER THE STATE PROGRAM IF THE DEPARTMENT OR A PUBLIC**  
24 **HOUSING AGENCY FINDS THAT ANY INDIVIDUAL IN A FAMILY HAS BEEN CONVICTED**  
25 **OF:**

26                          **(I) A DRUG-RELATED CRIME UNDER STATE LAW; OR**

27                          **(II) A VIOLENT CRIME.**

28           **(4) IF THE DEPARTMENT OR PUBLIC HOUSING AGENCY DENIES**  
29 **ASSISTANCE UNDER THE STATE PROGRAM, THE DEPARTMENT OR THE PUBLIC**



1 HOUSING AGENCY SHALL PROMPTLY PROVIDE THE APPLICANT WITH A NOTICE  
2 EXPLAINING THE DENIAL AND INDICATING THAT THE APPLICANT MAY REQUEST AN  
3 INFORMAL REVIEW.

4 (B) (1) THE DEPARTMENT OR A PUBLIC HOUSING AGENCY MAY  
5 TERMINATE ASSISTANCE UNDER THE STATE PROGRAM BY:

6 (I) REFUSING TO ENTER INTO A STATE PROGRAM CONTRACT;

7 (II) REFUSING TO APPROVE A LEASE UNDER THE STATE  
8 PROGRAM; OR

9 (III) TERMINATING HOUSING ASSISTANCE PAYMENTS UNDER A  
10 STATE PROGRAM CONTRACT.

11 (2) THE DEPARTMENT OR A PUBLIC AGENCY SHALL TERMINATE  
12 ASSISTANCE UNDER THE STATE PROGRAM FOR:

13 (I) FAMILIES WHO WERE EVICTED UNDER THE STATE  
14 PROGRAM FOR SERIOUS VIOLATIONS OF THE LEASE;

15 (II) FAMILIES WHO FAIL TO SIGN ANY FORMS FROM THE  
16 DEPARTMENT OR A PUBLIC HOUSING AGENCY INDICATING CONSENT TO OBTAIN  
17 INFORMATION;

18 (III) SEX OFFENDERS SUBJECT TO A LIFETIME REGISTRATION  
19 REQUIREMENT UNDER A STATE SEX OFFENDER REGISTRATION PROGRAM;

20 (IV) ALL OTHER SEX OFFENDERS, FOR 10 YEARS FOLLOWING  
21 THEIR CONVICTION FOR A SEX-RELATED CRIME UNDER STATE LAW; AND

22 (V) FAMILIES THAT ARE ABSENT FROM A STATE PROGRAM UNIT  
23 FOR MORE THAN 180 CONSECUTIVE DAYS.

24 (C) AFTER CONSIDERING ALL RELEVANT CIRCUMSTANCES, INCLUDING THE  
25 SERIOUSNESS OF THE CASE, THE EXTENT OF PARTICIPATION OR CULPABILITY OF  
26 INDIVIDUAL FAMILY MEMBERS, MITIGATING CIRCUMSTANCES RELATED TO THE  
27 DISABILITY OF A FAMILY MEMBER, AND THE EFFECTS OF DENIAL OR TERMINATION  
28 OF ASSISTANCE ON OTHER FAMILY MEMBERS WHO WERE NOT INVOLVED IN THE  
29 ACTION OR FAILURE, THE DEPARTMENT OR THE PUBLIC HOUSING AGENCY MAY  
30 DENY ADMISSION INTO OR TERMINATE ASSISTANCE UNDER THE STATE PROGRAM IF  
31 A FAMILY MEMBER:

1           **(1) VIOLATES ANY OBLIGATIONS UNDER THE STATE PROGRAM;**

2           **(2) HAS BEEN EVICTED FROM FEDERALLY ASSISTED HOUSING WITHIN**  
3 **THE PRECEDING 3 YEARS;**

4           **(3) HAS COMMITTED FRAUD, BRIBERY, OR ANY OTHER CORRUPT OR**  
5 **CRIMINAL ACT IN CONNECTION WITH THE STATE PROGRAM;**

6           **(4) OWES A FINANCIAL OBLIGATION TO THE DEPARTMENT OR PUBLIC**  
7 **HOUSING AGENCY IN CONNECTION WITH ANOTHER HOUSING OR RENTAL**  
8 **ASSISTANCE PROGRAM;**

9           **(5) BREACHES A REPAYMENT AGREEMENT TO PAY AMOUNTS OWED**  
10 **TO THE DEPARTMENT OR PUBLIC HOUSING AGENCY; OR**

11           **(6) HAS ENGAGED IN OR THREATENED ABUSIVE OR VIOLENT**  
12 **BEHAVIOR TOWARD DEPARTMENT OR PUBLIC HOUSING AGENCY EMPLOYEES.**

13           **(D) (1) THE DEPARTMENT OR A PUBLIC HOUSING AGENCY MAY PROHIBIT**  
14 **OTHER FAMILY MEMBERS WHO PARTICIPATED IN OR WERE CULPABLE FOR ACTIONS**  
15 **SPECIFIED UNDER THIS SECTION FROM RESIDING IN A UNIT RENTED USING**  
16 **ASSISTANCE FROM THE STATE PROGRAM.**

17           **(2) IN MAKING THE DETERMINATION UNDER PARAGRAPH (1) OF THIS**  
18 **SUBSECTION, THE DEPARTMENT OR A PUBLIC HOUSING AGENCY MAY CONSIDER:**

19                   **(I) THE SERIOUSNESS OF THE CASE;**

20                   **(II) THE EXTENT OF PARTICIPATION BY OR CULPABILITY OF**  
21 **INDIVIDUAL FAMILY MEMBERS;**

22                   **(III) MITIGATING CIRCUMSTANCES RELATED TO THE DISABILITY**  
23 **OF A FAMILY MEMBER; AND**

24                   **(IV) THE EFFECTS OF THE PROHIBITION ON OTHER FAMILY**  
25 **MEMBERS WHO WERE NOT INVOLVED IN THE ACTION OR FAILURE.**

26 **4-2914.**

27           **(A) A FAMILY THAT RECEIVES A VOUCHER UNDER THE STATE PROGRAM**  
28 **SHALL:**

1           **(1) SUPPLY ANY INFORMATION TO THE DEPARTMENT OR THE PUBLIC**  
2 **HOUSING AGENCY NECESSARY FOR THE ADMINISTRATION OF THE STATE PROGRAM;**

3           **(2) NOTIFY THE DEPARTMENT OR THE PUBLIC HOUSING AGENCY**  
4 **BEFORE VACATING THE UNIT;**

5           **(3) USE THE UNIT ONLY AS A PRINCIPAL PLACE OF RESIDENCE; AND**

6           **(4) MAINTAIN ALL UTILITIES THAT ARE NOT PAID THROUGH THE**  
7 **HOUSING ASSISTANCE PAYMENT.**
