AMENDMENTS TO HOUSE BILL 892
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**and Young**” and substitute “**Young, Toles, Conaway, and Williams**”; in line 2, strike “**Trafficking**” and substitute “**Exploitation**”; in line 9, strike “trafficking” and substitute “**exploitation**”; strike beginning with “3-1301” in line 12 down through “Trafficking” in line 13 and substitute “**8-524**”; strike line 19 in its entirety; and in line 20, strike “**3-1301.**” and substitute “**8-524.**”.

On page 2, in line 1, after “(A)” insert “**(1)**”; in the same line, strike “SUBTITLE” and substitute “**SECTION**”; in lines 3, 22, and 24, strike “(B)”, “(C)”, and “(D)”, respectively, and substitute “**(2)**”, “**(3)**”, and “**(4)**”, respectively; in lines 4, 8, 12, 16, 19, 25, and 28, strike “(1)”, “(2)”, “(3)”, “(4)”, “(5)”, “(1)”, and “(2)”, respectively, and substitute “**(I)**”, “**(II)**”, “**(III)**”, “**(IV)**”, “**(V)**”, “**(I)**”, and “**(II)**”, respectively; and in lines 4 and 6, strike “(I)” and “(II)”, respectively, and substitute “**1.**” and “**2.**”, respectively.

On page 3, in lines 1, 6, and 13, strike “(E)”, “(F)”, and “(G)”, respectively, and substitute “**(5)**”, “**(6)**”, and “**(7)**”, respectively; in lines 7, 8, 9, 10, and 12, strike “(1)”, “(2)”, “(3)”, “(4)”, and “(5)”, respectively, and substitute “**(I)**”, “**(II)**”, “**(III)**”, “**(IV)**”, and “**(V)**”, respectively; in lines 19 and 29, strike “(A)” and “(B)”, respectively, and substitute “**(B)**” and “**(C)**”, respectively; and in line 29, strike “(A)” and substitute “**(B)**”.

On page 4, in line 1, strike “(C)” and substitute “**(D)**”.

AMENDMENT NO. 2

On page 2, in line 18, strike “OR”; and in line 21, after “ADULT” insert “**; OR**”.

(VI) DEPRIVING AN INDIVIDUAL OF MEDICAL CARE.

On page 3, in line 7, after “**MEDICARE**” insert “**BENEFITS**”; in line 8, after “**MEDICAID**” insert “**BENEFITS**”; in line 9, after “**(TANF)**” insert “**BENEFITS**”; in line 11, after “**(WIC)**” insert “**BENEFITS**”; in line 11, strike the second “**AND**”; in line 12, after “**(SNAP)**” insert “**BENEFITS**”;

(VI) SOCIAL SECURITY BENEFITS;

(VII) SOCIAL SECURITY DISABILITY (SSDI) BENEFITS;

(VIII) VETERANS BENEFITS;

(IX) PENSION BENEFITS;

(X) TEMPORARY DISABILITY ASSISTANCE PROGRAM (TDAP) BENEFITS; AND

(XI) PUBLIC ASSISTANCE TO ADULTS (PAA) BENEFITS;

and strike line 18 in its entirety.
