## A BILL ENTITLED

1 AN ACT concerning

2 **Interstate Social Work Licensure Compact**

3 FOR the purpose of entering into the Social Work Licensure Compact for the purpose of  
4 authorizing regulated social workers who hold multistate licenses to practice social  
5 work in member states; establishing requirements for multistate licensure;  
6 establishing the Social Work Licensure Compact Commission; providing for  
7 withdrawal from the Compact; and generally relating to the Social Work Licensure  
8 Compact.

9 BY adding to

10 Article – Health Occupations

11 Section 19–3A–01 to be under the new subtitle “Subtitle 3A. Interstate Social Work  
12 Licensure Compact”

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – Health Occupations**

18 **SUBTITLE 3A. INTERSTATE SOCIAL WORK LICENSURE COMPACT.**

19 **19–3A–01.**

20 **THE SOCIAL WORK LICENSURE COMPACT IS ENACTED INTO LAW AND**  
21 **ENTERED INTO WITH ALL OTHER STATES LEGALLY JOINING IN IT IN THE FORM**  
22 **SUBSTANTIALLY AS IT APPEARS IN THIS SECTION AS FOLLOWS:**

1 **SECTION 1. PURPOSE.**

2 **THE PURPOSE OF THIS COMPACT IS TO FACILITATE INTERSTATE PRACTICE**  
3 **OF REGULATED SOCIAL WORKERS BY IMPROVING PUBLIC ACCESS TO COMPETENT**  
4 **SOCIAL WORK SERVICES. THE COMPACT PRESERVES THE REGULATORY AUTHORITY**  
5 **OF STATES TO PROTECT PUBLIC HEALTH AND SAFETY THROUGH THE CURRENT**  
6 **SYSTEM OF STATE LICENSURE. THIS COMPACT IS DESIGNED TO ACHIEVE THE**  
7 **FOLLOWING OBJECTIVES:**

8 **(1) INCREASE PUBLIC ACCESS TO SOCIAL WORKERS;**

9 **(2) REDUCE OVERLY BURDENSOME AND DUPLICATIVE**  
10 **REQUIREMENTS ASSOCIATED WITH HOLDING MULTIPLE LICENSES;**

11 **(3) ENHANCE THE MEMBER STATES' ABILITY TO PROTECT THE**  
12 **PUBLIC'S HEALTH AND SAFETY;**

13 **(4) ENCOURAGE THE COOPERATION OF MEMBER STATES IN**  
14 **REGULATING MULTISTATE PRACTICE;**

15 **(5) PROMOTE MOBILITY AND ADDRESS WORKFORCE SHORTAGES BY**  
16 **ELIMINATING THE NECESSITY FOR LICENSES IN MULTIPLE STATES BY PROVIDING**  
17 **FOR THE MUTUAL RECOGNITION OF OTHER MEMBER STATE LICENSES;**

18 **(6) SUPPORT MILITARY FAMILIES;**

19 **(7) FACILITATE THE EXCHANGE OF LICENSURE AND DISCIPLINARY**  
20 **INFORMATION AMONG MEMBER STATES;**

21 **(8) AUTHORIZE ALL MEMBER STATES TO HOLD A REGULATED SOCIAL**  
22 **WORKER ACCOUNTABLE FOR ABIDING BY A MEMBER STATE'S LAWS, REGULATIONS,**  
23 **AND APPLICABLE PROFESSIONAL STANDARDS IN THE MEMBER STATE IN WHICH THE**  
24 **CLIENT IS LOCATED AT THE TIME CARE IS RENDERED; AND**

25 **(9) ALLOW THE USE OF TELEHEALTH TO FACILITATE INCREASED**  
26 **ACCESS TO REGULATED SOCIAL WORK SERVICES.**

27 **SECTION 2. DEFINITIONS.**

28 **AS USED IN THIS COMPACT, AND EXCEPT AS OTHERWISE PROVIDED, THE**  
29 **FOLLOWING DEFINITIONS SHALL APPLY:**

1           (1) “ACTIVE MILITARY MEMBER” MEANS ANY INDIVIDUAL WITH  
2 FULL-TIME DUTY STATUS IN THE ACTIVE ARMED FORCES OF THE UNITED STATES,  
3 INCLUDING MEMBERS OF THE NATIONAL GUARD AND RESERVE.

4           (2) “ADVERSE ACTION” MEANS ANY ADMINISTRATIVE, CIVIL,  
5 EQUITABLE, OR CRIMINAL ACTION PERMITTED BY A STATE’S LAWS WHICH IS  
6 IMPOSED BY A LICENSING AUTHORITY OR OTHER AUTHORITY AGAINST A  
7 REGULATED SOCIAL WORKER, INCLUDING ACTIONS AGAINST AN INDIVIDUAL’S  
8 LICENSE OR MULTISTATE AUTHORIZATION TO PRACTICE SUCH AS REVOCATION,  
9 SUSPENSION, PROBATION, MONITORING OF THE LICENSEE, LIMITATION ON THE  
10 LICENSEE’S PRACTICE, OR ANY OTHER ENCUMBRANCE ON LICENSURE AFFECTING A  
11 REGULATED SOCIAL WORKER’S AUTHORIZATION TO PRACTICE, INCLUDING  
12 ISSUANCE OF A CEASE AND DESIST ACTION.

13           (3) “ALTERNATIVE PROGRAM” MEANS A NON-DISCIPLINARY  
14 MONITORING OR PRACTICE REMEDIATION PROCESS APPROVED BY A LICENSING  
15 AUTHORITY TO ADDRESS PRACTITIONERS WITH AN IMPAIRMENT.

16           (4) “CHARTER MEMBER STATES” MEANS MEMBER STATES WHO HAVE  
17 ENACTED LEGISLATION TO ADOPT THIS COMPACT WHERE SUCH LEGISLATION  
18 PREDATES THE EFFECTIVE DATE OF THIS COMPACT AS DESCRIBED IN SECTION 14.

19           (5) “COMPACT COMMISSION” OR “COMMISSION” MEANS THE  
20 GOVERNMENT AGENCY WHOSE MEMBERSHIP CONSISTS OF ALL STATES THAT HAVE  
21 ENACTED THIS COMPACT, WHICH IS KNOWN AS THE SOCIAL WORK LICENSURE  
22 COMPACT COMMISSION, AS DESCRIBED IN SECTION 10, AND WHICH SHALL  
23 OPERATE AS AN INSTRUMENTALITY OF THE MEMBER STATES.

24           (6) “CURRENT SIGNIFICANT INVESTIGATIVE INFORMATION” MEANS:

25           (i) INVESTIGATIVE INFORMATION THAT A LICENSING  
26 AUTHORITY, AFTER A PRELIMINARY INQUIRY THAT INCLUDES NOTIFICATION AND  
27 AN OPPORTUNITY FOR THE REGULATED SOCIAL WORKER TO RESPOND HAS REASON  
28 TO BELIEVE IS NOT GROUNDLESS AND, IF PROVED TRUE, WOULD INDICATE MORE  
29 THAN A MINOR INFRACTION AS MAY BE DEFINED BY THE COMMISSION; OR

30           (ii) INVESTIGATIVE INFORMATION THAT INDICATES THAT THE  
31 REGULATED SOCIAL WORKER REPRESENTS AN IMMEDIATE THREAT TO PUBLIC  
32 HEALTH AND SAFETY, AS MAY BE DEFINED BY THE COMMISSION, REGARDLESS OF  
33 WHETHER THE REGULATED SOCIAL WORKER HAS BEEN NOTIFIED AND HAS HAD AN  
34 OPPORTUNITY TO RESPOND.

1           **(7) “DATA SYSTEM” MEANS A REPOSITORY OF INFORMATION ABOUT**  
2 **LICENSEES, INCLUDING CONTINUING EDUCATION, EXAMINATION, LICENSURE,**  
3 **CURRENT SIGNIFICANT INVESTIGATIVE INFORMATION, DISQUALIFYING EVENT,**  
4 **MULTISTATE LICENSE, AND ADVERSE ACTION INFORMATION OR OTHER**  
5 **INFORMATION AS REQUIRED BY THE COMMISSION.**

6           **(8) “DISQUALIFYING EVENT” MEANS ANY ADVERSE ACTION OR**  
7 **INCIDENT WHICH RESULTS IN AN ENCUMBRANCE THAT DISQUALIFIES OR MAKES**  
8 **THE LICENSEE INELIGIBLE TO OBTAIN, RETAIN, OR RENEW A MULTISTATE LICENSE.**

9           **(9) “DOMICILE” MEANS THE JURISDICTION IN WHICH THE LICENSEE**  
10 **RESIDES AND INTENDS TO REMAIN INDEFINITELY.**

11           **(10) “ENCUMBRANCE” MEANS A REVOCATION OR SUSPENSION OF, OR**  
12 **ANY LIMITATION ON, THE FULL AND UNRESTRICTED PRACTICE OF SOCIAL WORK**  
13 **LICENSED AND REGULATED BY A LICENSING AUTHORITY.**

14           **(11) “EXECUTIVE COMMITTEE” MEANS A GROUP OF DELEGATES**  
15 **ELECTED OR APPOINTED TO ACT ON BEHALF OF, AND WITHIN THE POWERS**  
16 **GRANTED TO THEM BY, THE COMPACT AND COMMISSION.**

17           **(12) “HOME STATE” MEANS THE MEMBER STATE THAT IS THE**  
18 **LICENSEE’S PRIMARY DOMICILE.**

19           **(13) “IMPAIRMENT” MEANS A CONDITION THAT MAY IMPAIR A**  
20 **PRACTITIONER’S ABILITY TO ENGAGE IN FULL AND UNRESTRICTED PRACTICE AS A**  
21 **REGULATED SOCIAL WORKER WITHOUT SOME TYPE OF INTERVENTION AND MAY**  
22 **INCLUDE ALCOHOL AND DRUG DEPENDENCE, MENTAL HEALTH IMPAIRMENT, AND**  
23 **NEUROLOGICAL OR PHYSICAL IMPAIRMENTS.**

24           **(14) “LICENSEE” MEANS AN INDIVIDUAL WHO CURRENTLY HOLDS A**  
25 **LICENSE FROM A STATE TO PRACTICE AS A REGULATED SOCIAL WORKER.**

26           **(15) “LICENSING AUTHORITY” MEANS THE BOARD OR AGENCY OF A**  
27 **MEMBER STATE, OR EQUIVALENT, THAT IS RESPONSIBLE FOR THE LICENSING AND**  
28 **REGULATION OF REGULATED SOCIAL WORKERS.**

29           **(16) “MEMBER STATE” MEANS A STATE, COMMONWEALTH, DISTRICT,**  
30 **OR TERRITORY OF THE UNITED STATES OF AMERICA THAT HAS ENACTED THIS**  
31 **COMPACT.**

32           **(17) “MULTISTATE AUTHORIZATION TO PRACTICE” MEANS A LEGALLY**  
33 **AUTHORIZED PRIVILEGE TO PRACTICE, WHICH IS EQUIVALENT TO A LICENSE,**

1 ASSOCIATED WITH A MULTISTATE LICENSE PERMITTING THE PRACTICE OF SOCIAL  
2 WORK IN A REMOTE STATE.

3 (18) "MULTISTATE LICENSE" MEANS A LICENSE TO PRACTICE AS A  
4 REGULATED SOCIAL WORKER ISSUED BY A HOME STATE LICENSING AUTHORITY  
5 THAT AUTHORIZES THE REGULATED SOCIAL WORKER TO PRACTICE IN ALL MEMBER  
6 STATES UNDER MULTISTATE AUTHORIZATION TO PRACTICE.

7 (19) "QUALIFYING NATIONAL EXAM" MEANS A NATIONAL LICENSING  
8 EXAMINATION APPROVED BY THE COMMISSION.

9 (20) "REGULATED SOCIAL WORKER" MEANS ANY CLINICAL, MASTER'S,  
10 OR BACHELOR'S SOCIAL WORKER LICENSED BY A MEMBER STATE REGARDLESS OF  
11 THE TITLE USED BY THAT MEMBER STATE.

12 (21) "REMOTE STATE" MEANS A MEMBER STATE OTHER THAN THE  
13 HOME STATE.

14 (22) "RULE" OR "RULE OF THE COMMISSION" MEANS A REGULATION  
15 DULY PROMULGATED BY THE COMMISSION, AS AUTHORIZED BY THIS COMPACT,  
16 THAT HAS THE FORCE OF LAW.

17 (23) "SINGLE STATE LICENSE" MEANS A SOCIAL WORK LICENSE  
18 ISSUED BY ANY STATE THAT AUTHORIZES PRACTICE ONLY WITHIN THE ISSUING  
19 STATE AND DOES NOT INCLUDE MULTISTATE AUTHORIZATION TO PRACTICE IN ANY  
20 MEMBER STATE.

21 (24) "SOCIAL WORK" OR "SOCIAL WORK SERVICES" MEANS THE  
22 APPLICATION OF SOCIAL WORK THEORY, KNOWLEDGE, METHODS, ETHICS, AND THE  
23 PROFESSIONAL USE OF SELF TO RESTORE OR ENHANCE SOCIAL, PSYCHOSOCIAL, OR  
24 BIOPSYCHOSOCIAL FUNCTIONING OF INDIVIDUALS, COUPLES, FAMILIES, GROUPS,  
25 ORGANIZATIONS, AND COMMUNITIES THROUGH THE CARE AND SERVICES PROVIDED  
26 BY A REGULATED SOCIAL WORKER AS SET FORTH IN THE MEMBER STATE'S  
27 STATUTES AND REGULATIONS IN THE STATE WHERE THE SERVICES ARE BEING  
28 PROVIDED.

29 (25) "STATE" MEANS ANY STATE, COMMONWEALTH, DISTRICT, OR  
30 TERRITORY OF THE UNITED STATES OF AMERICA THAT REGULATES THE PRACTICE  
31 OF SOCIAL WORK.

32 (26) "UNENCUMBERED LICENSE" MEANS A LICENSE THAT  
33 AUTHORIZES A REGULATED SOCIAL WORKER TO ENGAGE IN THE FULL AND  
34 UNRESTRICTED PRACTICE OF SOCIAL WORK.

1 **SECTION 3. STATE PARTICIPATION IN THE COMPACT.**

2 (A) TO BE ELIGIBLE TO PARTICIPATE IN THE COMPACT, A POTENTIAL  
3 MEMBER STATE MUST CURRENTLY MEET ALL OF THE FOLLOWING CRITERIA:

4 (1) LICENSE AND REGULATE SOCIAL WORK AT EITHER THE CLINICAL,  
5 MASTER'S OR BACHELOR'S CATEGORY;

6 (2) REQUIRE APPLICANTS FOR LICENSURE TO GRADUATE FROM A  
7 PROGRAM THAT:

8 (i) IS OPERATED BY A COLLEGE OR UNIVERSITY RECOGNIZED  
9 BY THE LICENSING AUTHORITY;

10 (ii) IS ACCREDITED, OR IN CANDIDACY BY AN INSTITUTION  
11 THAT SUBSEQUENTLY BECOMES ACCREDITED, BY AN ACCREDITING AGENCY  
12 RECOGNIZED BY EITHER:

13 1. THE COUNCIL FOR HIGHER EDUCATION  
14 ACCREDITATION OR ITS SUCCESSOR; OR

15 2. THE UNITED STATES DEPARTMENT OF EDUCATION;  
16 AND

17 (iii) CORRESPONDS TO THE LICENSURE SOUGHT AS OUTLINED  
18 IN SECTION 4;

19 (3) REQUIRE APPLICANTS FOR CLINICAL LICENSURE TO COMPLETE A  
20 PERIOD OF SUPERVISED PRACTICE; AND

21 (4) HAVE A MECHANISM IN PLACE FOR RECEIVING, INVESTIGATING,  
22 AND ADJUDICATING COMPLAINTS ABOUT LICENSEES.

23 (B) TO MAINTAIN MEMBERSHIP IN THE COMPACT A MEMBER STATE SHALL:

24 (1) REQUIRE THAT APPLICANTS FOR A MULTISTATE LICENSE PASS A  
25 QUALIFYING NATIONAL EXAM FOR THE CORRESPONDING CATEGORY OF  
26 MULTISTATE LICENSE SOUGHT AS OUTLINED IN SECTION 4;

27 (2) PARTICIPATE FULLY IN THE COMMISSION'S DATA SYSTEM,  
28 INCLUDING USING THE COMMISSION'S UNIQUE IDENTIFIER AS DEFINED IN RULES;

1           **(3) NOTIFY THE COMMISSION, IN COMPLIANCE WITH THE TERMS OF**  
2 **THE COMPACT AND RULES, OF ANY ADVERSE ACTION OR THE AVAILABILITY OF**  
3 **CURRENT SIGNIFICANT INVESTIGATIVE INFORMATION REGARDING A LICENSEE;**

4           **(4) IMPLEMENT PROCEDURES FOR CONSIDERING THE CRIMINAL**  
5 **HISTORY RECORDS OF APPLICANTS FOR A MULTISTATE LICENSE. SUCH**  
6 **PROCEDURES SHALL INCLUDE THE SUBMISSION OF FINGERPRINTS OR OTHER**  
7 **BIOMETRIC-BASED INFORMATION BY APPLICANTS FOR THE PURPOSE OF**  
8 **OBTAINING AN APPLICANT'S CRIMINAL HISTORY RECORD INFORMATION FROM THE**  
9 **FEDERAL BUREAU OF INVESTIGATION AND THE AGENCY RESPONSIBLE FOR**  
10 **RETAINING THAT STATE'S CRIMINAL RECORDS;**

11           **(5) COMPLY WITH THE RULES OF THE COMMISSION;**

12           **(6) REQUIRE AN APPLICANT TO OBTAIN OR RETAIN A LICENSE IN THE**  
13 **HOME STATE AND MEET THE HOME STATE'S QUALIFICATIONS FOR LICENSURE OR**  
14 **RENEWAL OF LICENSURE, AS WELL AS ALL OTHER APPLICABLE HOME STATE LAWS;**

15           **(7) AUTHORIZE A LICENSEE HOLDING A MULTISTATE LICENSE IN ANY**  
16 **MEMBER STATE TO PRACTICE IN ACCORDANCE WITH THE TERMS OF THE COMPACT**  
17 **AND RULES OF THE COMMISSION; AND**

18           **(8) DESIGNATE A DELEGATE TO PARTICIPATE IN THE COMMISSION**  
19 **MEETINGS.**

20           **(C) A MEMBER STATE MEETING THE REQUIREMENTS OF SECTIONS 3(A) AND**  
21 **3(B) OF THIS COMPACT SHALL DESIGNATE THE CATEGORIES OF SOCIAL WORK**  
22 **LICENSURE THAT ARE ELIGIBLE FOR ISSUANCE OF A MULTISTATE LICENSE FOR**  
23 **APPLICANTS IN SUCH MEMBER STATE. TO THE EXTENT THAT ANY MEMBER STATE**  
24 **DOES NOT MEET THE REQUIREMENTS FOR PARTICIPATION IN THE COMPACT AT ANY**  
25 **PARTICULAR CATEGORY OF SOCIAL WORK LICENSURE, SUCH MEMBER STATE MAY**  
26 **CHOOSE, BUT IS NOT OBLIGATED TO, ISSUE A MULTISTATE LICENSE TO APPLICANTS**  
27 **THAT OTHERWISE MEET THE REQUIREMENTS OF SECTION 4 FOR ISSUANCE OF A**  
28 **MULTISTATE LICENSE IN SUCH CATEGORY OR CATEGORIES OF LICENSURE.**

29           **(D) THE HOME STATES MAY CHARGE A FEE FOR GRANTING THE**  
30 **MULTISTATE LICENSE.**

31 **SECTION 4. REGULATED SOCIAL WORKER PARTICIPATION IN THE**  
32 **COMPACT.**

33           **(A) TO BE ELIGIBLE FOR A MULTISTATE LICENSE UNDER THE TERMS AND**  
34 **PROVISIONS OF THE COMPACT, AN APPLICANT, REGARDLESS OF CATEGORY MUST:**

1           **(1) HOLD OR BE ELIGIBLE FOR AN ACTIVE, UNENCUMBERED LICENSE**  
2 **IN THE HOME STATE;**

3           **(2) PAY ANY APPLICABLE FEES, INCLUDING ANY STATE FEE, FOR THE**  
4 **MULTISTATE LICENSE;**

5           **(3) SUBMIT, IN CONNECTION WITH AN APPLICATION FOR A**  
6 **MULTISTATE LICENSE, FINGERPRINTS OR OTHER BIOMETRIC DATA FOR THE**  
7 **PURPOSE OF OBTAINING CRIMINAL HISTORY RECORD INFORMATION FROM THE**  
8 **FEDERAL BUREAU OF INVESTIGATION AND THE AGENCY RESPONSIBLE FOR**  
9 **RETAINING THAT STATE'S CRIMINAL RECORDS;**

10           **(4) NOTIFY THE HOME STATE OF ANY ADVERSE ACTION,**  
11 **ENCUMBRANCE, OR RESTRICTION ON ANY PROFESSIONAL LICENSE TAKEN BY ANY**  
12 **MEMBER STATE OR NON-MEMBER STATE WITHIN 30 DAYS FROM THE DATE THE**  
13 **ACTION IS TAKEN;**

14           **(5) MEET ANY CONTINUING COMPETENCE REQUIREMENTS**  
15 **ESTABLISHED BY THE HOME STATE; AND**

16           **(6) ABIDE BY THE LAWS, REGULATIONS, AND APPLICABLE**  
17 **STANDARDS IN THE MEMBER STATE WHERE THE CLIENT IS LOCATED AT THE TIME**  
18 **CARE IS RENDERED.**

19           **(B) AN APPLICANT FOR A CLINICAL-CATEGORY MULTISTATE LICENSE MUST**  
20 **MEET ALL OF THE FOLLOWING REQUIREMENTS:**

21           **(1) FULFILL A COMPETENCY REQUIREMENT, WHICH SHALL BE**  
22 **SATISFIED BY EITHER:**

23                   **(I) PASSAGE OF A CLINICAL-CATEGORY QUALIFYING**  
24 **NATIONAL EXAM;**

25                   **(II) LICENSURE OF THE APPLICANT IN THEIR HOME STATE AT**  
26 **THE CLINICAL CATEGORY, BEGINNING PRIOR TO SUCH TIME AS A QUALIFYING**  
27 **NATIONAL EXAM WAS REQUIRED BY THE HOME STATE AND ACCOMPANIED BY A**  
28 **PERIOD OF CONTINUOUS SOCIAL WORK LICENSURE THEREAFTER, ALL OF WHICH**  
29 **MAY BE FURTHER GOVERNED BY THE RULE OF THE COMMISSION; OR**

30                   **(III) THE SUBSTANTIAL EQUIVALENCY OF THE FOREGOING**  
31 **COMPETENCY REQUIREMENTS WHICH THE COMMISSION MAY DETERMINE BY RULE.**



1           **(2) ATTAIN AT LEAST A MASTER’S DEGREE IN SOCIAL WORK FROM A**  
2 **PROGRAM THAT IS:**

3                   **(I) OPERATED BY A COLLEGE OR UNIVERSITY RECOGNIZED BY**  
4 **THE LICENSING AUTHORITY; AND**

5                   **(II) ACCREDITED, OR IN CANDIDACY THAT SUBSEQUENTLY**  
6 **BECOMES ACCREDITED, BY AN ACCREDITING AGENCY RECOGNIZED BY EITHER:**

7                           **1. THE COUNCIL FOR HIGHER EDUCATION**  
8 **ACCREDITATION OR ITS SUCCESSOR; OR**

9                           **2. THE UNITED STATES DEPARTMENT OF EDUCATION;**

10           **(3) FULFILL A PRACTICE REQUIREMENT, WHICH SHALL BE SATISFIED**  
11 **BY DEMONSTRATING COMPLETION OF EITHER:**

12                   **(I) A PERIOD OF POSTGRADUATE SUPERVISED CLINICAL**  
13 **PRACTICE EQUAL TO A MINIMUM OF THREE THOUSAND HOURS;**

14                   **(II) A MINIMUM OF TWO YEARS OF FULL-TIME POSTGRADUATE**  
15 **SUPERVISED CLINICAL PRACTICE; OR**

22                           **(I) PASSAGE OF A MASTER’S-CATEGORY QUALIFYING**  
23 **NATIONAL EXAM;**

24                           **(II) LICENSURE OF THE APPLICANT IN THEIR HOME STATE AT**  
25 **THE MASTER’S CATEGORY, BEGINNING PRIOR TO SUCH TIME AS A QUALIFYING**  
26 **NATIONAL EXAM WAS REQUIRED BY THE HOME STATE AT THE MASTER’S CATEGORY**  
27 **AND ACCOMPANIED BY A CONTINUOUS PERIOD OF SOCIAL WORK LICENSURE**  
28 **THEREAFTER, ALL OF WHICH MAY BE FURTHER GOVERNED BY THE RULE OF THE**  
29 **COMMISSION; OR**

1                   **(III) THE SUBSTANTIAL EQUIVALENCY OF THE FOREGOING**  
2 **COMPETENCY REQUIREMENTS WHICH THE COMMISSION MAY DETERMINE BY RULE.**

3                   **(2) ATTAIN AT LEAST A MASTER'S DEGREE IN SOCIAL WORK, FROM A**  
4 **PROGRAM THAT IS:**

5                   **(I) OPERATED BY A COLLEGE OR UNIVERSITY RECOGNIZED BY**  
6 **THE LICENSING AUTHORITY; AND**

7                   **(II) ACCREDITED, OR IN CANDIDACY THAT SUBSEQUENTLY**  
8 **BECOMES ACCREDITED, BY AN ACCREDITING AGENCY RECOGNIZED BY EITHER:**

9                   **1. THE COUNCIL FOR HIGHER EDUCATION**  
10 **ACCREDITATION, OR ITS SUCCESSOR; OR**

11                   **2. THE UNITED STATES DEPARTMENT OF EDUCATION.**

12                   **(D) AN APPLICANT FOR A BACHELOR'S-CATEGORY MULTISTATE LICENSE**  
13 **MUST MEET ALL OF THE FOLLOWING REQUIREMENTS:**

14                   **(1) FULFILL A COMPETENCY REQUIREMENT, WHICH SHALL BE**  
15 **SATISFIED BY EITHER:**

16                   **(I) PASSAGE OF A BACHELOR'S-CATEGORY QUALIFYING**  
17 **NATIONAL EXAM;**

18                   **(II) LICENSURE OF THE APPLICANT IN THEIR HOME STATE AT**  
19 **THE BACHELOR'S CATEGORY, BEGINNING PRIOR TO SUCH TIME AS A QUALIFYING**  
20 **NATIONAL EXAM WAS REQUIRED BY THE HOME STATE AND ACCOMPANIED BY A**  
21 **CONTINUOUS PERIOD OF SOCIAL WORK LICENSURE THEREAFTER, ALL OF WHICH**  
22 **MAY BE FURTHER GOVERNED BY THE RULE OF THE COMMISSION; OR**

23                   **(III) THE SUBSTANTIAL EQUIVALENCY OF THE FOREGOING**  
24 **COMPETENCY REQUIREMENTS WHICH THE COMMISSION MAY DETERMINE BY RULE;**  
25 **AND**

26                   **(2) ATTAIN AT LEAST A BACHELOR'S DEGREE IN SOCIAL WORK FROM**  
27 **A PROGRAM THAT IS:**

28                   **(I) OPERATED BY A COLLEGE OR UNIVERSITY RECOGNIZED BY**  
29 **THE LICENSING AUTHORITY; AND**

1 (II) ACCREDITED, OR IN CANDIDACY THAT SUBSEQUENTLY  
2 BECOMES ACCREDITED, BY AN ACCREDITING AGENCY RECOGNIZED BY EITHER:

3 1. THE COUNCIL FOR HIGHER EDUCATION  
4 ACCREDITATION, OR ITS SUCCESSOR; OR

5 2. THE UNITED STATES DEPARTMENT OF EDUCATION.

6 (E) THE MULTISTATE LICENSE FOR A REGULATED SOCIAL WORKER IS  
7 SUBJECT TO THE RENEWAL REQUIREMENTS OF THE HOME STATE. THE REGULATED  
8 SOCIAL WORKER MUST MAINTAIN COMPLIANCE WITH THE REQUIREMENTS OF  
9 SECTION 4(A) TO BE ELIGIBLE TO RENEW A MULTISTATE LICENSE.

10 (F) THE REGULATED SOCIAL WORKER'S SERVICES IN A REMOTE STATE ARE  
11 SUBJECT TO THAT MEMBER STATE'S REGULATORY AUTHORITY. A REMOTE STATE  
12 MAY, IN ACCORDANCE WITH DUE PROCESS AND THAT MEMBER STATE'S LAWS,  
13 REMOVE A REGULATED SOCIAL WORKER'S MULTISTATE AUTHORIZATION TO  
14 PRACTICE IN THE REMOTE STATE FOR A SPECIFIC PERIOD OF TIME, IMPOSE FINES,  
15 AND TAKE ANY OTHER NECESSARY ACTIONS TO PROTECT THE HEALTH AND SAFETY  
16 OF ITS CITIZENS.

17 (G) IF A MULTISTATE LICENSE IS ENCUMBERED, THE REGULATED SOCIAL  
18 WORKER'S MULTISTATE AUTHORIZATION TO PRACTICE SHALL BE DEACTIVATED IN  
19 ALL REMOTE STATES UNTIL THE MULTISTATE LICENSE IS NO LONGER  
20 ENCUMBERED.

21 (H) IF A MULTISTATE AUTHORIZATION TO PRACTICE IS ENCUMBERED IN A  
22 REMOTE STATE, THE REGULATED SOCIAL WORKER'S MULTISTATE AUTHORIZATION  
23 TO PRACTICE MAY BE DEACTIVATED IN THAT STATE UNTIL THE MULTISTATE  
24 AUTHORIZATION TO PRACTICE IS NO LONGER ENCUMBERED.

## 25 SECTION 5. ISSUANCE OF A MULTISTATE LICENSE.

26 (A) UPON RECEIPT OF AN APPLICATION FOR A MULTISTATE LICENSE, THE  
27 HOME STATE LICENSING AUTHORITY SHALL DETERMINE THE APPLICANT'S  
28 ELIGIBILITY FOR A MULTISTATE LICENSE IN ACCORDANCE WITH SECTION 4 OF THIS  
29 COMPACT.

30 (B) IF SUCH APPLICANT IS ELIGIBLE PURSUANT TO SECTION 4 OF THIS  
31 COMPACT, THE HOME STATE LICENSING AUTHORITY SHALL ISSUE A MULTISTATE  
32 LICENSE THAT AUTHORIZES THE APPLICANT OR REGULATED SOCIAL WORKER TO  
33 PRACTICE IN ALL MEMBER STATES UNDER A MULTISTATE AUTHORIZATION TO  
34 PRACTICE.

1 (C) UPON ISSUANCE OF A MULTISTATE LICENSE, THE HOME STATE  
2 LICENSING AUTHORITY SHALL DESIGNATE WHETHER THE REGULATED SOCIAL  
3 WORKER HOLDS A MULTISTATE LICENSE IN THE BACHELOR'S, MASTER'S, OR  
4 CLINICAL CATEGORY OF SOCIAL WORK.

5 (D) A MULTISTATE LICENSE ISSUED BY A HOME STATE TO A RESIDENT IN  
6 THAT STATE SHALL BE RECOGNIZED BY ALL COMPACT MEMBER STATES AS  
7 AUTHORIZING SOCIAL WORK PRACTICE UNDER A MULTISTATE AUTHORIZATION TO  
8 PRACTICE CORRESPONDING TO EACH CATEGORY OF LICENSURE REGULATED IN  
9 EACH MEMBER STATE.

10 **SECTION 6. AUTHORITY OF INTERSTATE COMPACT COMMISSION AND**  
11 **MEMBER STATE LICENSING AUTHORITIES.**

12 (A) NOTHING IN THIS COMPACT, NOR ANY RULE OF THE COMMISSION,  
13 SHALL BE CONSTRUED TO LIMIT, RESTRICT, OR IN ANY WAY REDUCE THE ABILITY  
14 OF A MEMBER STATE TO ENACT AND ENFORCE LAWS, REGULATIONS, OR OTHER  
15 RULES RELATED TO THE PRACTICE OF SOCIAL WORK IN THAT STATE, WHERE THOSE  
16 LAWS, REGULATIONS, OR OTHER RULES ARE NOT INCONSISTENT WITH THE  
17 PROVISIONS OF THIS COMPACT.

18 (B) NOTHING IN THIS COMPACT SHALL AFFECT THE REQUIREMENTS  
19 ESTABLISHED BY A MEMBER STATE FOR THE ISSUANCE OF A SINGLE STATE LICENSE.

20 (C) NOTHING IN THIS COMPACT, NOR ANY RULE OF THE COMMISSION,  
21 SHALL BE CONSTRUED TO LIMIT, RESTRICT, OR IN ANY WAY REDUCE THE ABILITY  
22 OF A REMOTE STATE TO TAKE ADVERSE ACTION AGAINST A LICENSEE'S SINGLE  
23 STATE AUTHORIZATION TO PRACTICE IN THAT STATE.

24 (D) NOTHING IN THIS COMPACT, NOR ANY RULE OF THE COMMISSION,  
25 SHALL BE CONSTRUED TO LIMIT, RESTRICT, OR IN ANY WAY REDUCE THE ABILITY  
26 OF A REMOTE STATE TO TAKE ADVERSE ACTION AGAINST A LICENSEE'S MULTISTATE  
27 AUTHORIZATION TO PRACTICE IN THAT STATE.

28 (E) NOTHING IN THIS COMPACT, NOR ANY RULE OF THE COMMISSION,  
29 SHALL BE CONSTRUED TO LIMIT, RESTRICT, OR IN ANY WAY REDUCE THE ABILITY  
30 OF A LICENSEE'S HOME STATE TO TAKE ADVERSE ACTION AGAINST A LICENSEE'S  
31 MULTISTATE LICENSE BASED UPON INFORMATION PROVIDED BY A REMOTE STATE.

32 **SECTION 7. REISSUANCE OF A MULTISTATE LICENSE BY A NEW HOME**  
33 **STATE.**

1           **(A) A LICENSEE CAN HOLD A MULTISTATE LICENSE, ISSUED BY THEIR HOME**  
2 **STATE, IN ONLY ONE MEMBER STATE AT ANY GIVEN TIME.**

3           **(B) IF A LICENSEE CHANGES THEIR HOME STATE BY MOVING BETWEEN TWO**  
4 **MEMBER STATES:**

5                 **(1) THE LICENSEE SHALL IMMEDIATELY APPLY FOR THE REISSUANCE**  
6 **OF THEIR MULTISTATE LICENSE IN THEIR NEW HOME STATE. THE LICENSEE SHALL**  
7 **PAY ALL APPLICABLE FEES AND NOTIFY THE PRIOR HOME STATE IN ACCORDANCE**  
8 **WITH THE RULES OF THE COMMISSION.**

9                 **(2) UPON RECEIPT OF AN APPLICATION TO REISSUE A MULTISTATE**  
10 **LICENSE, THE NEW HOME STATE SHALL VERIFY THAT THE MULTISTATE LICENSE IS**  
11 **ACTIVE, UNENCUMBERED AND ELIGIBLE FOR REISSUANCE UNDER THE TERMS OF**  
12 **THE COMPACT AND THE RULES OF THE COMMISSION. THE MULTISTATE LICENSE**  
13 **ISSUED BY THE PRIOR HOME STATE WILL BE DEACTIVATED AND ALL MEMBER**  
14 **STATES NOTIFIED IN ACCORDANCE WITH THE APPLICABLE RULES ADOPTED BY THE**  
15 **COMMISSION.**

16                 **(3) PRIOR TO THE REISSUANCE OF THE MULTISTATE LICENSE, THE**  
17 **NEW HOME STATE SHALL CONDUCT PROCEDURES FOR CONSIDERING THE CRIMINAL**  
18 **HISTORY RECORDS OF THE LICENSEE. SUCH PROCEDURES SHALL INCLUDE THE**  
19 **SUBMISSION OF FINGERPRINTS OR OTHER BIOMETRIC-BASED INFORMATION**  
20 **APPLICABLE FOR THE PURPOSE OF OBTAINING AN APPLICANT'S CRIMINAL HISTORY**  
21 **RECORD INFORMATION FROM THE FEDERAL BUREAU OF INVESTIGATION AND THE**  
22 **AGENCY RESPONSIBLE FOR RETAINING THAT STATE'S CRIMINAL RECORDS.**

23                 **(4) IF REQUIRED FOR INITIAL LICENSURE, THE NEW HOME STATE**  
24 **MAY REQUIRE COMPLETION OF JURISPRUDENCE REQUIREMENTS IN THE NEW HOME**  
25 **STATE.**

26                 **(5) NOTWITHSTANDING ANY OTHER PROVISION OF THIS COMPACT, IF**  
27 **A LICENSEE DOES NOT MEET THE REQUIREMENTS SET FORTH IN THIS COMPACT FOR**  
28 **THE REISSUANCE OF A MULTISTATE LICENSE BY THE NEW HOME STATE, THEN THE**  
29 **LICENSEE SHALL BE SUBJECT TO THE NEW HOME STATE REQUIREMENTS FOR THE**  
30 **ISSUANCE OF A SINGLE STATE LICENSE IN THAT STATE.**

31           **(C) IF A LICENSEE CHANGES THEIR PRIMARY STATE OF RESIDENCE BY**  
32 **MOVING FROM A MEMBER STATE TO A NON-MEMBER STATE, OR FROM A**  
33 **NON-MEMBER STATE TO A MEMBER STATE, THEN THE LICENSEE SHALL BE SUBJECT**  
34 **TO THE STATE REQUIREMENTS FOR THE ISSUANCE OF A SINGLE STATE LICENSE IN**  
35 **THE NEW HOME STATE.**

1 (D) NOTHING IN THIS COMPACT SHALL INTERFERE WITH A LICENSEE'S  
2 ABILITY TO HOLD A SINGLE STATE LICENSE IN MULTIPLE STATES; HOWEVER, FOR  
3 THE PURPOSES OF THIS COMPACT, A LICENSEE SHALL HAVE ONLY ONE HOME  
4 STATE, AND ONLY ONE MULTISTATE LICENSE.

5 (E) NOTHING IN THIS COMPACT SHALL INTERFERE WITH THE  
6 REQUIREMENTS ESTABLISHED BY A MEMBER STATE FOR THE ISSUANCE OF A SINGLE  
7 STATE LICENSE.

## 8 SECTION 8. MILITARY FAMILIES.

9 AN ACTIVE MILITARY MEMBER OR THEIR SPOUSE SHALL DESIGNATE A HOME  
10 STATE WHERE THE INDIVIDUAL HAS A MULTISTATE LICENSE. THE INDIVIDUAL MAY  
11 RETAIN THEIR HOME STATE DESIGNATION DURING THE PERIOD THE SERVICE  
12 MEMBER IS ON ACTIVE DUTY.

## 13 SECTION 9. ADVERSE ACTIONS.

14 (A) IN ADDITION TO THE OTHER POWERS CONFERRED BY STATE LAW, A  
15 REMOTE STATE SHALL HAVE THE AUTHORITY, IN ACCORDANCE WITH EXISTING  
16 STATE DUE PROCESS LAW, TO:

17 (1) TAKE ADVERSE ACTION AGAINST A REGULATED SOCIAL  
18 WORKER'S MULTISTATE AUTHORIZATION TO PRACTICE ONLY WITHIN THAT MEMBER  
19 STATE, AND ISSUE SUBPOENAS FOR BOTH HEARINGS AND INVESTIGATIONS THAT  
20 REQUIRE THE ATTENDANCE AND TESTIMONY OF WITNESSES AS WELL AS THE  
21 PRODUCTION OF EVIDENCE. SUBPOENAS ISSUED BY A LICENSING AUTHORITY IN A  
22 MEMBER STATE FOR THE ATTENDANCE AND TESTIMONY OF WITNESSES OR THE  
23 PRODUCTION OF EVIDENCE FROM ANOTHER MEMBER STATE SHALL BE ENFORCED  
24 IN THE LATTER STATE BY ANY COURT OF COMPETENT JURISDICTION, ACCORDING  
25 TO THE PRACTICE AND PROCEDURE OF THAT COURT APPLICABLE TO SUBPOENAS  
26 ISSUED IN PROCEEDINGS PENDING BEFORE IT. THE ISSUING AUTHORITY SHALL PAY  
27 ANY WITNESS FEES, TRAVEL EXPENSES, MILEAGE AND OTHER FEES REQUIRED BY  
28 THE SERVICE STATUTES OF THE STATE IN WHICH THE WITNESSES OR EVIDENCE ARE  
29 LOCATED.

30 (2) ONLY THE HOME STATE SHALL HAVE THE POWER TO TAKE  
31 ADVERSE ACTION AGAINST A REGULATED SOCIAL WORKER'S MULTISTATE LICENSE.

32 (B) FOR PURPOSES OF TAKING ADVERSE ACTION, THE HOME STATE SHALL  
33 GIVE THE SAME PRIORITY AND EFFECT TO REPORTED CONDUCT RECEIVED FROM A  
34 MEMBER STATE AS IT WOULD IF THE CONDUCT HAD OCCURRED WITHIN THE HOME

1 STATE. IN SO DOING, THE HOME STATE SHALL APPLY ITS OWN STATE LAWS TO  
2 DETERMINE APPROPRIATE ACTION.

3 (C) THE HOME STATE SHALL COMPLETE ANY PENDING INVESTIGATIONS OF  
4 A REGULATED SOCIAL WORKER WHO CHANGES THEIR HOME STATE DURING THE  
5 COURSE OF THE INVESTIGATIONS. THE HOME STATE SHALL ALSO HAVE THE  
6 AUTHORITY TO TAKE APPROPRIATE ACTION(S) AND SHALL PROMPTLY REPORT THE  
7 CONCLUSIONS OF THE INVESTIGATIONS TO THE ADMINISTRATOR OF THE DATA  
8 SYSTEM. THE ADMINISTRATOR OF THE DATA SYSTEM SHALL PROMPTLY NOTIFY THE  
9 NEW HOME STATE OF ANY ADVERSE ACTIONS.

10 (D) A MEMBER STATE, IF OTHERWISE PERMITTED BY STATE LAW, MAY  
11 RECOVER FROM THE AFFECTED REGULATED SOCIAL WORKER THE COSTS OF  
12 INVESTIGATIONS AND DISPOSITIONS OF CASES RESULTING FROM ANY ADVERSE  
13 ACTION TAKEN AGAINST THAT REGULATED SOCIAL WORKER.

14 (E) A MEMBER STATE MAY TAKE ADVERSE ACTION BASED ON THE FACTUAL  
15 FINDINGS OF ANOTHER MEMBER STATE, PROVIDED THAT THE MEMBER STATE  
16 FOLLOWS ITS OWN PROCEDURES FOR TAKING ADVERSE ACTION.

17 (F) (1) IN ADDITION TO THE AUTHORITY GRANTED TO A MEMBER STATE  
18 BY ITS RESPECTIVE REGULATED SOCIAL WORK PRACTICE ACT OR OTHER  
19 APPLICABLE STATE LAW, ANY MEMBER STATE MAY PARTICIPATE WITH OTHER  
20 MEMBER STATES IN JOINT INVESTIGATIONS OF LICENSEES.

21 (2) MEMBER STATES SHALL SHARE ANY INVESTIGATIVE, LITIGATION,  
22 OR COMPLIANCE MATERIALS IN FURTHERANCE OF ANY JOINT OR INDIVIDUAL  
23 INVESTIGATION INITIATED UNDER THE COMPACT.

24 (G) IF AN ADVERSE ACTION IS TAKEN BY THE HOME STATE AGAINST THE  
25 MULTISTATE LICENSE OF A REGULATED SOCIAL WORKER, THE REGULATED SOCIAL  
26 WORKER'S MULTISTATE AUTHORIZATION TO PRACTICE IN ALL OTHER MEMBER  
27 STATES SHALL BE DEACTIVATED UNTIL ALL ENCUMBRANCES HAVE BEEN REMOVED  
28 FROM THE MULTISTATE LICENSE. ALL HOME STATE DISCIPLINARY ORDERS THAT  
29 IMPOSE ADVERSE ACTION AGAINST THE LICENSE OF A REGULATED SOCIAL WORKER  
30 SHALL INCLUDE A STATEMENT THAT THE REGULATED SOCIAL WORKER'S  
31 MULTISTATE AUTHORIZATION TO PRACTICE IS DEACTIVATED IN ALL MEMBER  
32 STATES UNTIL ALL CONDITIONS OF THE DECISION, ORDER, OR AGREEMENT ARE  
33 SATISFIED.

34 (H) IF A MEMBER STATE TAKES ADVERSE ACTION, IT SHALL PROMPTLY  
35 NOTIFY THE ADMINISTRATOR OF THE DATA SYSTEM. THE ADMINISTRATOR OF THE

1 DATA SYSTEM SHALL PROMPTLY NOTIFY THE HOME STATE AND ALL OTHER MEMBER  
2 STATES OF ANY ADVERSE ACTIONS BY REMOTE STATES.

3 (I) NOTHING IN THIS COMPACT SHALL OVERRIDE A MEMBER STATE'S  
4 DECISION THAT PARTICIPATION IN AN ALTERNATIVE PROGRAM MAY BE USED IN  
5 LIEU OF ADVERSE ACTION.

6 (J) NOTHING IN THIS COMPACT SHALL AUTHORIZE A MEMBER STATE TO  
7 DEMAND THE ISSUANCE OF SUBPOENAS FOR ATTENDANCE AND TESTIMONY OF  
8 WITNESSES OR THE PRODUCTION OF EVIDENCE FROM ANOTHER MEMBER STATE  
9 FOR LAWFUL ACTIONS WITHIN THAT MEMBER STATE.

10 (K) NOTHING IN THIS COMPACT SHALL AUTHORIZE A MEMBER STATE TO  
11 IMPOSE DISCIPLINE AGAINST A REGULATED SOCIAL WORKER WHO HOLDS A  
12 MULTISTATE AUTHORIZATION TO PRACTICE FOR LAWFUL ACTIONS WITHIN  
13 ANOTHER MEMBER STATE.

14 SECTION 10. ESTABLISHMENT OF THE SOCIAL WORK LICENSURE  
15 COMPACT COMMISSION.

16 (A) THE COMPACT MEMBER STATES HEREBY CREATE AND ESTABLISH A  
17 JOINT GOVERNMENT AGENCY WHOSE MEMBERSHIP CONSISTS OF ALL MEMBER  
18 STATES THAT HAVE ENACTED THE COMPACT KNOWN AS THE SOCIAL WORK  
19 LICENSURE COMPACT COMMISSION. THE COMMISSION IS AN INSTRUMENTALITY  
20 OF THE COMPACT STATES ACTING JOINTLY AND NOT AN INSTRUMENTALITY OF ANY  
21 ONE STATE. THE COMMISSION SHALL COME INTO EXISTENCE ON OR AFTER THE  
22 EFFECTIVE DATE OF THE COMPACT AS SET FORTH IN SECTION 14.

23 (B) (1) EACH MEMBER STATE SHALL HAVE AND BE LIMITED TO ONE  
24 DELEGATE SELECTED BY THAT MEMBER STATE'S LICENSING AUTHORITY.

25 (2) THE DELEGATE SHALL BE EITHER:

26 (I) A CURRENT MEMBER OF THE LICENSING AUTHORITY AT  
27 THE TIME OF APPOINTMENT, WHO IS A REGULATED SOCIAL WORKER, OR PUBLIC  
28 MEMBER OF THE LICENSING AUTHORITY; OR

29 (II) AN ADMINISTRATOR OF THE LICENSING AUTHORITY OR  
30 THEIR DESIGNEE.

31 (3) THE COMMISSION SHALL BY RULE OR BYLAW ESTABLISH A TERM  
32 OF OFFICE FOR DELEGATES AND MAY BY RULE OR BYLAW ESTABLISH TERM LIMITS.



1           **(4) THE COMMISSION MAY RECOMMEND REMOVAL OR SUSPENSION**  
2 **OF ANY DELEGATE FROM OFFICE.**

3           **(5) A MEMBER STATE'S LICENSING AUTHORITY SHALL FILL ANY**

2 APPROVED EACH YEAR FOR WHICH REVENUE IS NOT PROVIDED BY OTHER SOURCES.  
3 THE AGGREGATE ANNUAL ASSESSMENT AMOUNT FOR MEMBER STATES SHALL BE  
4 ALLOCATED BASED UPON A FORMULA THAT THE COMMISSION SHALL PROMULGATE

6 (4) THE COMMISSION SHALL NOT INCUR OBLIGATIONS OF ANY KIND  
7 PRIOR TO SECURING THE FUNDS ADEQUATE TO MEET THE SAME; NOR SHALL THE  
8 COMMISSION PLEDGE THE CREDIT OF ANY OF THE MEMBER STATES, EXCEPT BY AND  
9 WITH THE AUTHORITY OF THE MEMBER STATE.

10 (5) THE COMMISSION SHALL KEEP ACCURATE ACCOUNTS OF ALL  
11 RECEIPTS AND DISBURSEMENTS. THE RECEIPTS AND DISBURSEMENTS OF THE  
12 COMMISSION SHALL BE SUBJECT TO THE FINANCIAL REVIEW AND ACCOUNTING  
13 PROCEDURES ESTABLISHED UNDER ITS BYLAWS. HOWEVER, ALL RECEIPTS AND  
14 DISBURSEMENTS OF FUNDS HANDLED BY THE COMMISSION SHALL BE SUBJECT TO  
15 AN ANNUAL FINANCIAL REVIEW BY A CERTIFIED OR LICENSED PUBLIC  
16 ACCOUNTANT, AND THE REPORT OF THE FINANCIAL REVIEW SHALL BE INCLUDED IN  
17 AND BECOME PART OF THE ANNUAL REPORT OF THE COMMISSION.

18 (H) (1) THE MEMBERS, OFFICERS, EXECUTIVE DIRECTOR, EMPLOYEES  
19 AND REPRESENTATIVES OF THE COMMISSION SHALL BE IMMUNE FROM SUIT AND  
20 LIABILITY, BOTH PERSONALLY AND IN THEIR OFFICIAL CAPACITY, FOR ANY CLAIM  
21 FOR DAMAGE TO OR LOSS OF PROPERTY OR PERSONAL INJURY OR OTHER CIVIL  
22 LIABILITY CAUSED BY OR ARISING OUT OF ANY ACTUAL OR ALLEGED ACT, ERROR OR  
23 OMISSION THAT OCCURRED, OR THAT THE PERSON AGAINST WHOM THE CLAIM IS  
24 MADE HAD A REASONABLE BASIS FOR BELIEVING OCCURRED WITHIN THE SCOPE OF  
25 COMMISSION EMPLOYMENT, DUTIES OR RESPONSIBILITIES; PROVIDED THAT  
26 NOTHING IN THIS PARAGRAPH SHALL BE CONSTRUED TO PROTECT ANY SUCH  
27 PERSON FROM SUIT OR LIABILITY FOR ANY DAMAGE, LOSS, INJURY, OR LIABILITY  
28 CAUSED BY THE INTENTIONAL OR WILLFUL OR WANTON MISCONDUCT OF THAT  
29 PERSON. THE PROCUREMENT OF INSURANCE OF ANY TYPE BY THE COMMISSION  
30 SHALL NOT IN ANY WAY COMPROMISE OR LIMIT THE IMMUNITY GRANTED  
31 HEREUNDER.

32 (2) THE COMMISSION SHALL DEFEND ANY MEMBER, OFFICER,  
33 EXECUTIVE DIRECTOR, EMPLOYEE, AND REPRESENTATIVE OF THE COMMISSION IN  
34 ANY CIVIL ACTION SEEKING TO IMPOSE LIABILITY ARISING OUT OF ANY ACTUAL OR  
35 ALLEGED ACT, ERROR, OR OMISSION THAT OCCURRED WITHIN THE SCOPE OF  
36 COMMISSION EMPLOYMENT, DUTIES, OR RESPONSIBILITIES, OR AS DETERMINED BY  
37 THE COMMISSION THAT THE PERSON AGAINST WHOM THE CLAIM IS MADE HAD A  
38 REASONABLE BASIS FOR BELIEVING OCCURRED WITHIN THE SCOPE OF  
39 COMMISSION EMPLOYMENT, DUTIES, OR RESPONSIBILITIES; PROVIDED THAT

1 NOTHING HEREIN SHALL BE CONSTRUED TO PROHIBIT THAT PERSON FROM  
2 RETAINING THEIR OWN COUNSEL AT THEIR EXPENSE; AND PROVIDED FURTHER,  
3 THAT THE ACTUAL OR ALLEGED ACT, ERROR, OR OMISSION DID NOT RESULT FROM  
4 THAT PERSON'S INTENTIONAL OR WILLFUL OR WANTON MISCONDUCT.

5 (3) THE COMMISSION SHALL INDEMNIFY AND HOLD HARMLESS ANY  
6 MEMBER, OFFICER, EXECUTIVE DIRECTOR, EMPLOYEE, AND REPRESENTATIVE OF  
7 THE COMMISSION FOR THE AMOUNT OF ANY SETTLEMENT OR JUDGMENT OBTAINED  
8 AGAINST THAT PERSON ARISING OUT OF ANY ACTUAL OR ALLEGED ACT, ERROR OR  
9 OMISSION THAT OCCURRED WITHIN THE SCOPE OF COMMISSION EMPLOYMENT,  
10 DUTIES, OR RESPONSIBILITIES, OR THAT SUCH PERSON HAD A REASONABLE BASIS  
11 FOR BELIEVING OCCURRED WITHIN THE SCOPE OF COMMISSION EMPLOYMENT,  
12 DUTIES, OR RESPONSIBILITIES, PROVIDED THAT THE ACTUAL OR ALLEGED ACT,  
13 ERROR, OR OMISSION DID NOT RESULT FROM THE INTENTIONAL OR WILLFUL OR  
14 WANTON MISCONDUCT OF THAT PERSON.

15 (4) NOTHING HEREIN SHALL BE CONSTRUED AS A LIMITATION ON  
16 THE LIABILITY OF ANY LICENSEE FOR PROFESSIONAL MALPRACTICE OR  
17 MISCONDUCT, WHICH SHALL BE GOVERNED SOLELY BY ANY OTHER APPLICABLE  
18 STATE LAWS.

19 (5) NOTHING IN THIS COMPACT SHALL BE INTERPRETED TO WAIVE  
20 OR OTHERWISE ABROGATE A MEMBER STATE'S ACTION IMMUNITY OR STATE ACTION  
21 AFFIRMATIVE DEFENSE WITH RESPECT TO ANTITRUST CLAIMS UNDER THE  
22 SHERMAN ACT, CLAYTON ACT, OR ANY OTHER STATE OR FEDERAL ANTITRUST OR  
23 ANTICOMPETITIVE LAW OR REGULATION.

24 (6) NOTHING IN THIS COMPACT SHALL BE CONSTRUED TO BE A  
25 WAIVER OF SOVEREIGN IMMUNITY BY THE MEMBER STATES OR BY THE  
26 COMMISSION.

## 27 SECTION 11. DATA SYSTEM.

28 (A) THE COMMISSION SHALL PROVIDE FOR THE DEVELOPMENT,  
29 MAINTENANCE, OPERATION, AND UTILIZATION OF A COORDINATED DATA SYSTEM.

30 (B) THE COMMISSION SHALL ASSIGN EACH APPLICANT FOR A MULTISTATE  
31 LICENSE A UNIQUE IDENTIFIER, AS DETERMINED BY THE RULES OF THE  
32 COMMISSION.

34 CONTRARY, A MEMBER STATE SHALL SUBMIT A UNIFORM DATA SET TO THE DATA



1 SYSTEM ON ALL INDIVIDUALS TO WHOM THIS COMPACT IS APPLICABLE AS  
2 REQUIRED BY THE RULES OF THE COMMISSION, INCLUDING:

3 (1) IDENTIFYING INFORMATION;

4 (2) LICENSURE DATA;

5 (3) ADVERSE ACTIONS AGAINST A LICENSE AND INFORMATION  
6 RELATED THERETO;

7 (4) NON-CONFIDENTIAL INFORMATION RELATED TO ALTERNATIVE  
8 PROGRAM PARTICIPATION, THE BEGINNING AND END DATES OF SUCH  
9 PARTICIPATION, AND OTHER INFORMATION RELATED TO SUCH PARTICIPATION NOT  
10 MADE CONFIDENTIAL UNDER MEMBER STATE LAW;

11 (5) ANY DENIAL OF APPLICATION FOR LICENSURE, AND THE  
12 REASON(S) FOR SUCH DENIAL;

13 (6) THE PRESENCE OF CURRENT SIGNIFICANT INVESTIGATIVE  
14 INFORMATION; AND

15 (7) OTHER INFORMATION THAT MAY FACILITATE THE  
16 ADMINISTRATION OF THIS COMPACT, AS DETERMINED BY THE RULES OF THE  
17 COMMISSION.

18 (D) THE RECORDS AND INFORMATION PROVIDED TO A MEMBER STATE  
19 PURSUANT TO THIS COMPACT OR THROUGH THE DATA SYSTEM, WHEN CERTIFIED  
20 BY THE COMMISSION OR AN AGENT THEREOF, SHALL CONSTITUTE THE  
21 AUTHENTICATED BUSINESS RECORDS OF THE COMMISSION, AND SHALL BE  
22 ENTITLED TO ANY ASSOCIATED HEARSAY EXCEPTION IN ANY RELEVANT JUDICIAL,  
23 QUASI-JUDICIAL OR ADMINISTRATIVE PROCEEDINGS IN A MEMBER STATE.

24 (E) CURRENT SIGNIFICANT INVESTIGATIVE INFORMATION PERTAINING TO  
25 A LICENSEE IN ANY MEMBER STATE WILL ONLY BE AVAILABLE TO OTHER MEMBER  
26 STATES.

27 (1) IT IS THE RESPONSIBILITY OF THE MEMBER STATES TO REPORT  
28 ANY ADVERSE ACTION AGAINST A LICENSEE AND TO MONITOR THE DATABASE TO  
29 DETERMINE WHETHER INFORMATION PERTAINING TO A LICENSEE IN ANY MEMBER  
30 STATE WILL BE AVAILABLE TO ANY OTHER MEMBER STATE.

1           **(F) MEMBER STATES CONTRIBUTING INFORMATION TO THE DATA SYSTEM**  
2 **MAY DESIGNATE INFORMATION THAT MAY NOT BE SHARED WITH THE PUBLIC**  
3 **WITHOUT THE EXPRESS PERMISSION OF THE CONTRIBUTING STATE.**

4           **(G) ANY INFORMATION SUBMITTED TO THE DATA SYSTEM THAT IS**  
5 **SUBSEQUENTLY EXPUNGED PURSUANT TO FEDERAL LAW OR THE LAWS OF THE**  
6 **MEMBER STATE CONTRIBUTING THE INFORMATION SHALL BE REMOVED FROM THE**  
7 **DATA SYSTEM.**

8 **SECTION 12. RULEMAKING.**

9           **(A) THE COMMISSION SHALL PROMULGATE REASONABLE RULES IN ORDER**  
10 **TO EFFECTIVELY AND EFFICIENTLY IMPLEMENT AND ADMINISTER THE PURPOSES**  
11 **AND PROVISIONS OF THE COMPACT. A RULE SHALL BE INVALID AND HAVE NO FORCE**  
12 **OR EFFECT ONLY IF A COURT OF COMPETENT JURISDICTION HOLDS THAT THE RULE**  
13 **IS INVALID BECAUSE THE COMMISSION EXERCISED ITS RULEMAKING AUTHORITY IN**  
14 **A MANNER THAT IS BEYOND THE SCOPE AND PURPOSES OF THE COMPACT, OR THE**  
15 **POWERS GRANTED HEREUNDER, OR BASED UPON ANOTHER APPLICABLE STANDARD**  
16 **OF REVIEW.**

17           **(B) THE RULES OF THE COMMISSION SHALL HAVE THE FORCE OF LAW IN**  
18 **EACH MEMBER STATE, PROVIDED HOWEVER THAT WHERE THE RULES OF THE**  
19 **COMMISSION CONFLICT WITH THE LAWS OF THE MEMBER STATE THAT ESTABLISH**  
20 **THE MEMBER STATE'S SCOPE OF PRACTICE AS HELD BY A COURT OF COMPETENT**  
21 **JURISDICTION, THE RULES OF THE COMMISSION SHALL BE INEFFECTIVE IN THAT**  
22 **STATE TO THE EXTENT OF THE CONFLICT.**

23           **(C) THE COMMISSION SHALL EXERCISE ITS RULEMAKING POWERS**  
24 **PURSUANT TO THE CRITERIA SET FORTH IN THIS SECTION AND THE RULES ADOPTED**  
25 **THEREUNDER. RULES SHALL BECOME BINDING AS ON THE DAY FOLLOWING**  
26 **ADOPTION OR THE DATE SPECIFIED IN THE RULE OR AMENDMENT, WHICHEVER IS**  
27 **LATER.**

28           **(D) IF A MAJORITY OF THE LEGISLATURES OF THE MEMBER STATES**  
29 **REJECTS A RULE OR PORTION OF A RULE, BY ENACTMENT OF A STATUTE OR**  
30 **RESOLUTION IN THE SAME MANNER USED TO ADOPT THE COMPACT WITHIN FOUR**  
31 **YEARS OF THE DATE OF ADOPTION OF THE RULE, THEN SUCH RULE SHALL HAVE NO**  
32 **FURTHER FORCE AND EFFECT IN ANY MEMBER STATE.**

33           **(E) RULES SHALL BE ADOPTED AT A REGULAR OR SPECIAL MEETING OF THE**  
34 **COMMISSION.**

1           **(F) PRIOR TO ADOPTION OF A PROPOSED RULE, THE COMMISSION SHALL**  
2 **HOLD A PUBLIC HEARING AND ALLOW PERSONS TO PROVIDE ORAL AND WRITTEN**  
3 **COMMENTS, DATA, FACTS, OPINIONS, AND ARGUMENTS.**

4           **(G) PRIOR TO ADOPTION OF A PROPOSED RULE BY THE COMMISSION, AND**  
5 **AT LEAST 30 DAYS IN ADVANCE OF THE MEETING AT WHICH THE COMMISSION WILL**  
6 **HOLD A PUBLIC HEARING ON THE PROPOSED RULE, THE COMMISSION SHALL**  
7 **PROVIDE A NOTICE OF PROPOSED RULEMAKING:**

8                   **(1) ON THE WEBSITE OF THE COMMISSION OR OTHER PUBLICLY**  
9 **ACCESSIBLE PLATFORM;**

10                   **(2) TO PERSONS WHO HAVE REQUESTED NOTICE OF THE**  
11 **COMMISSION'S NOTICES OF PROPOSED RULEMAKING; AND**

12                   **(3) IN SUCH OTHER WAY(S) AS THE COMMISSION MAY BY RULE**  
13 **SPECIFY.**

14           **(H) THE NOTICE OF PROPOSED RULEMAKING SHALL INCLUDE:**

15                   **(1) THE TIME, DATE, AND LOCATION OF THE PUBLIC HEARING AT**  
16 **WHICH THE COMMISSION WILL HEAR PUBLIC COMMENTS ON THE PROPOSED RULE,**  
17 **AND, IF DIFFERENT, THE TIME, DATE, AND LOCATION OF THE MEETING WHERE THE**  
18 **COMMISSION WILL CONSIDER AND VOTE ON THE PROPOSED RULE;**

19                   **(2) IF THE HEARING IS HELD VIA TELECOMMUNICATION, VIDEO**  
20 **CONFERENCE, OR OTHER ELECTRONIC MEANS, THE COMMISSION SHALL INCLUDE**  
21 **THE MECHANISM FOR ACCESS TO THE HEARING IN THE NOTICE OF PROPOSED**  
22 **RULEMAKING;**

23                   **(3) THE TEXT OF THE PROPOSED RULE AND THE REASON THEREFOR;**

24                   **(4) A REQUEST FOR COMMENTS ON THE PROPOSED RULE FROM ANY**  
25 **INTERESTED PERSON; AND**

26                   **(5) THE MANNER IN WHICH INTERESTED PERSONS MAY SUBMIT**  
27 **WRITTEN COMMENTS.**

28           **(I) ALL HEARINGS WILL BE RECORDED. A COPY OF THE RECORDING AND**  
29 **ALL WRITTEN COMMENTS AND DOCUMENTS RECEIVED BY THE COMMISSION IN**  
30 **RESPONSE TO THE PROPOSED RULE SHALL BE MADE AVAILABLE TO THE PUBLIC.**

1           **(J) NOTHING IN THIS SECTION SHALL BE CONSTRUED AS REQUIRING A**  
2 **SEPARATE HEARING ON EACH RULE. RULES MAY BE GROUPED FOR THE**  
3 **CONVENIENCE OF THE COMMISSION AT HEARINGS REQUIRED BY THIS SECTION.**

4           **(K) THE COMMISSION SHALL, BY MAJORITY VOTE OF ALL MEMBERS, TAKE**  
5 **FINAL ACTION ON THE PROPOSED RULE BASED ON THE RULEMAKING RECORD AND**  
6 **THE FULL TEXT OF THE RULE.**

7           **(1) THE COMMISSION MAY ADOPT CHANGES TO THE PROPOSED RULE**  
8 **PROVIDED THE CHANGES DO NOT ENLARGE THE ORIGINAL PURPOSE OF THE**  
9 **PROPOSED RULE.**

10           **(2) THE COMMISSION SHALL PROVIDE AN EXPLANATION OF THE**  
11 **REASONS FOR SUBSTANTIVE CHANGES MADE TO THE PROPOSED RULE AS WELL AS**  
12 **REASONS FOR SUBSTANTIVE CHANGES NOT MADE THAT WERE RECOMMENDED BY**  
13 **COMMENTERS.**

14           **(3) THE COMMISSION SHALL DETERMINE A REASONABLE EFFECTIVE**  
15 **DATE FOR THE RULE. EXCEPT FOR AN EMERGENCY AS PROVIDED IN SECTION 12(L),**  
16 **THE EFFECTIVE DATE OF THE RULE SHALL BE NO SOONER THAN 30 DAYS AFTER**  
17 **ISSUING THE NOTICE THAT IT ADOPTED OR AMENDED THE RULE.**

18           **(L) UPON DETERMINATION THAT AN EMERGENCY EXISTS, THE**  
19 **COMMISSION MAY CONSIDER AND ADOPT AN EMERGENCY RULE WITH 48 HOURS'**  
20 **NOTICE, WITH OPPORTUNITY TO COMMENT, PROVIDED THAT THE USUAL**  
21 **RULEMAKING PROCEDURES PROVIDED IN THE COMPACT AND IN THIS SECTION**  
22 **SHALL BE RETROACTIVELY APPLIED TO THE RULE AS SOON AS REASONABLY**  
23 **POSSIBLE, IN NO EVENT LATER THAN 90 DAYS AFTER THE EFFECTIVE DATE OF THE**  
24 **RULE. FOR THE PURPOSES OF THIS PROVISION, AN EMERGENCY RULE IS ONE THAT**  
25 **MUST BE ADOPTED IMMEDIATELY IN ORDER TO:**

26           **(1) MEET AN IMMINENT THREAT TO PUBLIC HEALTH, SAFETY, OR**  
27 **WELFARE;**

28           **(2) PREVENT A LOSS OF COMMISSION OR MEMBER STATE FUNDS;**

29           **(3) MEET A DEADLINE FOR THE PROMULGATION OF A RULE THAT IS**  
30 **ESTABLISHED BY FEDERAL LAW OR RULE; OR**

31           **(4) PROTECT PUBLIC HEALTH AND SAFETY.**

32           **(M) THE COMMISSION OR AN AUTHORIZED COMMITTEE OF THE**  
33 **COMMISSION MAY DIRECT REVISIONS TO A PREVIOUSLY ADOPTED RULE FOR**

1 PURPOSES OF CORRECTING TYPOGRAPHICAL ERRORS, ERRORS IN FORMAT,  
2 ERRORS IN CONSISTENCY, OR GRAMMATICAL ERRORS. PUBLIC NOTICE OF ANY  
3 REVISIONS SHALL BE POSTED ON THE WEBSITE OF THE COMMISSION. THE REVISION  
4 SHALL BE SUBJECT TO CHALLENGE BY ANY PERSON FOR A PERIOD OF 30 DAYS  
5 AFTER POSTING. THE REVISION MAY BE CHALLENGED ONLY ON GROUNDS THAT THE  
6 REVISION RESULTS IN A MATERIAL CHANGE TO A RULE. A CHALLENGE SHALL BE  
7 MADE IN WRITING AND DELIVERED TO THE CHAIR OF THE COMMISSION PRIOR TO  
8 THE END OF THE NOTICE PERIOD. IF NO CHALLENGE IS MADE, THE REVISION WILL  
9 TAKE EFFECT WITHOUT FURTHER ACTION. IF THE REVISION IS CHALLENGED, THE  
10 REVISION MAY NOT TAKE EFFECT WITHOUT THE APPROVAL OF THE COMMISSION.

11 (N) NO MEMBER STATE'S RULEMAKING REQUIREMENTS SHALL APPLY  
12 UNDER THIS COMPACT.

13 SECTION 13. OVERSIGHT, DISPUTE RESOLUTION, AND  
14 ENFORCEMENT.

15 (A) (1) THE EXECUTIVE AND JUDICIAL BRANCHES OF STATE  
16 GOVERNMENT IN EACH MEMBER STATE SHALL ENFORCE THIS COMPACT AND TAKE  
17 ALL ACTIONS NECESSARY AND APPROPRIATE TO IMPLEMENT THE COMPACT.

18 (2) EXCEPT AS OTHERWISE PROVIDED IN THIS COMPACT, VENUE IS  
19 PROPER AND JUDICIAL PROCEEDINGS BY OR AGAINST THE COMMISSION SHALL BE  
20 BROUGHT SOLELY AND EXCLUSIVELY IN A COURT OF COMPETENT JURISDICTION  
21 WHERE THE PRINCIPAL OFFICE OF THE COMMISSION IS LOCATED. THE  
22 COMMISSION MAY WAIVE VENUE AND JURISDICTIONAL DEFENSES TO THE EXTENT  
23 IT ADOPTS OR CONSENTS TO PARTICIPATE IN ALTERNATIVE DISPUTE RESOLUTION  
24 PROCEEDINGS. NOTHING HEREIN SHALL AFFECT OR LIMIT THE SELECTION OR  
25 PROPRIETY OF VENUE IN ANY ACTION AGAINST A LICENSEE FOR PROFESSIONAL  
26 MALPRACTICE, MISCONDUCT OR ANY SUCH SIMILAR MATTER.

27 (3) THE COMMISSION SHALL BE ENTITLED TO RECEIVE SERVICE OF  
28 PROCESS IN ANY SUCH PROCEEDING REGARDING THE ENFORCEMENT OR  
29 INTERPRETATION OF THE COMPACT, AND SHALL HAVE STANDING TO INTERVENE IN  
30 SUCH A PROCEEDING FOR ALL PURPOSES. FAILURE TO PROVIDE THE COMMISSION  
31 SERVICE OF PROCESS RENDERS A JUDGMENT OR ORDER VOID AS TO THE  
32 COMMISSION, THE COMPACT, OR PROMULGATED RULES.

33 (B) (1) IF THE COMMISSION DETERMINES THAT A MEMBER STATE HAS  
34 DEFAULTED IN THE PERFORMANCE OF ITS OBLIGATIONS OR RESPONSIBILITIES  
35 UNDER THIS COMPACT OR THE PROMULGATED RULES, THE COMMISSION SHALL  
36 PROVIDE WRITTEN NOTICE TO THE DEFAULTING STATE. THE NOTICE OF DEFAULT  
37 SHALL DESCRIBE THE DEFAULT, THE PROPOSED MEANS OF CURING THE DEFAULT,

1 AND ANY OTHER ACTION THAT THE COMMISSION MAY TAKE, AND SHALL OFFER  
2 TRAINING AND SPECIFIC TECHNICAL ASSISTANCE REGARDING THE DEFAULT.

3 (2) THE COMMISSION SHALL PROVIDE A COPY OF THE NOTICE OF  
4 DEFAULT TO THE OTHER MEMBER STATES.

5 (C) IF A STATE IN DEFAULT FAILS TO CURE THE DEFAULT, THE DEFAULTING  
6 STATE MAY BE TERMINATED FROM THE COMPACT UPON AN AFFIRMATIVE VOTE OF  
7 A MAJORITY OF THE DELEGATES OF THE MEMBER STATES, AND ALL RIGHTS,  
8 PRIVILEGES AND BENEFITS CONFERRED ON THAT STATE BY THIS COMPACT MAY BE  
9 TERMINATED ON THE EFFECTIVE DATE OF TERMINATION. A CURE OF THE DEFAULT  
10 DOES NOT RELIEVE THE OFFENDING STATE OF OBLIGATIONS OR LIABILITIES  
11 INCURRED DURING THE PERIOD OF DEFAULT.

12 (D) TERMINATION OF MEMBERSHIP IN THE COMPACT SHALL BE IMPOSED  
13 ONLY AFTER ALL OTHER MEANS OF SECURING COMPLIANCE HAVE BEEN  
14 EXHAUSTED. NOTICE OF INTENT TO SUSPEND OR TERMINATE SHALL BE GIVEN BY  
15 THE COMMISSION TO THE GOVERNOR, THE MAJORITY AND MINORITY LEADERS OF  
16 THE DEFAULTING STATE'S LEGISLATURE, THE DEFAULTING STATE'S STATE  
17 LICENSING AUTHORITY, AND EACH OF THE MEMBER STATES' LICENSING  
18 AUTHORITY.

19 (E) A STATE THAT HAS BEEN TERMINATED IS RESPONSIBLE FOR ALL  
20 ASSESSMENTS, OBLIGATIONS, AND LIABILITIES INCURRED THROUGH THE  
21 EFFECTIVE DATE OF TERMINATION, INCLUDING OBLIGATIONS THAT EXTEND  
22 BEYOND THE EFFECTIVE DATE OF TERMINATION.

23 (F) UPON THE TERMINATION OF A STATE'S MEMBERSHIP FROM THIS  
24 COMPACT, THAT STATE SHALL IMMEDIATELY PROVIDE NOTICE TO ALL LICENSEES  
25 WITHIN THAT STATE OF SUCH TERMINATION. THE TERMINATED STATE SHALL  
26 CONTINUE TO RECOGNIZE ALL LICENSES GRANTED PURSUANT TO THIS COMPACT  
27 FOR A MINIMUM OF SIX MONTHS AFTER THE DATE OF SAID NOTICE OF TERMINATION.

28 (G) THE COMMISSION MAY NOT BEAR ANY COSTS RELATED TO A STATE  
29 THAT IS FOUND TO BE IN DEFAULT OR THAT HAS BEEN TERMINATED FROM THE  
30 COMPACT, UNLESS AGREED UPON IN WRITING BETWEEN THE COMMISSION AND THE  
31 DEFAULTING STATE.

32 (H) THE DEFAULTING STATE MAY APPEAL THE ACTION OF THE COMMISSION  
33 BY PETITIONING THE U.S. DISTRICT COURT FOR THE DISTRICT OF COLUMBIA OR  
34 THE FEDERAL DISTRICT WHERE THE COMMISSION HAS ITS PRINCIPAL OFFICES.  
35 THE PREVAILING PARTY SHALL BE AWARDED ALL COSTS OF SUCH LITIGATION,  
36 INCLUDING REASONABLE ATTORNEY'S FEES.

1           **(I) (1) UPON REQUEST BY A MEMBER STATE, THE COMMISSION SHALL**  
2 **ATTEMPT TO RESOLVE DISPUTES RELATED TO THE COMPACT THAT ARISE AMONG**  
3 **MEMBER STATES AND BETWEEN MEMBER AND NON-MEMBER STATES.**

4           **(2) THE COMMISSION SHALL PROMULGATE A RULE PROVIDING FOR**  
5 **BOTH MEDIATION AND BINDING DISPUTE RESOLUTION FOR DISPUTES AS**  
6 **APPROPRIATE.**

7           **(J) (1) BY MAJORITY VOTE AS PROVIDED BY RULE, THE COMMISSION**  
8 **MAY INITIATE LEGAL ACTION AGAINST A MEMBER STATE IN DEFAULT IN THE**  
9 **UNITED STATES DISTRICT COURT FOR THE DISTRICT OF COLUMBIA OR THE**  
10 **FEDERAL DISTRICT WHERE THE COMMISSION HAS ITS PRINCIPAL OFFICES TO**  
11 **ENFORCE COMPLIANCE WITH THE PROVISIONS OF THE COMPACT AND ITS**  
12 **PROMULGATED RULES. THE RELIEF SOUGHT MAY INCLUDE BOTH INJUNCTIVE**  
13 **RELIEF AND DAMAGES. IN THE EVENT JUDICIAL ENFORCEMENT IS NECESSARY, THE**  
14 **PREVAILING MEMBER SHALL BE AWARDED ALL COSTS OF SUCH LITIGATION,**  
15 **INCLUDING REASONABLE ATTORNEY’S FEES. THE REMEDIES HEREIN SHALL NOT BE**  
16 **THE EXCLUSIVE REMEDIES OF THE COMMISSION. THE COMMISSION MAY PURSUE**  
17 **ANY OTHER REMEDIES AVAILABLE UNDER FEDERAL OR THE DEFAULTING MEMBER**  
18 **STATE’S LAW.**

19           **(2) A MEMBER STATE MAY INITIATE LEGAL ACTION AGAINST THE**  
20 **COMMISSION IN THE U.S. DISTRICT COURT FOR THE DISTRICT OF COLUMBIA OR**  
21 **THE FEDERAL DISTRICT WHERE THE COMMISSION HAS ITS PRINCIPAL OFFICES TO**  
22 **ENFORCE COMPLIANCE WITH THE PROVISIONS OF THE COMPACT AND ITS**  
23 **PROMULGATED RULES. THE RELIEF SOUGHT MAY INCLUDE BOTH INJUNCTIVE**  
24 **RELIEF AND DAMAGES. IN THE EVENT JUDICIAL ENFORCEMENT IS NECESSARY, THE**  
25 **PREVAILING PARTY SHALL BE AWARDED ALL COSTS OF SUCH LITIGATION,**  
26 **INCLUDING REASONABLE ATTORNEY’S FEES.**

27           **(3) NO PERSON OTHER THAN A MEMBER STATE SHALL ENFORCE THIS**  
28 **COMPACT AGAINST THE COMMISSION.**

#### 29 **SECTION 14. EFFECTIVE DATE, WITHDRAWAL, AND AMENDMENT.**

30           **(A) THE COMPACT SHALL COME INTO EFFECT ON THE DATE ON WHICH THE**  
31 **COMPACT STATUTE IS ENACTED INTO LAW IN THE SEVENTH MEMBER STATE.**

32           **(1) ON OR AFTER THE EFFECTIVE DATE OF THE COMPACT, THE**  
33 **COMMISSION SHALL CONVENE AND REVIEW THE ENACTMENT OF EACH OF THE**  
34 **FIRST SEVEN MEMBER STATES (“CHARTER MEMBER STATES”) TO DETERMINE IF**

1 THE STATUTE ENACTED BY EACH SUCH CHARTER MEMBER STATE IS MATERIALLY  
2 DIFFERENT THAN THE MODEL COMPACT STATUTE.

3 (I) A CHARTER MEMBER STATE WHOSE ENACTMENT IS FOUND  
4 TO BE MATERIALLY DIFFERENT FROM THE MODEL COMPACT STATUTE SHALL BE  
5 ENTITLED TO THE DEFAULT PROCESS SET FORTH IN SECTION 13.

6 (II) IF ANY MEMBER STATE IS LATER FOUND TO BE IN DEFAULT,  
7 OR IS TERMINATED OR WITHDRAWS FROM THE COMPACT, THE COMMISSION SHALL  
8 REMAIN IN EXISTENCE AND THE COMPACT SHALL REMAIN IN EFFECT EVEN IF THE  
9 NUMBER OF MEMBER STATES SHOULD BE LESS THAN SEVEN.

10 (2) MEMBER STATES ENACTING THE COMPACT SUBSEQUENT TO THE  
11 SEVEN INITIAL CHARTER MEMBER STATES SHALL BE SUBJECT TO THE PROCESS SET  
12 FORTH IN SECTION 10(C)(21) TO DETERMINE IF THEIR ENACTMENTS ARE  
13 MATERIALLY DIFFERENT FROM THE MODEL COMPACT STATUTE AND WHETHER  
14 THEY QUALIFY FOR PARTICIPATION IN THE COMPACT.

15 (3) ALL ACTIONS TAKEN FOR THE BENEFIT OF THE COMMISSION OR  
16 IN FURTHERANCE OF THE PURPOSES OF THE ADMINISTRATION OF THE COMPACT  
17 PRIOR TO THE EFFECTIVE DATE OF THE COMPACT OR THE COMMISSION COMING  
18 INTO EXISTENCE SHALL BE CONSIDERED TO BE ACTIONS OF THE COMMISSION  
19 UNLESS SPECIFICALLY REPUDIATED BY THE COMMISSION.

20 (4) ANY STATE THAT JOINS THE COMPACT SUBSEQUENT TO THE  
21 COMMISSION'S INITIAL ADOPTION OF THE RULES SHALL BE SUBJECT TO THE RULES  
22 AND BYLAWS AS THEY EXIST ON THE DATE ON WHICH THE COMPACT BECOMES LAW  
23 IN THAT STATE. ANY RULE THAT HAS BEEN PREVIOUSLY ADOPTED BY THE  
24 COMMISSION SHALL HAVE THE FULL FORCE AND EFFECT OF LAW ON THE DAY THE  
25 COMPACT BECOMES LAW IN THAT STATE.

26 (B) ANY MEMBER STATE MAY WITHDRAW FROM THE COMPACT BY  
27 ENACTING A STATUTE REPEALING THE SAME.

28 (1) A MEMBER STATE'S WITHDRAWAL SHALL NOT TAKE EFFECT  
29 UNTIL 180 DAYS AFTER ENACTMENT OF THE REPEALING STATUTE.

30 (2) WITHDRAWAL SHALL NOT AFFECT THE CONTINUING  
31 REQUIREMENT OF THE WITHDRAWING STATE'S LICENSING AUTHORITY TO COMPLY  
32 WITH THE INVESTIGATIVE AND ADVERSE ACTION REPORTING REQUIREMENTS OF  
33 THIS ACT PRIOR TO THE EFFECTIVE DATE OF WITHDRAWAL.



1           **(3) UPON THE ENACTMENT OF A STATUTE WITHDRAWING FROM THIS**  
2 **COMPACT, A STATE SHALL IMMEDIATELY PROVIDE NOTICE OF SUCH WITHDRAWAL**  
3 **TO ALL LICENSEES WITHIN THAT STATE. NOTWITHSTANDING ANY SUBSEQUENT**  
4 **STATUTORY ENACTMENT TO THE CONTRARY, SUCH WITHDRAWING STATE SHALL**  
5 **CONTINUE TO RECOGNIZE ALL LICENSES GRANTED PURSUANT TO THIS COMPACT**  
6 **FOR A MINIMUM OF 180 DAYS AFTER THE DATE OF SUCH NOTICE OF WITHDRAWAL.**

7           **(C) NOTHING CONTAINED IN THIS COMPACT SHALL BE CONSTRUED TO**  
8 **INVALIDATE OR PREVENT ANY SOCIAL WORK LICENSURE AGREEMENT OR OTHER**  
9 **COOPERATIVE ARRANGEMENT BETWEEN A MEMBER STATE AND A NON-MEMBER**  
10 **STATE THAT DOES NOT CONFLICT WITH THE PROVISIONS OF THIS COMPACT.**

11           **(D) THIS COMPACT MAY BE AMENDED BY THE MEMBER STATES. NO**  
12 **AMENDMENT TO THE COMPACT SHALL BECOME EFFECTIVE AND BINDING UPON ANY**  
13 **MEMBER STATE UNTIL IT IS ENACTED INTO THE LAWS OF ALL MEMBER STATES.**

14 **SECTION 15. CONSTRUCTION AND SEVERABILITY.**

15           **(A) THIS COMPACT AND THE COMMISSION'S RULEMAKING AUTHORITY**  
16 **SHALL BE LIBERALLY CONSTRUED SO AS TO EFFECTUATE THE PURPOSES, AND THE**  
17 **IMPLEMENTATION AND ADMINISTRATION OF THE COMPACT. PROVISIONS OF THE**  
18 **COMPACT EXPRESSLY AUTHORIZING OR REQUIRING THE PROMULGATION OF RULES**  
19 **SHALL NOT BE CONSTRUED TO LIMIT THE COMMISSION'S RULEMAKING AUTHORITY**  
20 **SOLELY FOR THOSE PURPOSES.**

21           **(B) THE PROVISIONS OF THIS COMPACT SHALL BE SEVERABLE AND IF ANY**  
22 **PHRASE, CLAUSE, SENTENCE OR PROVISION OF THIS COMPACT IS HELD BY A COURT**  
23 **OF COMPETENT JURISDICTION TO BE CONTRARY TO THE CONSTITUTION OF ANY**  
24 **MEMBER STATE, A STATE SEEKING PARTICIPATION IN THE COMPACT, OR OF THE**  
25 **UNITED STATES, OR THE APPLICABILITY THEREOF TO ANY GOVERNMENT, AGENCY,**  
26 **PERSON OR CIRCUMSTANCE IS HELD TO BE UNCONSTITUTIONAL BY A COURT OF**  
27 **COMPETENT JURISDICTION, THE VALIDITY OF THE REMAINDER OF THE COMPACT**  
28 **AND THE APPLICABILITY THEREOF TO ANY GOVERNMENT, AGENCY, PERSON, OR**  
29 **CIRCUMSTANCE SHALL NOT BE AFFECTED THEREBY.**

30           **(C) NOTWITHSTANDING SUBSECTION (B) OF THIS SECTION, THE**  
31 **COMMISSION MAY DENY A STATE'S PARTICIPATION IN THE COMPACT OR, IN**  
32 **ACCORDANCE WITH THE REQUIREMENTS OF SECTION 13(B), TERMINATE A MEMBER**  
33 **STATE'S PARTICIPATION IN THE COMPACT, IF IT DETERMINES THAT A**  
34 **CONSTITUTIONAL REQUIREMENT OF A MEMBER STATE IS A MATERIAL DEPARTURE**  
35 **FROM THE COMPACT. OTHERWISE, IF THIS COMPACT SHALL BE HELD TO BE**  
36 **CONTRARY TO THE CONSTITUTION OF ANY MEMBER STATE, THE COMPACT SHALL**  
37 **REMAIN IN FULL FORCE AND EFFECT AS TO THE REMAINING MEMBER STATES AND**

1 IN FULL FORCE AND EFFECT AS TO THE MEMBER STATE AFFECTED AS TO ALL  
2 SEVERABLE MATTERS.

3 **SECTION 16. BINDING EFFECT OF COMPACT AND OTHER LAWS.**

4 (A) A LICENSEE PROVIDING SERVICES IN A REMOTE STATE UNDER A  
5 MULTISTATE AUTHORIZATION TO PRACTICE SHALL ADHERE TO THE LAWS AND  
6 REGULATIONS, INCLUDING SCOPE OF PRACTICE, OF THE REMOTE STATE WHERE  
7 THE CLIENT IS LOCATED AT THE TIME CARE IS RENDERED.

8 (B) NOTHING HEREIN SHALL PREVENT OR INHIBIT THE ENFORCEMENT OF  
9 ANY OTHER LAW OF A MEMBER STATE THAT IS NOT INCONSISTENT WITH THE  
10 COMPACT.

11 (C) ANY LAWS, STATUTES, REGULATIONS, OR OTHER LEGAL  
12 REQUIREMENTS IN A MEMBER STATE IN CONFLICT WITH THE COMPACT ARE  
13 SUPERSEDED TO THE EXTENT OF THE CONFLICT.

14 (D) ALL PERMISSIBLE AGREEMENTS BETWEEN THE COMMISSION AND THE  
15 MEMBER STATES ARE BINDING IN ACCORDANCE WITH THEIR TERMS.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act is contingent on the  
17 enacting of substantially similar legislation in six other states. The Maryland Department  
18 of Health shall notify the Department of Legislative Services within 10 days after six states  
19 have enacted legislation that is substantially similar to this Act.

20 SECTION 3. AND BE IT FURTHER ENACTED, That, subject to Section 2 of this  
21 Act, this Act shall take effect October 1, 2024.
