## A BILL ENTITLED

1 AN ACT concerning

2 **State Retirement and Pension System – Immediate Vesting**

3 FOR the purpose of providing that an individual serving as the State Superintendent of  
4 Schools shall immediately vest in the State Retirement and Pension System; and  
5 generally relating to vesting in the State Retirement and Pension System.

6 BY repealing and reenacting, with amendments,  
7 Article – State Personnel and Pensions  
8 Section 29–304  
9 Annotated Code of Maryland  
10 (2015 Replacement Volume and 2023 Supplement)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
12 That the Laws of Maryland read as follows:

13 **Article – State Personnel and Pensions**

14 29–304.

15 An individual shall have immediate vesting rights on taking office in the State  
16 system in which the individual is a member if the individual is the:

17 (1) secretary of a principal department of the Executive Branch of State  
18 government as provided under § 8–201 of the State Government Article;

19 (2) Executive Director of the Alcohol and Tobacco Commission;

20 (3) Adjutant General of the Military Department;

21 (4) Chair of the State Board of Contract Appeals;

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
23 1, 2024.
