1 AN ACT concerning

2 **Maryland Community Investment Corporation – Establishment**
3 **(Housing and Community Development Financing Act of 2024)**

4 FOR the purpose of establishing the Maryland Community Investment Corporation as an
5 independent unit to make investments in certain low-income communities;
6 authorizing the Board of Directors of the Corporation to establish a certain advisory
7 committee and requiring the Corporation to establish an investment committee;
8 requiring the Corporation to apply for an allocation of federal new markets tax
9 credits; establishing eligible uses of money of the Corporation; expanding the eligible
10 uses of the Strategic Demolition and Smart Growth Impact Fund to include grants
11 and loans for ~~debt payments and for~~ credit enhancement for certain projects; and
12 generally relating to community investment, the Maryland Community Investment
13 Corporation, and the Strategic Demolition and Smart Growth Impact Fund.

7 **(7) MAKE INVESTMENTS AND FINANCIAL ASSISTANCE AVAILABLE TO**
8 **LOW-INCOME COMMUNITIES IN THE STATE FROM THE CORPORATION'S MONEY OR**
9 **FROM ANY OTHER SOURCE;**

10 **(8) BUILD A LONG-TERM FINANCIAL CAPACITY AND SUSTAINED**
11 **INVESTMENT IN LOW-INCOME COMMUNITIES IN THE STATE;**

12 **(9) COORDINATE AND CREATE PATHWAYS TO FOLLOW-ON FINANCING**
13 **IN THE STATE; AND**

14 **(10) FOSTER INCLUSIVE AND DIVERSE ENTREPRENEURSHIP AND**
15 **INNOVATION THROUGHOUT THE STATE, WHICH MAY INCLUDE INITIATIVES TO RAISE**
16 **AWARENESS OF PROGRAMS TO ASSIST LOW-INCOME COMMUNITIES.**

18 **(A) A BOARD OF DIRECTORS SHALL MANAGE THE CORPORATION AND ITS**
19 **UNITS AND EXERCISE ITS CORPORATE POWERS.**

20 **(B) THE BOARD CONSISTS OF THE FOLLOWING MEMBERS:**

21 **(1) THE COMPTROLLER OR THE COMPTROLLER'S DESIGNEE;**

22 **(2) THE SECRETARY OR THE SECRETARY'S DESIGNEE;**

23 **(3) THE SECRETARY OF HOUSING AND COMMUNITY DEVELOPMENT**
24 **OR THE SECRETARY'S DESIGNEE;**

25 **(4) THE SECRETARY OF PLANNING OR THE SECRETARY'S DESIGNEE;**

26 **(5) THE SECRETARY OF GENERAL SERVICES OR THE SECRETARY'S**
27 **DESIGNEE; AND**

28 **(6) THE FOLLOWING MEMBERS APPOINTED BY THE GOVERNOR WITH**
29 **THE ADVICE AND CONSENT OF THE SENATE:**

1 (I) ONE REPRESENTATIVE OF NONPROFIT ENTITIES IN THE
2 STATE; AND

3 (II) ONE REPRESENTATIVE OF LOW-INCOME COMMUNITIES.

4 (C) A MEMBER OF THE BOARD SHALL RESIDE IN THE STATE.

5 (D) IN MAKING APPOINTMENTS TO THE BOARD, THE GOVERNOR SHALL
6 CONSIDER:

7 (1) DIVERSITY; AND

8 (2) ALL GEOGRAPHIC REGIONS OF THE STATE.

9 (E) A MEMBER OF THE BOARD:

10 (1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE BOARD;
11 BUT

12 (2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE
13 STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.

14 (F) (1) THE TERM OF AN APPOINTED MEMBER IS 4 YEARS.

15 (2) THE TERMS OF THE APPOINTED MEMBERS ARE STAGGERED AS
16 REQUIRED BY THE TERMS PROVIDED FOR MEMBERS ON OCTOBER 1, 2024.

17 (3) AT THE END OF A TERM, AN APPOINTED MEMBER CONTINUES TO
18 SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

19 (4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES
20 ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND
21 QUALIFIES.

22 (G) (1) THIS SUBSECTION APPLIES TO A MEMBER WHO IS APPOINTED BY
23 THE GOVERNOR UNDER SUBSECTION (B)(6) OF THIS SECTION.

24 (2) THE GOVERNOR MAY REMOVE AN APPOINTED MEMBER FOR
25 INCOMPETENCE, MISCONDUCT, OR FAILURE TO PERFORM THE DUTIES OF THE
26 POSITION.

17 OPERATED BY ENTITIES THAT HAVE THEIR PRINCIPAL PLACE OF BUSINESS IN THE
18 STATE WHEN ADVISING ON INVESTMENTS MADE IN LOW-INCOME COMMUNITIES IN
19 THE STATE.

19 **1. ADVISE THE CHIEF EXECUTIVE OFFICER, THE**
20 **BOARD, AND ANY OTHER OFFICIAL OF THE CORPORATION AS REQUESTED BY THE**
21 **CORPORATION;**

22 **2. SUPERVISE THE OTHER ASSISTANT ATTORNEYS**
23 **GENERAL ASSIGNED TO THE CORPORATION; AND**

24 **3. PERFORM FOR THE CORPORATION OTHER DUTIES**
25 **THE ATTORNEY GENERAL ASSIGNS.**

26 **(II) THE GENERAL COUNSEL MAY NOT PROVIDE ANY OTHER**
27 **ASSISTANCE NOT SPECIFIED IN SUBPARAGRAPH (I) OF THIS PARAGRAPH.**

28 **(C) WITH THE APPROVAL OF THE ATTORNEY GENERAL, THE CORPORATION**
29 **MAY RETAIN ANY ADDITIONAL NECESSARY ATTORNEYS.**
