1 AN ACT concerning

2 **Allegany County – Property Tax Credit – Evergreen Heritage Center**

3 FOR the purpose of authorizing the governing body of Allegany County or a municipal
4 corporation in Allegany County to grant, by law, a property tax credit against the
5 county or municipal corporation property tax imposed on property that is owned by
6 a certain entity; and generally relating to a property tax credit in Allegany County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

1 (b) The governing body of Allegany County or of a municipal corporation in
2 Allegany County may grant, by law, a property tax credit under this section against the
3 county or municipal corporation property tax imposed on:

4 (16) property that is:

5 (i) owned by:

- 6 1. The Lions Center, LLC;
- 7 2. The Lions Center I, LLC; or
- 8 3. The Lions Center II, LLC; and

9 (ii) known as The Lions Center for Rehabilitation and Extended
10 Care; [and]

11 (17) property that is owned by the Cumberland Economic Development
12 Corporation; AND

13 **(18) PROPERTY THAT IS OWNED BY EVERGREEN HERITAGE CENTER**
14 **FOUNDATION, INC., OR EVERGREEN HERITAGE CENTER HOLDINGS, LLC.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
16 1, 2024, and shall be applicable to all taxable years beginning after June 30, 2024.
