25 SECTION ~~2~~ 3. AND BE IT FURTHER ENACTED, That, on or before December 31,
26 2024, and on or before December 31 each year thereafter, the Governor's Office of Crime
27 Prevention, ~~Youth, and Victim Services~~ *and Policy* shall report to the General Assembly,
28 in accordance with § 2-1257 of the State Government Article, on the number of children
29 arrested and the number of times the arrest resulted in a complaint with the Department
