AMENDMENTS TO HOUSE BILL 731

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**and Woods**” and substitute “**Woods, Behler, and Healey**”; and strike beginning with “establishing” in line 5 down through “purposes;” in line 7.

On page 2, strike in their entirety lines 1 through 15, inclusive.

AMENDMENT NO. 2

On page 3, strike beginning with “**(4)**” in line 3 down through “**(5)**” in line 4 and substitute “**(4)**”; and in lines 6 and 9, strike “**(6)**” and “**(7)**”, respectively, and substitute “**(5)**” and “**(6)**”, respectively.

On page 4, in line 7, after “**(4)**” insert “**THE STATE HIGHWAY ADMINISTRATOR OR THE ADMINISTRATOR’S DESIGNEE SHALL SERVE AS CHAIR OF THE COALITION.**”

“**(5)**”;

and in line 15, strike “**(5)**” and substitute “**(6)**”.

AMENDMENT NO. 3

On page 5, in lines 3, 8, 9, 10, 12, 14, 16, 18, and 21, strike “**(6)**”, “**(7)**”, “**(I)**”, “**(II)**”, “**(III)**”, “**(IV)**”, “**(V)**”, “**(8)**”, and “**(9)**”, respectively, and substitute “**(7)**”, “**(8)**”, “**1.**”, “**2.**”, “**3.**”, “**4.**”, “**5.**”, “**(9)**”, and “**(10)**”, respectively; in line 8, strike “**THE**” and substitute “**(I)** **EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS PARAGRAPH, THE**”;

in lines 16 and 17, strike “DISBURSEMENTS FROM THE FUND” and substitute “FUNDING FOR WILDLIFE CONNECTIVITY”; and after line 17, insert:

**“(II) THE COALITION MAY CANCEL A MEETING FOR LACK OF AN AGENDA.”**

**AMENDMENT NO. 4**

On pages 6 through 9, strike beginning with “(1)” in line 5 on page 6 down through “(E)” in line 1 on page 9.

**AMENDMENT NO. 5**

On page 9, in line 11, strike “(F)” and substitute “(D)”.

**AMENDMENT NO. 6**

On pages 10 and 11, strike in their entirety the lines beginning with line 23 on page 10 through line 5 on page 11, inclusive.
