## A BILL ENTITLED

1 AN ACT concerning

2 **Department of Aging – Aging Services – Program Repeal and Consolidation**

3 FOR the purpose of repealing provisions of law requiring the Secretary of Aging to develop  
4 certain congregate housing and assisted living programs for seniors; repealing the  
5 Interagency Committee on Aging Services and transferring certain responsibilities  
6 of the Committee to the Department of Aging; authorizing the Department to  
7 perform certain duties to implement and coordinate services to older adults and to  
8 collaborate with certain entities that establish local interagency committees;  
9 requiring the Department to establish, coordinate, and supervise a program to  
10 provide single points of entry within each planning and service area; authorizing  
11 area agencies on aging to make agreements with certain entities and provide staff at  
12 the single points of entry for certain purposes; requiring the Department to develop,  
13 coordinate, and administer with area agencies on aging or other persons a certain  
14 system to provide certain services to certain older adults; and generally relating to  
15 the Department of Aging and aging services.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
2 That Section(s) 10–209 through 10–211, 10–301 through 10–305, and 10–310 of  
3 Article – Human Services of the Annotated Code of Maryland be repealed.

4 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
5 as follows:

6 **Article – Human Services**

7 10–101.

8 (a) In this title the following words have the meanings indicated.

9 (b) “Area agency” means the local agency that the Department designates in  
10 accordance with the Older Americans Act of 1965 to administer the delivery of a  
11 comprehensive and coordinated plan of social and other services and activities for [seniors]  
12 **OLDER ADULTS** in a planning and service area.

13 (c) “Community for a Lifetime” means a community certified under § 10–804 of  
14 this title.

15 (d) [“Congregate housing services” means services provided in an apartment  
16 building that promote independent living for an eligible individual.

17 (e)] “Department” means the Department of Aging.

18 [(f) “Interagency Committee” means the unit established in § 10–301 of this title  
19 to oversee the coordination and consolidation of services for seniors in the State.

20 (g)] **(E)** “Planning and service area” means an area of the State that the  
21 Department designates in accordance with the Older Americans Act of 1965 for the  
22 planning and administration of social, health, and other services for [seniors] **OLDER**  
23 **ADULTS**.

24 [(h)] **(F)** “Secretary” means the Secretary of Aging.

25 Subtitle 3. [Interagency Committee on] Aging Services.

26 [10–306.] **10–301**.

27 (a) [(1) The Interagency Committee shall develop and update annually a plan  
28 for providing coordinated health services, social services, transportation, housing, and  
29 employment services to seniors in the State consistent with the priorities that the  
30 Department establishes.

31 (2) If the members of the Interagency Committee cannot agree on a plan,

1 the chair shall refer the matter to the Governor for resolution.

2 (b) The [Interagency Committee shall establish interagency] **DEPARTMENT**  
3 **MAY ENTER INTO** agreements and **CONTRACTS**, adopt regulations, **AND ADOPT**  
4 **POLICIES AND PROCEDURES** to[:

5 (1) implement and coordinate services to [seniors consistent with the plan  
6 developed under subsection (a) of this section;

7 (2) maximize the sharing of resources among units of State government for  
8 services to seniors;

9 (3) consolidate planning and evaluation efforts at the State and local levels;  
10 and

11 (4) coordinate and expedite the delivery of services to seniors by providing  
12 technical assistance to local agencies] **OLDER ADULTS UNDER THIS TITLE.**

13 [(c) (1) (B) The [Interagency Committee shall assist] **DEPARTMENT MAY**  
14 **COLLABORATE WITH** county agencies [to], **AREA AGENCIES ON AGING, NONPROFIT**  
15 **ORGANIZATIONS, OR OTHER PERSONS THAT** establish local interagency committees  
16 [composed of:

17 (i) the directors of the local health department, local department of  
18 social services, and area agency; and

19 (ii) officials from housing, transportation, mental health,  
20 employment, and economic development agencies.

21 (2) Local interagency committees shall coordinate and expedite the  
22 delivery of services to seniors at the local level].

23 [10-307.] **10-302.**

24 (a) [(1) The [Interagency Committee] **DEPARTMENT** shall establish [and],  
25 coordinate, **AND SUPERVISE** a program to provide single points of entry within each  
26 planning and service area.

27 [(2) The Department shall supervise the program for the Interagency  
28 Committee.]

29 (b) Each area agency **ON AGING** shall operate a single point of entry program to  
30 assess the needs of [seniors] **OLDER ADULTS** and their caregivers and provide appropriate  
31 services.

32 (c) The following services shall be provided through a single point of entry:

1 (1) providing current information on available programs, services, or  
2 benefits;

3 (2) determining the service needs of each [senior] **OLDER ADULT** who  
4 requests service;

5 (3) processing requests for service from [seniors] **OLDER ADULTS**;

6 (4) through widely publicized local outreach facilities and communications  
7 systems, providing access to available public and private programs and services for  
8 [seniors] **OLDER ADULTS**, including:

9 (i) transportation services;

10 (ii) health and nutrition services;

11 (iii) financial assistance;

12 (iv) social services;

13 (v) educational services;

14 (vi) services available through volunteer organizations or private  
15 agencies;

16 (vii) appropriate housing arrangements;

17 (viii) health insurance counseling;

18 (ix) employment and volunteer opportunities;

19 (x) respite care services; and

20 (xi) other programs, information, counseling, or benefits for [seniors]  
21 **OLDER ADULTS**;

22 (5) monitoring the outcome of requests for service or information; and

23 (6) arranging with other agencies for individual assessment to determine  
24 the service needs of [a frail or health-impaired senior] **OLDER ADULTS IN NEED OF**  
25 **LONG-TERM SERVICES AND SUPPORTS**.

26 (d) To the extent possible, each single point of entry shall be:

27 (1) located in a senior citizen center; and

1 (2) available for access at least 5 days a week.

2 (e) [Local interagency committees on services to seniors] **AREA AGENCIES ON**  
3 **AGING** shall make agreements [among themselves] **WITH NONPROFIT ORGANIZATIONS**  
4 **OR OTHER PERSONS AS NEEDED** and [with other agencies to] provide staff on a regular  
5 basis at the single points of entry to:

6 (1) provide information and services to [seniors] **OLDER ADULTS**; and

7 (2) administer agency programs.

8 **[10-308.] 10-303.**

9 Each planning and service area shall have a telephone information and referral  
10 service that is available on a 24-hour basis.

11 **[10-309.] 10-304.**

12 (a) [(1)] The [Interagency Committee] **DEPARTMENT** shall[:

13 (i)] develop, **COORDINATE, AND ADMINISTER WITH AREA**  
14 **AGENCIES ON AGING OR OTHER PERSONS** a system to provide services to [frail or  
15 health-impaired seniors at risk of institutionalization; and

16 (ii) coordinate the system among the agencies represented on the  
17 Interagency Committee.

18 (2) The Department shall administer the system for the Interagency  
19 Committee] **OLDER ADULTS IN NEED OF LONG-TERM SERVICES AND SUPPORTS TO**  
20 **ALLOW OLDER ADULTS TO AGE IN A LOCATION SELECTED BY THE OLDER ADULT**  
21 **WITH APPROPRIATE SERVICES, SUPPORTS, AND HOUSING OPPORTUNITIES.**

22 (b) The services [shall] **MAY** include:

23 (1) integrated screening and evaluation;

24 (2) development of an individual plan of care;

25 (3) in-home services such as [minor] home repair **OR OTHER HOME**  
26 **MODIFICATIONS**, shopping assistance, homemaking, **CHORE SERVICES**, personal care,  
27 meal delivery or preparation, **TRANSPORTATION SERVICES, HEALTH SERVICES, AND**  
28 **OTHER** supportive services [to group or shared living arrangements, transportation  
29 services, and health services; and];

1           (4) [community] **COMMUNITY-BASED** services such as day care,  
2 [congregate meals] **FOOD AND OTHER MEAL COORDINATION**, and other [programs]  
3 **EFFORTS** to assist [seniors] **OLDER ADULTS** or adult caregivers [in providing care for  
4 seniors];

5           (5) **A SUBSIDY FOR THE COSTS OF AN ASSISTED LIVING PROGRAM AS**  
6 **DEFINED IN § 19-1801 OF THE HEALTH – GENERAL ARTICLE;**

7           (6) **ANY OTHER SERVICE THAT MAY MITIGATE THE RISK OF IMPACT**  
8 **TO, OR IMPROVE RESILIENCE OF, HOUSING OR SERVICES OF OLDER ADULTS BY**  
9 **NATURAL, TECHNOLOGICAL, OR HUMAN-MADE THREATS AND HAZARDS, INCLUDING**  
10 **CLIMATE CHANGE; AND**

11           (7) **ANY OTHER SERVICE AUTHORIZED BY THE DEPARTMENT.**

12           (c) To be eligible to participate in the system, a county, [or counties] **AREA**  
13 **AGENCY ON AGING, NONPROFIT ORGANIZATION, OR ANY OTHER PERSON** shall  
14 [establish a community-based plan that:

15           (1) is developed by a local or regional committee composed of:

16                   (i) the directors of the local health department, local department of  
17 social services, and area agency; and

18                   (ii) officials of other relevant agencies, such as local housing,  
19 transportation, employment, and economic development officials;

20           (2) is consistent with the plan developed under § 10-306(a) of this subtitle;

21           (3) specifies administrative arrangements to evaluate and develop care  
22 plans for frail or health-impaired seniors;

23           (4) encourages further coordination of service delivery;

24           (5) fosters individual contributions for services provided;

25           (6) fosters the development of innovative service delivery;

26           (7) fosters the development of services in conjunction with the private  
27 sector; and

28           (8) fosters community involvement through the use of volunteers]  
29 **COMPLY WITH DEPARTMENT STANDARDS.**

1            [(d) The Interagency Committee, through the Department, shall work with local  
2 health departments, local departments of social services, area agencies, and local housing,  
3 transportation, economic development, and employment development officials to:

4            (1) a system to designate case managers to secure and manage necessary  
5 services for each frail or health-impaired senior in need; and

6            (2) guidelines, to establish local or regional committees to coordinate the  
7 services system to implement this section.]

8            SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall be construed to  
9 apply only prospectively and may not be applied or interpreted to have any effect on or  
10 application to any cause of action arising before the effective date of this Act.

11            SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
12 1, 2026.
