5 Waiver Advisory Council to advise and provide recommendations to the
6 Developmental Disabilities Administration on system design, service delivery, and
7 quality enhancement strategies for the Medicaid waiver programs operated by the
8 Administration; and generally relating to the Maryland Developmental Disabilities
9 Administration Waiver Advisory Council.

13 **IN THE ADMINISTRATION;**

14 **(IV) ONE REPRESENTATIVE OF THE DEPARTMENT OF**
15 **DISABILITIES, DESIGNATED BY THE SECRETARY OF DISABILITIES;**

16 **(V) ONE REPRESENTATIVE OF THE DEPARTMENT OF HOUSING**
17 **AND COMMUNITY DEVELOPMENT, DESIGNATED BY THE SECRETARY OF HOUSING**
18 **AND COMMUNITY DEVELOPMENT;**

19 **(VI) ONE REPRESENTATIVE OF THE DEPARTMENT OF HUMAN**

22 ~~(6)~~ (5) TO THE EXTENT PRACTICABLE, THE MEMBERSHIP OF THE
23 COUNCIL SHALL REFLECT THE GENDER, RACIAL, ETHNIC, AND GEOGRAPHICAL
24 DIVERSITY OF THE STATE.

25 (B) (1) THE TERM OF A MEMBER IS 3 YEARS.

26 (2) THE TERMS OF MEMBERS ARE STAGGERED AS REQUIRED BY THE
27 TERMS PROVIDED FOR THE MEMBERS OF THE COUNCIL ON OCTOBER 1, 2025.

28 (3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL
29 A SUCCESSOR IS APPOINTED AND QUALIFIES.

1 **(4) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES**
2 **ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND**
3 **QUALIFIES.**

4 **(5) A MEMBER MAY NOT SERVE CONSECUTIVE TERMS BUT MAY SERVE**
5 **FOR MULTIPLE NONCONSECUTIVE TERMS.**

6 **(C) (1) THE DIRECTOR OF FEDERAL PROGRAMS SHALL SERVE AS A**
7 **NONVOTING COCHAIR.**

8 **(2) THE COUNCIL SHALL VOTE FOR THE ADDITIONAL COCHAIR.**

9 **(D) (1) THE ADMINISTRATION SHALL PROVIDE STAFF FOR THE COUNCIL.**

10 **(2) THE DEPARTMENT SHALL INCLUDE A DEDICATED COUNCIL**
11 **WEBPAGE ON THE DEPARTMENT'S WEBSITE THAT INCLUDES MEETING DATES AND**
12 **TIMES, AGENDAS AND OTHER MEETING DOCUMENTS, AND RECORDED PAST**
13 **MEETINGS OF THE COUNCIL.**

14 **(E) A MEMBER OF THE COUNCIL:**

15 **(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE**
16 **COUNCIL; BUT**

17 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
18 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.**

19 **(F) THE COUNCIL MAY PROVIDE TRAVEL ARRANGEMENTS, AS NECESSARY,**
20 **FOR MEMBERS OF THE COUNCIL WITH DISABILITIES.**

22 **(A) (1) THE COUNCIL SHALL MEET ONCE EVERY 2 MONTHS IN A**
23 **LOCATION THAT IS MADE PUBLICLY AVAILABLE AT LEAST 2 WEEKS BEFORE THE**
24 **MEETING.**

25 **(2) THE COUNCIL MAY HOLD ADDITIONAL MEETINGS IF DETERMINED**
26 **NECESSARY BY THE COCHAIRS.**

27 **(3) MEETINGS OF THE COUNCIL SHALL:**

28 **(I) BE OPEN TO THE PUBLIC AND RECORDED BY VIDEO;**

1 (II) FOLLOW AGENDAS THAT ARE DISTRIBUTED AT LEAST 1
2 WEEK BEFORE THE MEETING TO COUNCIL MEMBERS BY E-MAIL;

3 (III) CONCLUDE WITH A CLEAR UNDERSTANDING OF
4 EXPECTATIONS AND ASSIGNMENTS FOR FUTURE STEPS;

5 (IV) PROVIDE ACCOMMODATIONS FOR INDIVIDUALS WITH
6 DISABILITIES; AND

7 (V) INCLUDE TIME FOR PUBLIC COMMENT AFTER MEETING
8 AGENDA ITEMS HAVE BEEN ADDRESSED.

9 (4) A MEETING OF THE COUNCIL MAY BE HELD VIRTUALLY IF
10 DETERMINED NECESSARY BY THE COCHAIRS.

11 (5) THE COUNCIL SHALL PROVIDE NOTICE OF ITS MEETINGS BY
12 E-MAIL TO MEMBERS AT LEAST 1 WEEK BEFORE THE MEETING AND SHALL INCLUDE
13 AN AGENDA AND ANY DOCUMENTS TO BE REVIEWED FOR THE MEETING.

14 (6) THE COUNCIL SHALL DISTRIBUTE MEETING MINUTES TO
15 MEMBERS WITHIN 2 WEEKS AFTER EACH COUNCIL MEETING.

16 (B) THE COUNCIL MAY FORM WORKGROUPS THAT MAY MEET AS DIRECTED
17 BY THE COCHAIRS.

18 (C) THE COUNCIL SHALL ESTABLISH A CODE OF CONDUCT FOR COUNCIL
19 MEETINGS.

21 (A) THE COUNCIL SHALL PROVIDE ADVICE AND MAKE RECOMMENDATIONS
22 TO THE ADMINISTRATION ON:

23 (1) ADMINISTRATION-OPERATED MEDICAID WAIVER PROGRAM
24 SYSTEM DESIGN, INCLUDING WAIVER APPLICATION REGULATIONS AND POLICIES;

25 (2) SERVICE DELIVERY AND ACCESS TO SERVICES;

26 (3) FEDERAL WAIVER ASSURANCES;

27 (4) ENSURING ACCESS TO MEDICAID SERVICES;

28 (5) QUALITY ENHANCEMENT EFFORTS AND IMPROVEMENT
29 STRATEGIES;

1 **(6) COMMUNICATION WITH STAKEHOLDERS, INCLUDING A**
2 **TRANSPARENT FEEDBACK PROCESS; AND**

3 **(7) COLLABORATIVE PROCESSES WITH STAKEHOLDERS.**

4 **(B) (1) THE COUNCIL SHALL VOTE ON THE ADVICE AND**
5 **RECOMMENDATIONS TO PROVIDE TO THE ADMINISTRATION UNDER SUBSECTION (A)**
6 **OF THIS SECTION.**

7 **(2) THE COUNCIL SHALL ATTEMPT TO REACH CONSENSUS AND ALL**
8 **MEMBERS SHALL BE AFFORDED AN OPPORTUNITY TO BE HEARD.**

9 **(3) IF CONSENSUS CANNOT BE REACHED ON A PARTICULAR ISSUE,**
10 **THE COUNCIL MAY VOTE WITH A 75% AGREEMENT THRESHOLD.**

11 **(4) (I) A COUNCIL MEMBER MAY NOT VOTE ON ANOTHER**
12 **MEMBER'S BEHALF.**

13 **(II) A COUNCIL MEMBER MAY DESIGNATE A PROXY FOR THE**
14 **MEMBER.**

15 **(III) A COUNCIL MEMBER'S PROXY MAY VOTE ON BEHALF OF A**
16 **MEMBER ONLY IF THE PROXY IS ATTENDING THE MEETING FOR THE MEMBER.**

17 **(IV) A COUNCIL MEMBER'S PROXY MAY NOT VOTE ON BEHALF OF**
18 **THE PROXY.**

19 SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the initial voting
20 members of the Maryland Development Disabilities Administration Waiver Advisory
21 Council shall expire as follows:

22 (1) ~~18~~ ~~20~~ 22 members in 2027; and

23 (2) ~~17~~ ~~19~~ 21 members in 2028.

24 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
25 October 1, 2025.
