1 AN ACT concerning

2 **Criminal Records – Expungement and Maryland Judiciary Case Search**
3 **(Expungement Reform Act of 2025)**

4 FOR the purpose of altering certain provisions of law relating to waiting periods for the
5 filing of certain petitions for expungement to authorize the filing of a petition a
6 certain amount of time after the completion of the sentence; adding to the list of
7 misdemeanor convictions that a person may expunge under certain circumstances;
8 requiring a court to ~~determine that a person seeking a certain expungement has paid~~
9 ~~restitution ordered by the court or does not have the ability to pay the restitution~~
10 make certain determinations in relation to a petition to expungement, under certain
11 circumstances; prohibiting the Maryland Judiciary Case Search from in any way
12 referring to the existence of certain records; and generally relating to expungement
13 and the Maryland Judiciary Case Search.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

Article – Criminal Procedure

10–101.

(a) In this subtitle the following words have the meanings indicated.

(b) “Central Repository” means the Criminal Justice Information System Central Repository in the Department.

(c) **“COMPLETION OF THE SENTENCE” MEANS THE TIME WHEN A SENTENCE HAS EXPIRED, INCLUDING ANY PERIOD OF PROBATION, PAROLE, OR MANDATORY SUPERVISION.**

(D) (1) “Court record” means an official record of a court that the clerk of a court or other court personnel keeps about:

(i) a criminal proceeding; or

(ii) any other proceeding, except a juvenile proceeding, concerning a civil offense or infraction enacted under State or local law as a substitute for a criminal charge.

(2) “Court record” includes:

(i) a record of a violation of the Transportation Article for which a term of imprisonment may be imposed; and

(ii) an index, docket entry, charging document, pleading, memorandum, transcription of proceedings, electronic recording, order, and judgment.

[(d)] (E) “Expunge” means to remove information from public inspection in accordance with this subtitle.

[(e)] (F) Except as otherwise provided in this subtitle, “expungement” with respect to a court record or a police record means removal from public inspection:

(1) by obliteration;

(2) by removal to a separate secure area to which persons who do not have a legitimate reason for access are denied access; or

(3) if access to a court record or police record can be obtained only by reference to another court record or police record, by the expungement of it or the part of it that provides access.

1 [(f)] (G) “Law enforcement unit” means a State, county, or municipal police
2 department or unit, the office of a sheriff, the office of a State’s Attorney, the Office of the
3 State Prosecutor, or the Office of the Attorney General of the State.

4 [(g)] (H) “Minor traffic violation” means a nonincarcerable violation of the
5 Maryland Vehicle Law or any other traffic law, ordinance, or regulation.

6 [(h)] (I) “Police record” means an official record that a law enforcement unit,
7 booking facility, or the Central Repository maintains about the arrest and detention of, or
8 further proceeding against, a person for:

9 (1) a criminal charge;

10 (2) a suspected violation of a criminal law;

11 (3) a violation of the Transportation Article for which a term of
12 imprisonment may be imposed; or

13 (4) a civil offense or infraction, except a juvenile offense, enacted under
14 State or local law as a substitute for a criminal charge.

16 (c) (6) A petition for expungement based on the conviction of a crime under
17 subsection (a)(9) of this section may not be filed within 3 years after the [conviction or
18 satisfactory completion of the sentence, including probation, that was imposed for the
19 conviction, whichever is later] **COMPLETION OF THE SENTENCE**.

20 (8) A petition for expungement based on the conviction of a crime under
21 subsection (a)(12) of this section may not be filed before [satisfactory] **THE** completion of
22 the sentence[, including probation, that was imposed for the conviction].

23 (e) (1) If the State’s Attorney files a timely objection to the petition, the court
24 shall hold a hearing.

25 (2) If the court at the hearing finds that the person is entitled to
26 expungement, the court shall order the expungement of all police records and court records
27 about the charge.

28 (3) If the court finds that the person is not entitled to expungement, the
29 court shall deny the petition.

30 (4) The person is not entitled to expungement if:

31 (i) except as provided in item (ii) of this paragraph, the petition is
32 based on the entry of probation before judgment, except a probation before judgment for a

1 crime where the act on which the conviction is based is no longer a crime, and the person
 2 within 3 years after the entry of the probation before judgment has been convicted of a
 3 crime other than a minor traffic violation or a crime where the act on which the conviction
 4 is based is no longer a crime;

5 (ii) the petition is based on the entry of probation before judgment
 6 for a violation of § 21–902(a) or (b) of the Transportation Article and the person within 15
 7 years after the entry of the probation before judgment has:

8 1. been convicted of a crime other than a minor traffic
 9 violation or a crime where the act on which the conviction is based is no longer a crime; or

10 2. received probation before judgment for a violation of §
 11 21–902 of the Transportation Article; or

12 (iii) the person is a defendant in a pending criminal proceeding.

13 **(5) IN DETERMINING WHETHER THE PERSON IS ENTITLED TO**
 14 **EXPUNGEMENT, THE COURT SHALL CONSIDER, TO THE EXTENT APPLICABLE:**

15 **(I) THE PERSON’S SUCCESS AT PROBATION, PAROLE, OR**
 16 **MANDATORY SUPERVISION; AND**

17 **(II) WHETHER THE PERSON HAS PAID ANY MONETARY**
 18 **RESTITUTION ORDERED BY THE COURT IN THE ORIGINAL PROCEEDING OR DOES**
 19 **NOT HAVE THE ABILITY TO PAY THE RESTITUTION.**

21 (a) A person may file a petition listing relevant facts for expungement of a police
 22 record, court record, or other record maintained by the State or a political subdivision of
 23 the State if the person is convicted of:

24 (1) a misdemeanor that is a violation of:

25 (i) § 6–320 of the Alcoholic Beverages and Cannabis Article;

26 (ii) an offense listed in § 17–613(a) of the Business Occupations and
 27 Professions Article;

28 (iii) § 5–712, § 19–304, § 19–308, or Title 5, Subtitle 6 or Subtitle 9 of

30 (iv) § 3–1508 or § 10–402 of the Courts Article;

15 controlled dangerous substance under § 5–602 of the Criminal Law Article; or

16 (iii) § 6–202(a), § 6–203, or § 6–204 of the Criminal Law Article; or

17 (3) an attempt, a conspiracy, or a solicitation of any offense listed in item
18 (1) or (2) of this subsection.

19 (c) (1) Except as otherwise provided in this subsection, a petition for
20 expungement under this section may not be filed earlier than 5 years after the [person
21 satisfies the sentence or sentences imposed for all convictions for which expungement is
22 requested, including parole, probation, or mandatory supervision] **COMPLETION OF THE**
23 **SENTENCE.**

24 (2) A petition for expungement for a violation of § 3–203 of the Criminal
25 Law Article or common law battery may not be filed earlier than 7 years after the [person
26 satisfies the sentence or sentences imposed for all convictions for which expungement is
27 requested, including parole, probation, or mandatory supervision] **COMPLETION OF THE**
28 **SENTENCE.**

29 (3) A petition for expungement for an offense classified as a domestically
30 related crime under § 6–233 of this article may not be filed earlier than 15 years after the
31 [person satisfies the sentence or sentences imposed for all convictions for which

1 expungement is requested, including parole, probation, or mandatory supervision]
2 **COMPLETION OF THE SENTENCE.**

3 (4) Except as provided in paragraphs (5) and (6) of this subsection, a
4 petition for expungement of a felony may not be filed earlier than 7 years after the [person
5 satisfies the sentence or sentences imposed for all convictions for which expungement is
6 requested, including parole, probation, or mandatory supervision] **COMPLETION OF THE**
7 **SENTENCE.**

8 (5) A petition for expungement of a conviction of possession with intent to
9 distribute cannabis under § 5–602 of the Criminal Law Article may not be filed earlier than
10 3 years after the [person satisfies the sentence or sentences imposed for all convictions for
11 which expungement is requested, including parole, probation, or mandatory supervision]
12 **COMPLETION OF THE SENTENCE.**

13 (6) A petition for expungement of a conviction for § 6–202(a), § 6–203, or a
14 felony that is a violation of § 7–104 of the Criminal Law Article may not be filed earlier
15 than 10 years after the [person satisfies the sentence or sentences imposed for all
16 convictions for which expungement is requested, including parole, probation, or mandatory
17 supervision] **COMPLETION OF THE SENTENCE.**

18 (f) (1) If the State’s Attorney or a victim files a timely objection to the petition,
19 the court shall hold a hearing.

20 (2) The court shall order the expungement of all police records and court
21 records about the charge after a hearing, if the court finds and states on the record:

22 (i) that the conviction is eligible for expungement under subsection
23 (a) of this section;

24 (ii) that the person is eligible for expungement under subsection (d)
25 of this section;

26 (iii) that giving due regard to the nature of the crime, the history and
27 character of the person, **THE PERSON’S SUCCESS AT ~~COURT-ORDERED PROBATION~~**
28 **PROBATION, PAROLE, OR MANDATORY SUPERVISION**, and the person’s success at
29 rehabilitation, the person is not a risk to public safety; [and]

30 (iv) **THAT THE PERSON HAS PAID ANY MONETARY RESTITUTION**
31 **ORDERED BY THE COURT IN THE ORIGINAL PROCEEDING OR DOES NOT HAVE THE**
32 **ABILITY TO PAY THE RESTITUTION; AND**

33 (v) that an expungement would be in the interest of justice.

34 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
35 as follows:

Article – Criminal Procedure

10–401.

(A) The Maryland Judiciary Case Search may not in any way refer to the existence of records of a charge in a case with electronic records if the charge resulted in:

(1) acquittal;

(2) dismissal; [or]

(3) nolle prosequi[, except nolle prosequi with the requirement of drug or alcohol treatment]; **OR**

(4) THE COURT MARKING THE CHARGE STET ON THE DOCKET AT LEAST 3 YEARS PREVIOUSLY.

(B) THE MARYLAND JUDICIARY CASE SEARCH MAY NOT IN ANY WAY REFER TO THE EXISTENCE OF RECORDS OF A CHARGE OF POSSESSION OF CANNABIS IN A CASE WITH ELECTRONIC RECORDS IF THE CHARGE RESULTED IN A CONVICTION THAT WAS LATER PARDONED BY THE GOVERNOR.

SECTION 3. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take effect ~~January 1~~ January 31, 2026.

SECTION 4. AND BE IT FURTHER ENACTED, That, except as provided in Section 3 of this Act, this Act shall take effect October 1, 2025.
