## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **General Provisions – Veterans Benefits – Honorable Discharge**

3 FOR the purpose of defining “honorable discharge” with respect to any State program of  
4 benefits, rights, or privileges applicable to a veteran to include certain discharges;  
5 and generally relating to veteran discharges.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

12 That the Laws of Maryland read as follows:

13 **Article – General Provisions**

14 1–109.1.

15 (a) With respect to any State program of benefits, rights, or privileges applicable  
16 to a veteran under this Code, “honorable discharge” includes discharge that is less than  
17 honorable:

5 or consensual act was prohibited by the military or naval service at the time of discharge;

14 (3) IF THE DEPARTMENT OF VETERANS AND MILITARY FAMILIES  
15 DETERMINES AN INDIVIDUAL IS ELIGIBLE FOR STATE BENEFITS BASED ON THE  
16 CRITERIA ESTABLISHED IN 38 C.F.R. § 3.12.

17 (b) A veteran shall submit to the Secretary of Veterans and Military Families  
18 documentation that provides the basis for the veteran’s discharge.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
20 October 1, 2025.
