**Gaming - Charles County Gaming Permit Review Board - Repeal**

---

This bill repeals the Charles County Gaming Permit Review Board, and the county attorney must assume the board’s duties and responsibilities.

---

**Fiscal Summary**

**State Effect:** None. The bill only affects local government operations.

**Local Effect:** Repealing the Charles County Gaming Permit Review Board and transferring responsibilities to the Charles County attorney has no fiscal impact as the Charles County attorney has already assumed the board’s duties and responsibilities.

**Small Business Effect:** None.

**Analysis**

**Current Law:** The Charles County Gaming Permit Review Board consists of seven members, including a representative of the Charles County Sheriff’s Office, a representative of the Department of State Police, a representative of a fundraising organization in the community, an individual with a background and experience in finance, and three individuals appointed from the county at large. Additionally, each board member must be a resident of Charles County. The board’s chairperson is selected from among its members for a term set by the board.

The board may make recommendations to the county commissioners regarding the types of gaming devices that may be operated in the county, the approval or denial of gaming permits, and any modifications of the county gaming regulations and procedures.

The board must review gaming permit applications at least quarterly, review gaming regulations and permit procedures, keep specified records, and undertake any other duties relating to gaming regulation that the county commissioners delegate. As the county commissioners consider appropriate, the county commissioners must provide for the board a clerk, legal counsel, supplies, and funding, and the county commissioners may pay salaries to the board members.

### *Charles County Gaming Events*

A gaming event may only be conducted by a fundraising organization that has been located in the county for at least five years before applying for a gaming permit, and a fundraising organization must obtain a gaming permit for each gaming event that the fundraising organization conducts. A gaming event is an event that involves a game of chance, and includes a carnival, a bazaar, and a raffle involving prizes exceeding \$1,000.
