AMENDMENTS TO HOUSE BILL 1310  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in lines 3 and 4, strike “Commission on Environmental Justice and Sustainable Communities” and substitute “Department of the Environment”; in lines 8 and 9, strike “Commission on Environmental Justice and Sustainable Communities” and substitute “Department”; in line 9, strike “the Department of the Environment,”; in line 12, strike “Commission on Environmental Justice and Sustainable Communities” and substitute “Department”; in line 15, strike “Commission on Environmental Justice and Sustainable Communities” and substitute “Department”; in lines 16 and 17, strike “Commission on Environmental Justice and Sustainable Communities” and substitute “Department”; in line 22, after “exception;” insert “requiring that a certain percentage of federal funds appropriated be invested in low-income communities;”; and in line 29, after “1-701” insert “(a)”.

AMENDMENT NO. 2

On page 2, in line 4, strike “1-703” and substitute “1-702”; in line 31, after “(a)” insert “(1)”; and strike in their entirety lines 33 and 34.

On page 3, in lines 1 and 3, strike “(C)” and “(D)”, respectively, and substitute “(2)” and “(3)”, respectively; in lines 5 and 6, strike “(1)” and “(2)”, respectively, and substitute “(I)” and “(II)”, respectively; in lines 6 and 9, strike “(I)” and “(II)”, respectively, and substitute “1.” and “2.”, respectively; and in lines 11 and 12, strike “1.” and “2.”, respectively, and substitute “A.” and “B.”, respectively.

On pages 3 through 5, strike in their entirety the lines beginning with line 13 on page 3 through line 19 on page 5, inclusive.

On page 5, in line 20, strike “**1-703.**” and substitute “**1-702.**”; and in line 21, strike “**COMMISSION**” and substitute “**DEPARTMENT, IN COORDINATION WITH THE PUBLIC SERVICE COMMISSION,**”.

On page 6, in line 7, strike “**COMMISSION**” and substitute “**DEPARTMENT**”; in line 8, strike “**THE DEPARTMENT,**”; in line 18, strike “**COMMISSION**” and substitute “**DEPARTMENT**”; in the same line strike “**THE DEPARTMENT,**”; in line 19, strike the comma; in line 24, strike “**COMMISSION**” and substitute “**DEPARTMENT**”; and in line 31, strike “**COMMISSION**” and substitute “**DEPARTMENT**”.

On page 7, in line 2, strike “**THE COMMISSION,**”; in line 7, strike “**FEDERAL**” and substitute “**OF THE FEDERAL**”; in line 12, after “**DEVELOPMENT**” insert “**, 40%**”; and in the same line, strike “**PRIORITIZED**” and substitute “**INVESTED**”.
