Testimony Concerning HB 0467  
Education - Teacher Certification - Montessori Schools  
Submitted to House Ways & Means Committee

Position: Support

Montessori Schools of Maryland (MSM) strongly supports HB 0467. There currently are six public Montessori schools in Maryland: three public charter schools in Frederick County and Baltimore City, and three public Montessori magnet schools in Prince George's County. Frederick County recently approved the opening of the first Montessori public charter high school that is slated to open during the 2023-2024 school year. These schools serve over 2,125 children and carry significant wait lists. Our school, Carroll Creek Montessori Public Charter School, currently has 1060 applicants in the lottery for the 2022-2023 school year after only being open three weeks. We are on track to have over 1,500 applicants if previous years application trends are an indicator given current application submission rate.

Montessori schools have served as strong contributors to Maryland's public-school system and have produced strong academic results. Moreover, these schools provide additional educational options for families. This bill will create a much-needed pathway to state teacher licensure for Montessori credentialed teachers which will, in turn increase access to high quality authentic Montessori programs for children from all backgrounds throughout our state.

Currently, Maryland's certification process does not recognize the Montessori credential as part of a pathway to state certification and finding qualified teachers who are Montessori credentialed and meet Maryland's teaching certification requirements remains a challenge for many Montessori schools; the pipeline for these teachers is significantly strained in the public sector due to the double certification requirement. As such, we hire non-Montessori certified teachers which puts them in a learning environment for which they are not properly prepared. Student progress would suffer in a traditional school if an English teacher were placed in a math classroom, likewise it limits progress for student learning to place a non-Montessori trained teacher in a Montessori classroom. Both the teachers and the students are placed in situations that compromise the learning environment.

All students deserve to have highly qualified teachers in their classrooms. Montessori teacher preparation entails a rigorous graduate level course of study that covers child-development, curriculum and level specific subject matter, observation and assessment, supports for learning

differences and culturally responsive teaching in addition to a robust student teaching component. This bill would merely expand certification requirements to include these already highly qualified teaching professionals.

Because there is currently no path to state certification for Montessori credential holders, the public Montessori programs in Maryland, including Carroll Creek, have been forced to hire non-Montessori trained teachers who are state certified and then pay for them to take Montessori training while they are teaching. This creates a number of obstacles which short-change our students and our teachers:

- We have used limited funds from our budget to pay for the Montessori training needed,
- We have spent significant personnel resources on coaching and supporting teachers, working in an environment they are unprepared for,
- Montessori training is rigorous graduate level work and it is taxing for our teachers to spend their first 2-3 years in a Montessori school teaching as well as doing rigorous coursework after school,
- Frederick County Public Schools is now recognizing Montessori certification classes for a small portion of the teacher licensing renewal process, but does not fully recognize the number of hours teachers have spent in gaining their certification thus limiting their compensation for continuing education.

Carroll Creek Montessori Public Charter School is dedicated to providing children from age three through eighth grade with an exceptional Montessori education. We hold the highest level, Level 5, on the Maryland Excels quality rating and improvement system for preschool programs. Our school was the first school in the nation to reach a level 8 on the American Montessori Society Pathway to Accreditation. One of the key requirements of the Pathway is ensuring teachers in each classroom hold a credential from an American Montessori Society (AMS) or Association Montessori International (AMI) affiliated or MACTE accredited teacher education program.

This bill aligns with existing MSDE requirements that Montessori schools have Montessori trained teachers.

I urge a positive report on HB 0467. Thank you for your consideration.
