I am writing to ask you to support **SB 400 - Open Captioning Movie Bill**, sponsored by Senator Benjamin Brooks and Senator C. Anthony Muse. This bill will require all motion picture houses to offer closed captioning for each screening of a motion picture; and require that certain motion picture houses provide open captioning for at least two screenings each week.

Captioning, also known as same-language subtitles, benefits everyone who watches videos (children, adolescents, college students, and adults). More than 100 empirical studies document that captioning a video improves comprehension of, attention to, and memory for the video. Captions are particularly beneficial for persons watching videos in their non-native language, for children and adults learning to read, and for persons who are deaf or hard of hearing.

Most importantly, the bill provides communities with the assurance and peace of mind that they have access to the movie without using devices or other methods same as other people who go to the movie.

I love to go see movies! Lets have captions on movies so deaf people enjoy the movie like hearing people.
