Hearing people, on the other hand, do not have to worry about not being able to watch a movie at a convenient time. They simply can go and expect to have a great time.

I hope this bill will pass - I have had to leave about 10 movies in the last few years and I don't even go that often because it can be a hassle wondering if the device will work. It'd be wonderful to just go and see it open captioned - that way, the theater can see (and ensure) that it is working for everyone who goes.

Most importantly, the bill provides communities with the assurance and peace of mind that they have access to the movie without using devices or other methods same as other people who go to the movie.
