AMENDMENTS TO HOUSE BILL 343

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Membership**” and substitute “**Alterations**”; and in line 4, after “Committee;” insert “requiring the Committee to provide certain input and recommendations to the Maryland Port Administration regarding certain management of dredged material;”.

AMENDMENT NO. 2

On page 1, in line 18, strike “2 members of the North County Land Trust” and substitute “1 MEMBER OF THE LAND TRUST THAT HOLDS THE CONSERVATION EASEMENT OF THE COX CREEK FOREST CONSERVATION EASEMENT AREA”.

On page 2, in line 1, strike “member of the Anne Arundel County Watermen’s Association” and substitute “INDIVIDUAL WHO REPRESENTS RECREATIONAL BIRDING IN ANNE ARUNDEL COUNTY”; in line 9, strike “1 MEMBER OF THE STONEY BEACH ASSOCIATION” and substitute “2 INDIVIDUALS WHO REPRESENT A WATERFRONT COMMUNITY IN THE NORTHERN PART OF ANNE ARUNDEL COUNTY”; strike line 10 in its entirety; in lines 11 and 12, in each instance, strike the brackets; in the same lines, strike “(11)” and “(12)”, respectively; strike beginning with “redeposit” in line 14 down through “area” in line 15 and substitute “MANAGEMENT OF DREDGED MATERIAL AT THE COX CREEK DREDGED MATERIAL CONTAINMENT FACILITY”; in line 16, after “(2)” insert “(1)”; in the same line, strike “Hear and dispose” and substitute “ADVISE THE MARYLAND PORT ADMINISTRATION”; in line 18, strike “and”; after line 18, insert:

“(II) PROVIDE INPUT AND FEEDBACK TO THE MARYLAND PORT ADMINISTRATION REGARDING THE MANAGEMENT OF DREDGED MATERIAL AT THE COX CREEK DREDGED MATERIAL CONTAINMENT FACILITY; AND

(III) MAKE RECOMMENDATIONS TO THE MARYLAND PORT ADMINISTRATION ON THE POTENTIAL IMPACT THAT ACTIVITIES AT THE CONTAINMENT FACILITY MAY HAVE ON NEARBY COMMUNITIES AND NATURAL RESOURCES; AND”;

and in line 22, strike “October” and substitute “July”.
