

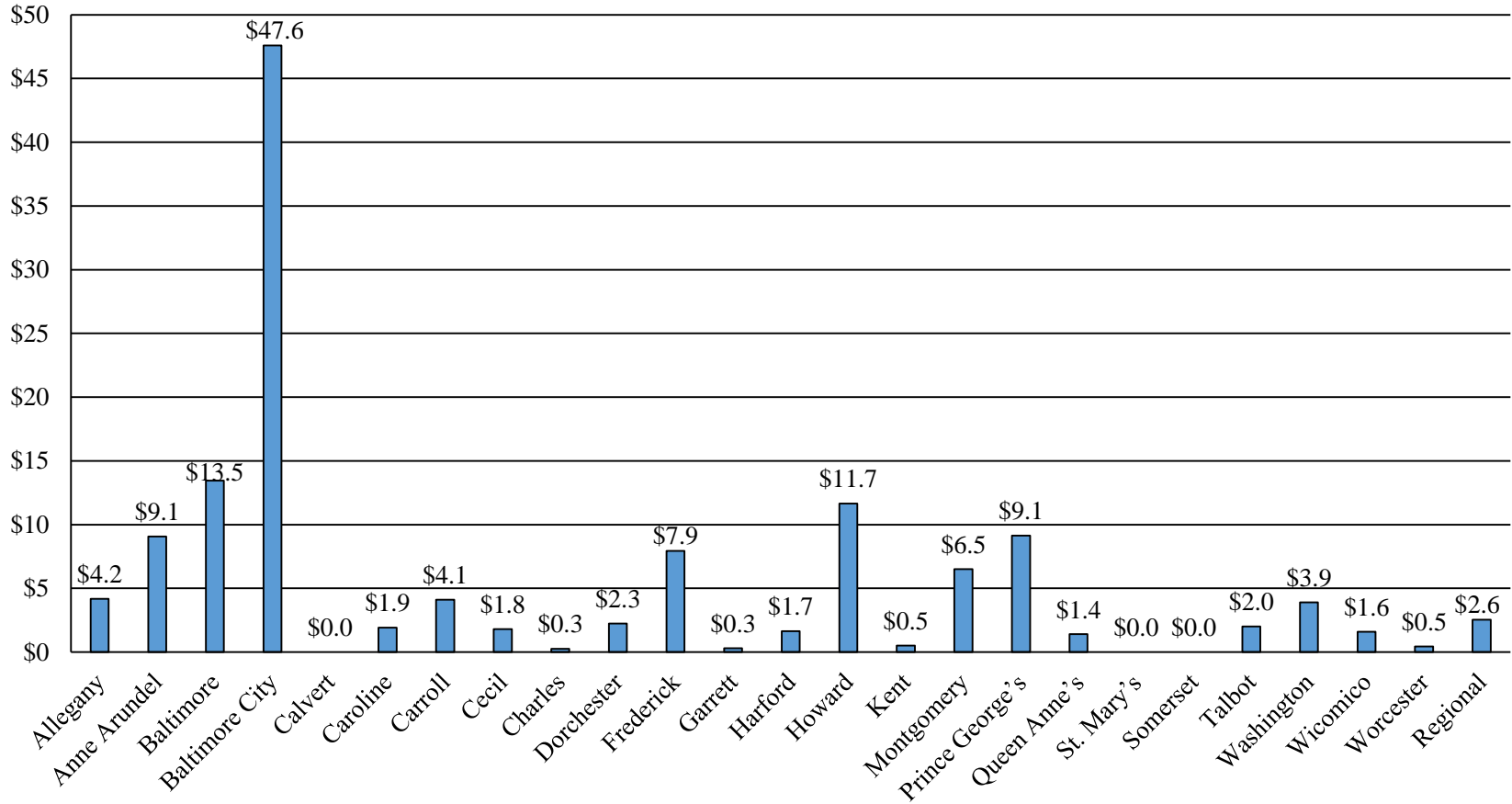

Miscellaneous Grant Programs – Capital

Capital Budget Summary

The Maryland Consolidated Capital Bond Loan of 2022 includes general obligation (GO) bond funds for a variety of miscellaneous grants. Fiscal 2023 GO bond funds reflected in this analysis total \$134.2 million for 132 projects of which \$36.4 million provides funds for grants preauthorized for fiscal 2023 by the General Assembly in last session’s capital budget bill. Three projects are listed in the 2022 *Capital Improvement Program* (CIP) as ongoing multi-year commitments. The aggregate future commitment to these projects is programmed at \$27.0 million from fiscal 2024 through 2027, of which \$19.0 million is programmed for ongoing facility improvements at the Maryland Zoo. **Exhibit 1** provides an illustration of the total amount of miscellaneous grant funds included in this analysis for each jurisdiction, and **Exhibit 2** provides a categorical illustration of the type of projects supported by these grants.

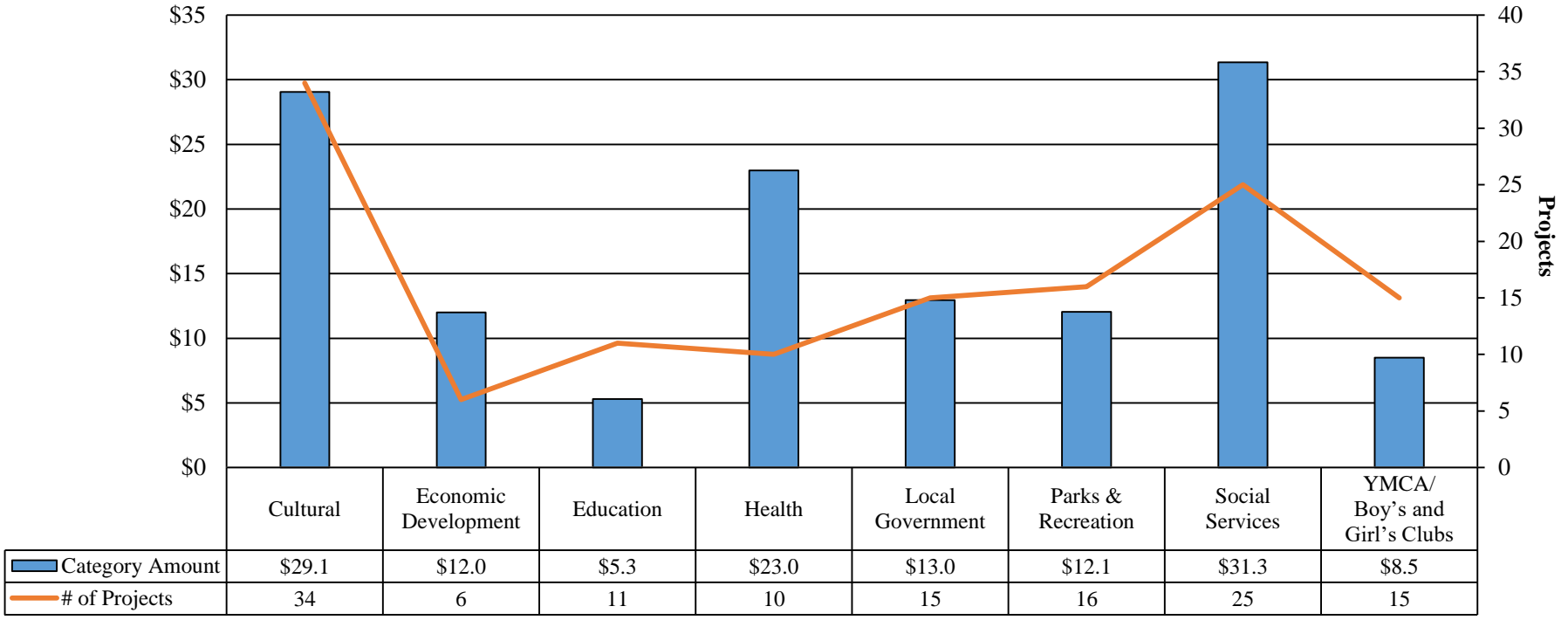
Most grants do not require the grantee provide a matching fund. For those where a match fund is required, the Department of Budget and Management (DBM) has requested the removal of such requirement consistent with current policy adopted by DBM and the Presiding Officers for fiscal 2023 grants. While a match fund may not be stipulated, most projects require funds in excess of what the State intends to provide. **Exhibit 3** provides detail for projects that are not programmed as multi-year commitments beyond fiscal 2023 for which the Department of Legislative Services (DLS) recommends approval or for which a technical amendment is recommended. **Exhibit 4** provides detail for projects where DLS recommends reducing or deleting the grant funds.

Summary of Grants – Multi-year Capital Improvement Program Commitments

Historic Annapolis Restoration

Recommendation: Approve

Project Description: Historic Annapolis, Inc. (HA) manages and maintains 12 State-owned historic properties in Annapolis. The proposed authorization continues to restore the James Brice House to its original 1774 construction. The exterior envelope, which includes the roof, masonry, and windows and cornices, should be completed by fiscal 2023.

The fiscal 2023 authorization was increased by \$2 million over the amount programmed in the 2021 CIP. Fiscal 2023 funds the first phase of a \$6 million replacement of all mechanical (including HVAC), electrical, plumbing and fire suppression, with another \$3 million needed to complete this work. Additionally, a remote central plant structure will be created that will house the boilers, heat pumps, water pumps, heat exchangers, and chemical treatment facilities. As these systems are interdependent, this work is best done at the same time, and the increased funding allows this work to be done together. Upgrading these systems separately increases costs, disrupts rework to historic finishes, and leaves parts of the building exposed and vulnerable to damage.

Out-year improvements planned for the James Brice House include (1) site work, such as retaining walls, garden walls, nonmechanical outbuildings, parking lot reconfiguration, and plaza-paver reconfiguration; (2) rebuilding front and rear porches, including Americans with Disabilities Act (ADA) ramp access; (3) interior plaster finish restoration, which is currently privately funded, and woodwork, such as door and window millwork, staircases, flooring, and fireplaces; and (4) interior painting, wood finishing, and wall treatments.

Matching funds are private contributions raised by HA. HA advises that it has raised \$1,078,000 in private contributions for planning and construction of the Brice House renovation, which is in excess

of the \$250,000 matching requirement in the fiscal 2016 authorization. An average of \$250,000 annually in fundraising revenues is anticipated through fiscal 2027.

Comments: HA’s goal is to open the Brice House for public use by calendar 2026, but the timing of the opening will depend on funding. HA estimates that it will need \$10 million to complete the renovations necessary to open the building by the end of calendar 2026 and that it will be able to raise \$1 million in private funds from fiscal 2024 to 2027. Adding authorizations planned in the CIP to the private fundraising provides a total of \$5 million from fiscal 2024 to 2027. To open in calendar 2026 with the current funding levels, the Brice House may have to phase its openings one section at a time. For example, once the mechanical (including HVAC), electrical, plumbing, fire suppression, and interior conservation work is complete, HA could open just the first-floor main block of the house for tours and educational meetings. Supplemental tour options that would require a hard hat could be made available as well. Prior to the pandemic, HA was providing hard hat tours on a regular basis.

Maryland Zoo in Baltimore

Recommendation: Approve

Project Description: The Maryland Zoo was founded in 1876 and is the third-oldest zoo in the country. It occupies a 135-acre parcel in Baltimore City in Druid Hill Park, of which 45 acres are developed. The table below shows that the fiscal 2023 grant is \$4.75 million, and \$19 million is planned for the fiscal 2024 to 2027 period in the 2021 CIP. The zoo receives an operating grant, which is budgeted in the Board of Public Works (BPW), totaling \$5.6 million, some of which can be applied to capital projects that do not qualify for GO bond funds.

Comments: The zoo maintains a list of improvements that are grouped into categories:

Infrastructure Improvements – \$4.25 Million

- **\$2,900,000 for Renovating and Constructing Parking Lots A and B:** Total costs are \$9.42 million. The zoo received \$1 million in fiscal 2020, \$1.2 million in fiscal 2021, and needs another \$4.32 million in the out-years to complete this project.
- **\$800,000 to Address Deficiencies Identified by the Association of Zoos and Aquariums:** This project will renovate the Lower Barn, which is an off-exhibit holding facility that needs the roofing and floors replaced, additional insulation, and other repairs. The project will also connect sanitary drains so that waste from the barn no longer flows into a creek that runs through the Maryland Wilderness exhibits.
- **\$450,000 to Begin Construction for Replacement of the African Watering Hole Life Support System:** The current system, which acts as a barrier between exhibits, is past its useful life. The U.S. Department of Agriculture Animal Welfare Act mandates that the zoo provide potable drinking water for all mammals at the zoo. The current total cost estimate is \$2 million. The fiscal 2022 authorization provided \$100,000 to start design.

- ***\$100,000 to Repair and Replace Perimeter Fencing:*** Funding is sufficient to replace approximately 670 linear feet of fencing, which is 10% of the total. Repairs are needed due to age of the fencing, damage from falling trees, vehicle hits, and vandalism.

Exhibits and Attractions – \$0.5 Million

- ***\$500,000 for Design and Construction of the Farmyard Exhibit Renovation:*** This will winterize the Pig and Sheep Barn by enclosing and insulating the three-wall structure.

National Aquarium in Baltimore

Recommendation: Approve

Project Description: The fiscal 2023 capital budget provides \$3.0 million of GO bond funds to fund deferred maintenance and facility renewal related infrastructure projects at the Main Aquarium Building in Baltimore City. The funds will be used to update the North Atlantic to the Pacific, River Forest, and Jellies Invasion exhibits; update on-site classrooms to meet the needs of Maryland students; replace aging escalators and other conveyances; upgrade restrooms for ADA compliance and efficiency; replace outdated and leaky membrane roofs; install new high-efficiency pumps and piping infrastructure; upgrade HVAC ducts and air handlers; install public safety upgrades recommended by the Department of Homeland Security; and improve loading dock access and security.

Note: figures do not reflect \$2.1 million of non-capital project costs to be funded by the National Aquarium.

Comments: The 2022 CIP programs an additional \$4.0 million through fiscal 2027 (\$1.0 million annually from fiscal 2024 through 2027). These funds reflect a multi-year commitment to assist the National Aquarium with its well-documented deferred facility renewal plans. Through its facility master planning process, the National Aquarium has identified roughly \$65 million in deferred facility renewal projects. The aquarium indicates that it intends to contribute \$3 million in fiscal 2023 and approximately \$5 million annually in fiscal 2024 through 2027.

The State has a long history of assisting the National Aquarium with capital infrastructure projects the most recent of which include:

- \$2 million in fiscal 2022 toward the replacement of the rain forest glass pyramid;
- \$5 million in fiscal 2021 toward the replacement of the rain forest glass pyramid;
- \$1 million in fiscal 2020 toward the \$21 million Animal Care and Rescue Center; and
- \$1 million in fiscal 2020 toward infrastructure projects.

The State has supported the museum with almost annual funding since fiscal 2001. Most recently, the State support Phase I of the master plan, which renovated and expanded the library. Choptank Community Health System Inc. New Federalsburg Health Center	Caroline	420,893	This project will construct a new facility for the Federally Qualified Health Center in Federalsburg. The new building will provide increased expansion for dental, medical, and behavioral health service, including a residency program for rural medical and dental care. Overall patient capacity will increase by 25%. State Share: 3.7%

Updates

1. Recommendations to Improve Capital Grants and Loan Administrative Process

The committees expressed concern regarding the Department of General Services (DGS) management and administration of State authorized capital grants. These concerns resulted in the adoption of committee narrative in the 2021 *Joint Chairmen's Reports* requiring DGS and BPW to conduct a full evaluation of the capital grants process to include recommendations for improving the process. BPW provided the required report (*Board of Public Works Evaluation of Capital Grant and Loan (CGL) Program in Response to 2021 Joint Chairmen's Report Requirement*) in January 2022 that included three primary observations:

- recommend that BPW initiate the process of implementing a web-based automated online project management tool;
- improve communication in CGL booklet and tutorial sessions; and
- improve customer service, including timely responses to inquiries, improved document management, grantee notification, and wait times for substantive updates on grant status.

In November 2021, Office of Legislative Audits (OLA) released an audit of State grants. This covered numerous agencies, including the Governor's Grants Office, DBM, the Department of Commerce, the Department of Human Services, the Maryland Department of Labor, the Maryland State Department of Education, and DGS. Some of the audit's findings relate to DGS administration of CGLs, specifically:

- not maintaining documentation to support grant payments;
- not ensuring that grantees submitted required documents to explain or support the basis used to select vendors to work on certain capital projects funded by State capital grants; and
- not performing routine site visits to ensure that capital projects funded with State grants were progressing in accordance with the terms of the contract.

OLA also recommended that a statewide grants management system be procured and implemented. OLA advises that a grant system should be able to:

- interface with State accounting (Financial Management Information System) systems and other information systems;
- create and disseminate grant award packages;

- submit reports on any aspect of the monitoring phase relevant to the grants, including site visits;
- query data and use data mining features to create reports on any aspect of the grant that is tracked in the system;
- track and monitor direct and indirect costs; and
- include a repository of grant award and monitoring documents, including applications and financial data.

DGS Fiscal 2023 Budget Includes New Positions and Major Information Technology Project for Grant Managements

The Administration is taking action to improve the CGL processes as 3 new positions and a major information technology (IT) project are added to the fiscal 2023 budget. With respect to the IT project, the functionality recommended by OLA should be built into the new system. This new system should also have a secure interface that can be used by grantees. This would address the observations of the BPW report, which noted that improvements in customer service were needed. Giving grantees secure access could resolve a number of the customer service concerns.
