Voting in Correctional Facilities: COMAR 33.01.07.01 through .06

According to the board, the purpose of this action is to:

- define specific terms related to proposed new amendments;
- implement the regulatory requirements of HB 222 and SB 525 of 2021;
- implement a program to inform eligible voters of upcoming elections and how to exercise their right to vote;
- provide the Baltimore City centralized booking facility with a ballot drop box for election mail, and determine the procedures for emptying the
